Summary

On Thursday, July 13, 2023, the Parks and Recreation Committee requested the City Council create an Ordinance banning the use of tobacco products at City Parks. Council considered this request during their Monday, August 7, 2023, Regular Council Meeting and directed staff to bring back the item when time allowed.

As such, staff has been working on drafting a Tobacco and Smoking Ordinance and is seeking Committee comment on the draft before submission to Council. A presentable version of that draft is still under development and will be given to the Committee during their Regular Meeting scheduled for Thursday, November 9, at 5:00 PM.

Summary

On Thursday, October 26, the Parks and Recreation Committee held a workshop reviewing the Parks and Recreation Master Plan. The workshop was very productive, and the Committee finalized their review of all current sections to date.

As such, the Assistant City Administrator recommended the committee discuss next steps by holding an additional workshop. This workshop would create a new section of the Master Plan to be labelled "Future Planning" and would cover larger projects the committee would like to see developed by the City.

The committee tentatively agreed to hold this workshop but desired to discuss the matter further during their next Regular Meeting.
