Breezy Point Parks & Recreation Committee July 13, 2023 - 6:55 pm Committee Workshop Minutes

A workshop of the Breezy Point Parks & Recreation Committee began at 7:00pm. Committee Members present were Megan Zierden, Gail Arne, Jim McKellar, Bill Toft, and Diane Williams. City Administrator David Chanski and Assistance City Administrator Daniel Eick were also in attendance. The purpose of the workshop was to discuss and plan a redrafting of section 1, the Plan Elements section, of the City of Breezy Point Parks & Recreation Master Plan.

Assistant City Administrator Daniel Eick walked the Committee through the original 2011 Master Plan and requested their input. Areas of discussion included:

- Mission Statement
 - The committee discussed the Master Plans mission objectives and altered the language to remove instances of terms such as: "acquire and preserve," "up north character," and "open space" or "green space."
 - The Committee also debated the definitions of the terms listed above and directed staff to improve the use of such terms in the redraft and condense this section.
- Plan Objectives
 - The Committee requested staff condense this section by removing redundant language and add an element to "enhance marketing and communication" for parks and trails.
 - Additionally, the Committee debated adding language into this section referring to the Committees fiduciary responsibility to protect residents and taxpayers.
 - Finally, the Committee requested the specific budget numbers outlined in this section be removed as they are no longer relevant.
- Development History and Calendar
 - The Committee requested staff remove "the process" and "community input" sections as they are no longer relevant.
 - In place of these sections, the Committee requested staff create a history section meant to summarize the findings of the removed sections and add a calendar of important events for the Committee to consider each year.
 - Additionally, the Committee requested a statement of intent be added to the Master Plan, so they revisit the document every five years to refine and update it.

Section 1: Plan Elements

Mission Statement of the Parks and Recreation Committee

The City of Breezy Point Parks and Recreation Committee seeks to acquire and preserve natural environmental areas with green spaces and provide recreational services that positively impact the health of our citizens, the broader City economy, and quality of life.

The Objective of the Parks, Trails, and Open Space Plan Master Plan

The City of Breezy Point Parks and Recreation Committee seeks to ensure existing park and recreational opportunities serve the residents of Breezy Point today and in the future. As such, this plan will create a framework to achieve this goal and ensure the community secures sufficient and appropriate land to:

- Develop high quality parkland with varying recreational opportunities.
- Create Open spaces and trails that meet the needs of all members of the community.
- Continue developing park and community areas with amenities for residents and visitors alike.
- Communicate and promote the use of parkland to enhance its use as a community building tool.

This document refines and implements general direction established throughout the Breezy Point Comprehensive Plan to guide park and recreation development moving forward. As the City grows, the Committee will plan for its budget to responsibly reflect this growth, so that subsequent Committees and residents are able to:

"Increase the amount of land devoted to parks and public open space whether for recreation or environmental protection. Extend and improve the trail corridor system. Improve public access to the lakes."

The City of Breezy Point Parks and Recreation Committee believes the citizens of Breezy Point desire a community that protects and preserves its natural asset features, recreation, and water quality. The development of parks, trails, and open spaces is an expenditure that can serve as an investment in the future well-being of individuals and groups when handled responsibly. As such, the committee will strive to contribute to the attractiveness and viability of the City while planning to utilize the City's monetary resources in a responsible and cohesive manner for the long term.

This Master Plan is a living document which the Committee intends to review every 5 years to evaluate and refine demographic, recreational, or financial trends that evolve over time. The Parks and Recreation Committee can alter this plan at any time to reflect changes in the City's Comprehensive Plan accordingly.

History and Development of the Parks, Trails, and Open Space Master Plan

In 2011 the City of Breezy Point Parks and Recreation Committee drafted the City's original Parks, Trails, and Open Space Master Plan utilizing information gathered throughout the 2010 Comprehensive Planning process. This process included:

- A review of planned future land use development in long term planning.
- A review of the 2010 community survey and presentation of relevant data.
- A review of all currently owned parkland, trails, and open spaces within the City.
- A review of the standing parkland dedication formulas and their associated financial costs.
- A review of all associated goals, strategies, and policies associated with parkland development.

Core considerations of the original plan were developed throughout several Citizen Brainstorming Sessions. From these sessions the Parks and Recreation Committee learned people chose to live in

Breezy Point primarily for its location, natural features, and quiet community. Following from this the Committee tasked itself with sustaining these features by:

- To Preserve the City's feel of clean lakes, trees, wildlife, and general green space or nature as a
 draw for tourism in recreational activities. Previous land use planning and development has
 focused on this broad goal.
- To Improve said spaces with green and/or nature focused amenities, such as trails and paths, while maintaining open water access through the City beach. Previous improvements have focused on maintaining access opportunities for community members regardless of age or location.
- To allow for the unique character of Breezy Point to thrive by further developing the City's recreational facilities and opportunities. Proposed improvements included a community center, public swimming pool, fitness center, and trail system expansions.
