The Committee reviewed images of the hydrants for the hydrant project and discussed future placement at city owned property locations. There are 20 hydrants that need to be refurbished and 10 blank ones. The Committee walked to the front of City Hall and decided where they

would like the hydrants placed. They returned to the Large Conference Room and discussed their findings. It was decided that they will place 3 at the front of City Hall, 6 at the beginning of Quarry trailhead on San Francisco Street and 7 at the Community Park near the Holiday tree area. The Committee then sorted images of the hydrants and grouped them together for each location. Staff will work with Public Works to begin the process of cleaning up the hydrants. Committee will reconvene in January.

#### PUBLIC ART ADVISORY COMMITTEE MEMO

Subject: Community Park Star Donor Wall

#### Purpose

To increase citizens' appreciation of art, to improve quality of life, and to enhance Brisbane's identity as a unique community within the greater Bay Area.

#### Recommendation

Consider taking on the project of revitalizing the Community Park seat wall and approving a not-toexceed amount for the project.

#### Background

In 2012 the Community Park playground underwent a significant renovation. In order to fill a funding gap for the project, more than 210 community donors or "star supporters" made tax-deductible donations amounting to \$33,400. The cast-in-place reinforced concrete seat wall located adjacent to the swing area proudly displayed commemorative donor stars acknowledging these contributions for the last 11 years. Unfortunately, in recent years, many of the donor stars have gotten chipped, scratched, faded, or have fallen off the wall entirely. City staff has handled replacing them as needed. Recently, a concerned citizen brought safety concerns to the attention of the City Council, after a small child picked up a sharp star that had fallen off the wall. Upon inspection and consideration of various alternatives the City decided it was best to remove the stars which will occur later this month. In the meantime, in lieu of a physical wall, the City has published a virtual wall on the City's website: brisbaneca.org/2012stardonors. There will also be a framed print-out of the virtual wall posted in a publicly accessible space (such as the Library or new City Hall annex).

#### Discussion

The Committee is being asked to weigh whether they are willing to support revitalization of the donor wall with a more permanent long-term solution using money from the Public Art Fund. One way this could be accomplished is by hiring an artist to paint the donor star inscriptions on the wall. The Committee may also propose alternate solutions if desired. If the Committee were to undertake this project, all procedures governing contracting an artist would need to be followed in accordance with the Public Art Implementation Guidelines which are as follows:

1. The Public Art Advisory Committee will recommend to the City Council the amount of money from the Public Art Fund to be used on any publicly installed public art pieces and the breakout between Administrative and Maintenance costs of the project. The Public Art Advisory Committee will also

recommend a location for the art project, type of artwork when appropriate, process for involving the community in the process, and method of calling for artists.

- 2. The Council will approve available funds for the artwork and solicit members to be part of an Art Selection Committee, if needed.
- 3. The Public Art Committee shall select an artist, or group of artists, through a public process using one of the following methods:
  - a. Request for qualifications (RFQ)
  - b. Request for proposals (RFP)
  - c. Invitational competition.
- 4. The City Council shall make a decision on the Public Art Committee's recommendations on the artist or artist group.
- 5. The Public Art Committee, any outside professional hired by the City for assisting with the selection of the artwork, and the appropriate City staff (as needed for the particular project) shall meet regularly with the selected artist, or group of artists, in developing the Conceptual Design Plan that meets the artwork and location criteria.
- 6. Once the Conceptual Plan has been approved by the Public Art Committee, the artist or artist's team shall refine the project objectives and the Conceptual Design Plan according to the direction of the Public Art Committee.

The Final Design will be approved by the City Council.

#### **Fiscal Impact**

The initial request would be for the Committee to designate a not-to-exceed amount for the project (approximately \$10,000 - \$15,000). However, routine maintenance would also be necessary in the future to preserve the painting as is the case with any mural.

#### Recommendation

Review the list of previously discussed projects and identify priorities to provide direction to staff for the 2024 year.

#### **Background & Discussion**

Throughout 2023, the Public Art Advisory Committee has expressed interest in a variety of small to medium-sized projects. A summary of those projects include:

- Plug Preserve relocation project (See Attachment 1)
- Firth Park (Helix & Turtle refresh, Barrier adjacent to Glen Park, benches, marquee sign, etc.)
- Artful benches throughout town
- Crocker Trail Master Plan art implementation
- Review Public Art Ordinance and Implementation Guidelines to consider updates
- Decorative mailboxes
- Surprise art around town

Other ideas discussed but not supported by existing guidelines/use of Public Art Funds:

- "A Day in Brisbane" photo showcase (Push Pin party concept)
- Chalk Art event
- Film Festival

At this time, staff is requesting that the Committee prioritize the list of prospective projects so that time and efforts can be focused in order to achieve the desired outcomes. It is important that the Committee also consider that we are embarking on the Public Art Master Planning effort which will consume most of the calendar year and will require significant outlay of staff and Committee member time and energy.
