SUBJECT: Application for Quarry Redevelopment

Background

At the March 10th Subcommittee meeting, Tyler Higgins from Orchard Partners will be presenting his concept for redeveloping the Guadalupe Quarry from its current use as a Quarry to commercial warehouse development.

As the Subcommittee is aware the Quarry is just outside of the current City boundary limits. An annexation into the City would be required for redevelopment of the site. The Quarry has been in the City of Brisbane's sphere of influence at least since the 1990's. The 1994 General Plan envisioned the site for an extension of Crocker Industrial Park.

In the past several months using the City's standard reimbursement process City staff contracted with Fehr and Peers to provide traffic information regarding the potential future development of the site with a warehouse project. That information has informed the developer in his concept of the site.

The purpose of the subcommittee meeting is for Mr. Higgins and his team to show the subcommittee members their development concept and get initial, non-binding feedback from the subcommittee.

If Mr. Higgins decides to move forward with an application, it will be subject to full environmental review. It is also anticipated that a Development Agreement will be negotiated and various community benefits will be negotiated. Project approvals and mitigations may also address a number of aspects that the community would be interested in including trail heads for access to San Bruno Mountain, etc.
