I also lead analyses of funding and budgets for childcare and recreation programs so am very knowledgeable about program administration and finance. I have also worked on many community engagement campaigns, including resident and parent surveys in multiple languages, to help assess needs and service preferences, and then have worked to implement improvements based on community input.

I have also worked diligently over the past ten months on projects to adapt programming to meet the challenges of the pandemic, both shifting services to virtual and meeting the health and safety codes for in person programming. I would bring this experience to the position to draw from for the duration of the pandemic.

I have a master's degree in public policy with a focus on youth policy, and coursework completed in public budgets and program administration and evaluation.

## Why do you want to be a member of the above Commission/Board?

Ensuring that government-funded services meet community needs is one of my professional and personal passions. As an active User of Parks and Recreation facilities and offerings, and most importantly as a parent of two children who have been very actively engaged in the Recreation and Parks programming, I would like to lend my expertise and experience in municipal recreation and youth programming to help guide the City's decisions about parks and recreation. I have over a decade of experience in program evaluation, policy and legislative review, and budget and finance analysis. I am very familiar with the Bay Area and more specifically San Mateo, it's parks and recreation offerings. I also have worked on several projects related to collaboration between City Departments and School Districts and non-profit organizations that are relevant to programs that take place on school campuses in Brisbane. I have also worked on many community engagement campaigns, including resident and parent surveys in multiple languages, to help assess needs and service preferences, and then have worked to implement improvements based on

community input. As I mentioned above, ensuring that government-funded services meet community needs is one of my professional and personal passions.
