Mike has engaged two appraisers and hope to have the appraisals soon. A Request For Proposal (RFP) draft has been created for your review. Council member Tuholski suggests the draft should reflect purchase or lease. Council agrees on the draft and legal counsel Bowman reviewed the next steps and the involvement of the Redevelopment Commission (RDC).
