### **REPORTS**

New executive director of the HUB, Chet Miller-Eshleman introduced himself and spoke to the Hearts United for Bristol (aka the HUB) vision, future plans, staff and the community. Jill Swartz, Assistant Town Manager introduced Sarah Burton. Sarah is a town resident and the Food Resources Coordinator at the HUB. Sarah wanted to highlight one of their long time volunteers, Bill Cavanaugh. He has been a dedicated volunteer for 20+ years and has a deep connection with the individuals and families that come into the food pantry. There will be a surprise send-off for Bill on Wednesday, November 12 at

noon at the food pantry to honor Mr. Cavanaugh. Council President Jeff Beachy read a Proclamation from the Town of Bristol to recognize and honor Bill Cavanaugh.

Committee decided to move forward with Mid-States and R Yoder Construction. The committee is currently looking into references and visiting buildings. Will be meeting with them next week and should be able to come back with a recommendation.

## Raber Golf Course update:

The 30-day waiting period ends November 14. No parties are interested in negotiating a proposal that is compliant with the RFP. Alternate proposals are being prepared to submit to Bristol RDC on Tuesday, November 18 at 5:30p.

Town Manager Mike Yoder recommended that the November 18<sup>th</sup> work session be cancelled and replaced with an RDC Executive Session. We have one proposal in hand and may have two more. Mike also suggests scheduling a Council Executive session as well (real estate issues relevant to the bypass Earthway and Bloomingdale).
