results of a Special Election held November 8, 2022, for the purpose of considering a ballot proposition on the question of reallocating sales and use tax revenue by reducing the rate of sales and use tax for the purposes authorized by Chapters 501, 502, and 505, Texas Local Government Code (Formerly Section 4B of the Development Corporation Act of 1979) and increasing the sales and use tax to

provide revenue for maintenance and repair of municipal streets.

SUMMARY:

A Special Election was held on November 8, 2022, for the purpose of voting on a ballot proposition on the question of reallocating sales and use tax revenue by reducing the rate of sales and use tax for the purposes authorized by Chapters 501, 502, and 505, Texas Local Government Code from the rate of one-quarter of one percent to the rate of one-eighth of one percent; and increasing the rate of sales and use tax to provide revenue for maintenance and repair of municipal streets from one-half of one percent to the rate of five-eighths of one percent, in the Town of Bartonville.

The unofficial cumulative returns for the election were as follows: For: 786 Against: 124. The proposition received a favorable majority vote and was passed.

The Texas Election Code requires that canvassing the results takes place between the 8th day and 11th day after the election.

TOWN OF BARTONVILLE RESOLUTION 2022-

A RESOLUTION CANVASSING RETURNS AND DECALRING RESULTS OF A SPECIAL ELECTION HELD NOVEMBER 8, 2022, FOR THE PURPOSE OF CONSIDERING A BALLOT PROPOSITION ON THE QUESTION OF REALLOCATING SALES AND USE TAX REVENUE BY REDUCING THE RATE OF SALES AND USE TAX FOR THE PURPOSES AUTHORIZED BY CHAPTERS 501, 502, AND 505, TEXAS LOCAL GOVERNMENT CODE AND INCREASING THE SALES AND USE TAX TO PROVIDE REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS

WHEREAS, the Town Council of the Town of Bartonville, Texas ("Town") caused to be published in accordance with the laws of the State of Texas, notice of the special election held November 8, 2022, to consider one ballot on the question of reallocating sales and use tax revenue by reducing the rate of sales and use tax for the purposes authorized by Chapters 501, 502, and 505, Texas Local Government Code from one-fourth of one percent to the rate of one-eighth of one percent; and increasing the rate of sales and use tax to provide revenue for maintenance and repair of municipal streets from one-half of one percent to the rate of five-eighths of one percent; and

WHEREAS, notice of election was properly given by the Town as required by law; and

WHEREAS, the Town Council has considered the returns of said election held November 8, 2022; and

WHEREAS, said election was duly and legally held on November 8, 2022, in the Town and in conformity with the election laws of the State of Texas, and the results of said election have been certified and returned by the proper judge and clerks thereof; and

WHEREAS, the election returns, duly and legally made, showed that there were cast in said election a total of 910 valid and legal votes, of which 26 were cast absentee, 697 were cast early, and 187 were cast on election day; and that the measure in said election received the following votes:

PROPOSITION #1

"The reduction of the sales and use tax authorized under The Development Corporation Act of 1979 and Chapters 501, 502 and 505 of the Local Government Code, in the Town of Bartonville, Texas, from the rate of one-quarter of one percent to the rate of one-eighth of one percent; and the adoption of a local sales and use tax in the Town of Bartonville, Texas, at the rate of five-eighths of one percent to provide revenue for maintenance and repair of municipal streets."

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE TOWN COUNCIL OF THE TOWN OF BARTONVILLE, TEXAS:

SECTION 1

The Town Council of the Town of Bartonville, Texas, officially finds and determines an election was duly ordered to be held in the Town of Bartonville, Texas, on the 8th day of November, 2022, for the purpose of voting on a ballot proposition on the question of reallocating sales and use tax revenue by reducing the rate of sales and use tax for the purposes authorized by Chapters 501, 502, and 505, Texas Local Government Code from one-fourth of one percent to the rate of one-eighth of one percent; and increasing the rate of sales and use tax to provide revenue for maintenance and repair of municipal streets from one-half of one percent to the rate of five-eighths of one percent, in the Town of Bartonville, Texas. Further, that proper notice of said election was duly given; that said election has been made and delivered; and that the Town Council has duly canvassed said returns, which is attached hereto as *Exhibit A*, were made in accordance with the law.

SECTION 2

The Town Council of the Town of Bartonville, Texas, officially finds and determines that only qualified resident voters of the Town were allowed to vote at said Special Election, the following votes were cast at said Special Election, and that the canvass of the votes cast in said election and returns thereof, which is attached hereto as *Exhibit A*, were made in accordance with the law.

FOR AGAINST 796 "The reduction of the sales and use tax authorized 124 under The Development Corporation Act of 1979 and Chapters 501, 502 and 505 of the Local Government Code, in the Town of Bartonville, Texas, from the rate of one-quarter of one percent to the rate of one-eighth of one percent; and the adoption of a local sales and use tax in the Town of Bartonville, Texas, at the rate of five-eighths of one percent to provide revenue *for maintenance and repair of municipal streets*."

SECTION 3

The Mayor is hereby authorized and directed to execute and deliver this order canvassing the Special Election, in accordance with the Texas Election Code and all other necessary action in connection herewith.
