Peter Lysy – Local History Room Archivist and local historian. Had questions about some aspects of the design. In the drawing, the canopy is higher than the roof instead of subordinate to it. He felt that covering up the pea gravel panels was an aesthetic mistake as well. He also wanted everyone to be aware that next year is eligible to pursue certain tax credits dependent on their decisions.

VIII. New Business

A. Exterior Facade Plan for the Honor Credit Union project at 128 N. Main St.

Built in the international architectural style in 1963. Building hasn't been changed much since the 70's. Their intent is not to change much of the exterior building beyond updating the color palette to match Honor's branding. They would like to cover the existing pea gravel panels due to their

looking dingy. Open to explore cleaning them but have plans to cover them with a metal panel reminiscent of existing Honor buildings.

There was discussion about changing the canopy height as well as other elements of the buildings.

Paolucci suggested they consider the application again after resubmittal, given that there were questions that needed answering and some speculation over design elements. Barker would also like to know how they would place the metal plating over the pea gravel.

Motion made by Paolucci, supported by Barker for resubmittal based on different elevation of the canopy. Voice vote carries unanimously.
