

Watervliet City holds regular meetings once a month. Commissioners receive \$45 per meeting, which includes special meetings. The Mayor is paid \$50 per meeting, including special meetings under a City Manager form of government.

Allegan City holds regular meetings twice a month. Commissioners receive \$50 per meeting, which includes special meetings. The Mayor receives \$55 per meeting, also including special meetings. The city operates under a City Manager form of government.

Buchanan City holds regular meetings twice a month. Commissioners receive \$50 per meeting. The Mayor receives \$70 per meeting. Special meetings are only paid if the meeting is over an hour at an hourly rate of \$15.00.

New Buffalo City holds regular meetings once a month. Commissioners receive a yearly payment of \$1,025 per year plus \$50 per meeting. The Mayor receives yearly payment of \$1,225 per year plus \$60 per meeting.

South Haven City holds regular meetings twice a month. Commissioners receive a salary of \$1,720 per meeting (\$144.33 per month). The Mayor receives a salary of \$2,220 (\$185 per month).

The Village of Cassopolis holds regular meetings once a month. The board receives a monthly payment of \$165. The Village President receives a monthly payment of \$300.

Niles City holds regular meetings twice a month. The Commission and Mayor receive a \$600 monthly payment.

*****Charter Townships are governed by a board of trustees, which consists of the Supervisor, Clerk, Treasurer, and four trustees. The Supervisor, Clerk, and Treasurer handle the day-to-day operations of the township. The trustees serve in a role similar to that of a commission or council.*******

Bertrand Township Trustees hold regular meetings once a month. The trustees receive a monthly pay of \$542.08

Buchanan Township holds regular meetings once a month. The trustees receive a monthly pay of \$433.35
