#### SUMMARY:

City staff previously provided the City Council and Planning and Zoning Commission a briefing on proposed text amendments to the city's Zoning Ordinance in anticipation of a voter referendum that would allow for liquor/package stores. Staff has attached the proposed text amendments as Exhibit 2. As required under state law, it will be necessary to conduct public hearings to solicit feedback for changes affecting the city's zoning regulations. In an effort to streamline the public hearing process, staff is recommending a joint City Council and Planning and Zoning Commission meeting for the date of March 4, 2024.

#### **RECOMMENDATION:**

Staff recommends the Planning and Zoning Commission approve a minute order recommending approval the resolution setting a joint City Council and Planning and Zoning Commission public hearing date of March 4, 2024.

# Background/Roadmap



- On January 8, 2024, the City Council received a presentation on proposed text amendments to the City's Zoning Ordinance regarding liquor/package stores. (The Planning and Zoning Commission received the same presentation on December 19, 2023).
- To amend the zoning ordinance, state law requires the City hold and give notice of a public hearing to solicit feedback on the proposed changes to the City's zoning regulations.
- As discussed on January 8<sup>th</sup>, staff is recommending the public hearing and consideration of the amendment occur at a joint meeting of the City Council and Planning and Zoning Commission. The City's zoning ordinance requires that the joint hearing be called by a Council resolution.
- The items before the Commission tonight are two resolutions. The first resolution sets the date of the public hearing and joint meeting. The second resolution sets the notification standards for the hearing and joint meeting.

## **Resolution Number 2 – Method and Type of Notice**



- The second proposed resolution requires that notice of the public hearing at the joint meeting of the Council and Commission be given by publishing notice of the date, time, meeting type, subject to be considered, and location in the newspaper at least twice.
  - The first notice shall be published at least 15 days before the date of the public hearing.
  - The second notice shall be published at least 10 days before the date of the public hearing.
- By setting a joint hearing, the law allows the Council to set notification standards without the necessity of mailing notices to individual property owners

**WHEREAS,** the City of Burleson, Texas ("City"), is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, on April 19, 2010, the City Council passed, approved, and adopted Ordinance B-582, being the zoning ordinance and map of the City of Burleson, Texas, showing the locations and boundaries of certain districts, as amended, and codified in Appendix B of the City of Burleson Code of Ordinances (2005) (the "Zoning Ordinance"); and

**WHEREAS,** on January 8, 2024, the City Council received a report and held a discussion regarding amending the text of the City's Zoning Ordinance regarding liquor sales, and

**WHEREAS,** in accordance with Sections 211.006 and 211.007 of the Texas Local Government Code and the City's Zoning Ordinance, the City Council desires to set a public hearing to take place at a joint meeting of the City Council and the City's Planning and Zoning Commission regarding amending the text of the City's Zoning Ordinance regarding liquor sales.

### NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS, THAT:

#### Section 1.

City Council hereby sets a joint public hearing to be held at a special joint meeting of the City Council and the Planning and Zoning Commission to consider an ordinance amending the text of the City's Zoning Ordinance codified in Appendix B of the City of Burleson Code of Ordinances relating to liquor sales with the following conditions:

#### SUMMARY:

Appendix B, Article I, Section 6-105 (f) of the City's Code of Ordinances prescribes the type of notice to be given for a joint public hearing between the City Council and the Planning and Zoning Commission. The Code provision is written as follows:

The city council may, by resolution, elect to combine the planning and zoning commission hearing and the council hearing; however, the city council shall not take action upon any proposed amendment or change until it has received the final report and recommendation from the planning and zoning commission. When the joint hearing provision of this ordinance is in effect, the city council shall cause a notice showing the time and place of the hearing to be published in a newspaper of general circulation at least 15 days prior to the hearing. In addition, notice of all jointly held public hearings on proposed changes in classification shall be sent to owners of real property lying within 200 feet of the property on which the change in classification is proposed, the notice to be given not less than ten days before the date set for hearing, to all the property owners as the ownership appears on the last approved city tax roll. Such notice may be served by depositing it, properly addressed and postage paid, in the United States mail. When any such amendment relates to a change of a zoning regulation or to the text of this ordinance not affecting specific property, notice requirements shall be the same as those specified in paragraph (c), above.

#### **RECOMMENDATION:**

Staff recommends approval of the method of notice as detailed in the resolution.

#### NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY **OF BURLESON, TEXAS, THAT:**

#### Section 1.

The City Council directs the City Manager or the City Manager's designee to give notice of the joint public hearing at the special joint meeting of the City Council and the Planning and Zoning Commission described above and by publishing notice of the joint public hearing in the Fort Worth Star-Telegram twice. A first notice shall be published before the 15<sup>th</sup> day before the date of the joint public hearing, and a second notice shall be published before the 10<sup>th</sup> day before the date of the joint public hearing. Notice of the joint public hearing shall state the meeting type, the time and place of the joint public hearing, and the subject to be considered. RESOLUTION
