Call to Order: Mayor Gary Wideman called the meeting to order at 11:38 a.m.

CONSIDERATION ITEMS:

2.1) Discuss and consider action: Request from C3 Air Works to lease the maintenance hangar and a portion of the FBO building at Burnet Municipal Airport:

City Manager David Vaughn reported that the current lease with Crosby Services is set to expire in January 2026. He noted that Crosby Services has sold the maintenance portion of their business to C3 Air Works, whose ownership has expressed interest in establishing a new lease upon the expiration of the existing agreement.

Mr. Vaughn explained that there are several moving parts involved in creating a new lease agreement, including considerations regarding the CAF and potential locations for each business. He stated that, if Council elects to move forward, the new lease with C3 Air Works would be structured as a one-year contract, consistent with the terms offered to the current FBO.

Councilman Philip Thurman made a motion to proceed as discussed. Council Member Ricky Langley seconded the motion. The motion passed unanimously.

2.2) Discuss and consider action: Amendment to the Honey Rock Development Agreement: D. Vaughn

City Manager David Vaughn reported that developers with Honey Rock Development have requested a rezoning of a portion of their plat. The area in question, located near the highway, is currently zoned C-2 Medium Commercial. Shawn Nelson, a representative of the developer for Honey Rock, stated that they would prefer a significant portion of the area be rezoned to R-3, noting that the remainder of their property already includes an R-3 zone and they would like that designation extended closer to the highway.

Mr. Nelson described the proposed multifamily housing as a higher-end product intended primarily

for retirees. He also explained that Honey Rock plans to construct a sound barrier to buffer highway noise and provide additional privacy.

Council directed City Staff to proceed with creating a zoning designation specific to the type of multifamily housing proposed by Mr. Nelson and Honey Rock Development, rather than an R-3 Multifamily zoning.

5.1) Burnet Police Department Quarterly Report: B. Lee:

Police Chief Brian Lee informed the Council that all updates to the gun range have been completed, and it is now considered one of the best training facilities in the area. Several nearby agencies have been using the facility frequently. Chief Lee also reported that the City of Burnet Police Department averages about 118 activities within a 24-hour period, including calls for service, traffic stops, arrests, and accidents. He provided additional statistics on animal control, investigations, and code enforcement, noting that 17 investigation cases were cleared during the quarter. Code enforcement handled a total of 90 cases, most of which involved complaints of high grass.

The necessary repairs are extensive and include the installation of a 15-inch main to allow for improved runoff. The cost of these repairs is estimated to range from \$50,000 to \$100,000.

In addition to the golf course pump station, the YMCA ballfields were discussed. A request has been made for restroom facilities on the upper fields, with an estimated cost of approximately \$175,000. Additional requests included batting cages and a shade structure.

At this time, Council determined that the most critical needs are the golf course pump station repairs and the addition of bathrooms at the YMCA ballfields.

Council Member Ricky Langley made a motion to approve the repairs to the golf course pump station house, up to \$100,000 and the purchase of a new restroom facility from CXT for \$144,000, with a total cost of the restrooms not to exceed \$175,000 for the YMCA ballfields. Information

The subject property is an undeveloped lot located on the south side of East Kerr Street in the middle of the block between North Pierce Street and North Main Street. It is currently zoned as Single-Family Residential – District “R-1”.

This lot was originally part of a larger lot situated at the corner of North Main and East Kerr Street. Following the recent platting process that subdivided the original parcel into two separate lots, the applicant is now requesting a rezoning of this lot to Duplex – District “R-2” to allow for the potential construction of a two-unit residential building.

District “R-2” zoning allows two-, three-, and four-unit residential structures, requiring a minimum living area of 900 square feet per unit. The zoning district also requires a minimum lot size of 4,500 square feet per unit and a minimum lot width of 75 feet. The subject lot is 11,064 square feet and has a lot width of 80 feet, meeting all minimum requirements for the proposed zoning classification.

The property is served by all City water, sewer, and electric utilities and is not located within a special flood hazard area.

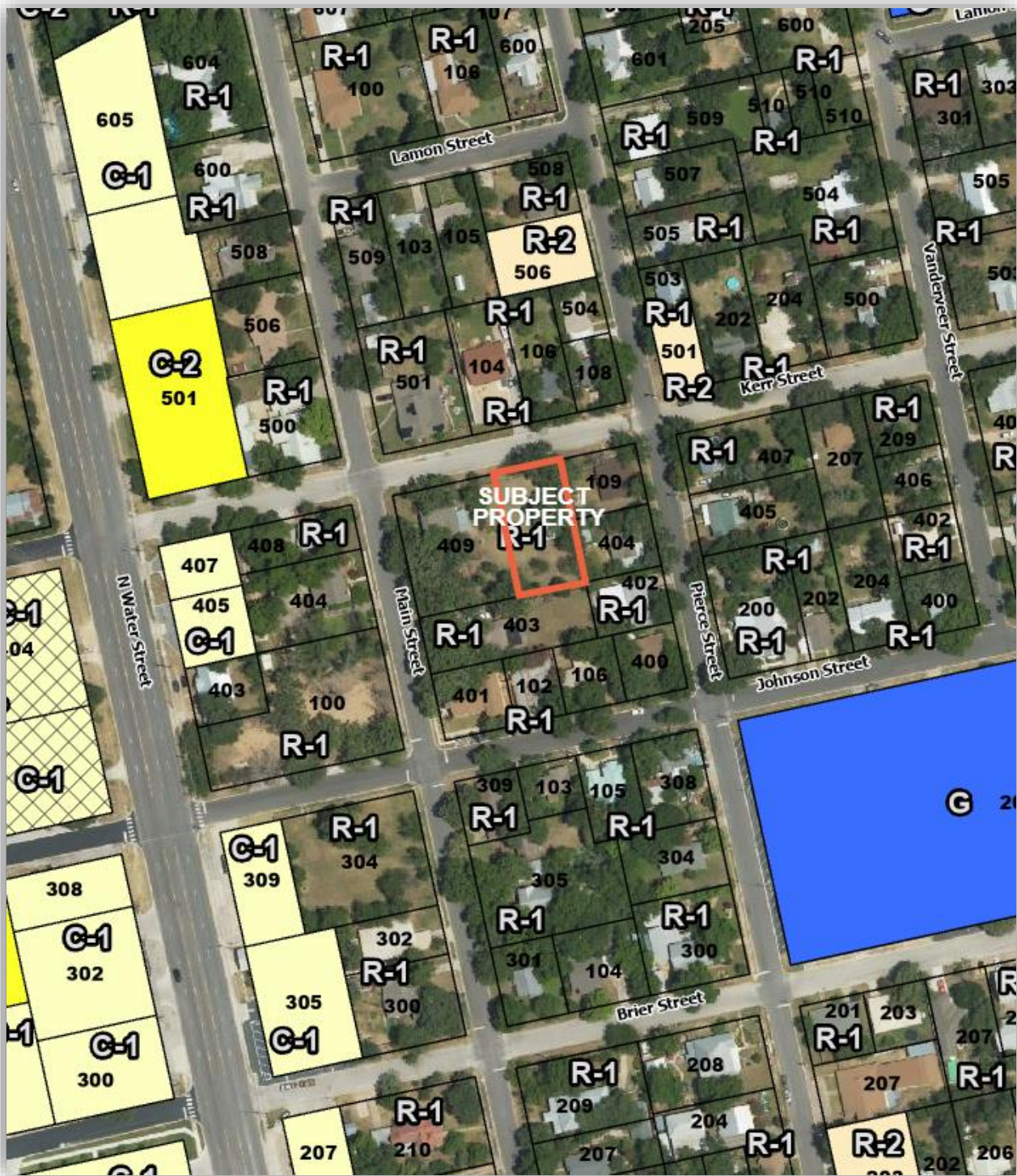


Exhibit A – Location North of Hwy 29 and East of Hwy 281

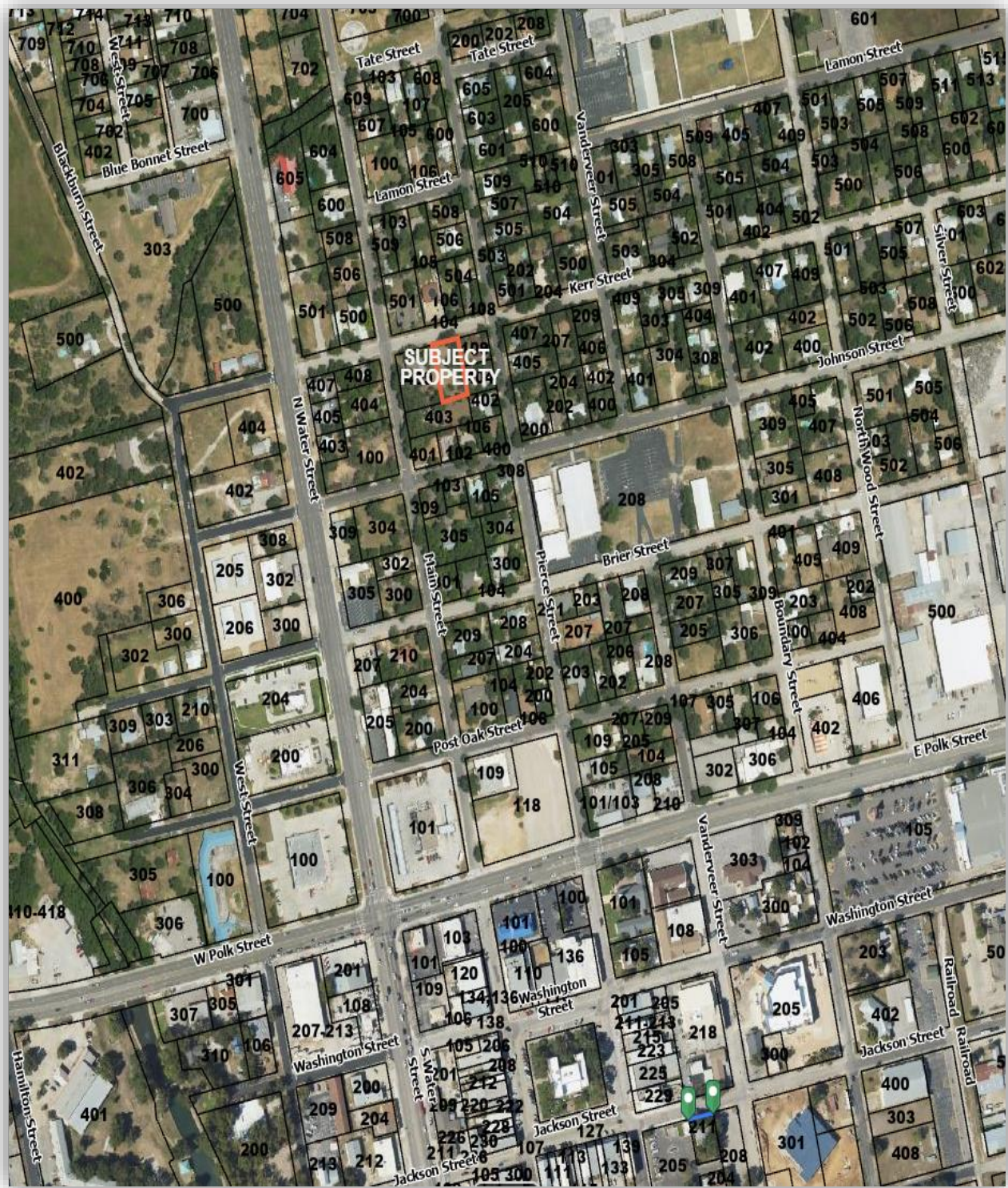

As a resident of Burnet and owner of 106 E. Kerr Street., I am writing to oppose the rezoning of 105 E. Kerr Street. My family have been residents of Burnet for three generations, starting when my grandparents first built a home here in 1960. I grew up visiting my grandparents and spending summers with them, and fell in love with this small, country town. I eventually made Burnet my permanent home and not much had changed other than the number of residents. It still had that old town, close knit feel of a small town.

I purchased 106 E. Kerr St. because it was in a quaint, quiet neighborhood with small, older homes that represent the history of Burnet. I intend to retire and make 106 E. Kerr St. my final, permanent home. I love the street because many of the neighbors are Burnet natives and appreciate the old town feel. Also, Kerr Street is lined with simple but beautiful homes surrounded by old pecan, oak and many other types of old trees. To remove this historic look by adding a duplex would completely change the feel and look of our street and neighborhood. The modern look would be an eyesore and take away from the vast unique, but older architecture of the homes on our street.

I want the City Council to consider the following:

The purpose of a comprehensive zoning plan is to bring stability and predictably to land use patterns to a community. I see that your department is taking proactive steps to bring other areas in town into a more cohesive state by changing zoning to match existing land usage. Spot rezoning in my neighborhood does not accomplish this goal.

The City of Burnet has recently announced grants for the development of multi-family units in an area of town already zoned for this use. The City's Zoning Board does not to make zoning decisions based on economics of a single residential lot.

The construction of a two story structure consisting of two living units each with 3 bedrooms represents high density development not usually consistent with what most people associate with a duplex.

There are no other duplexes of this nature nearby. The existing neighborhood is all single family units.

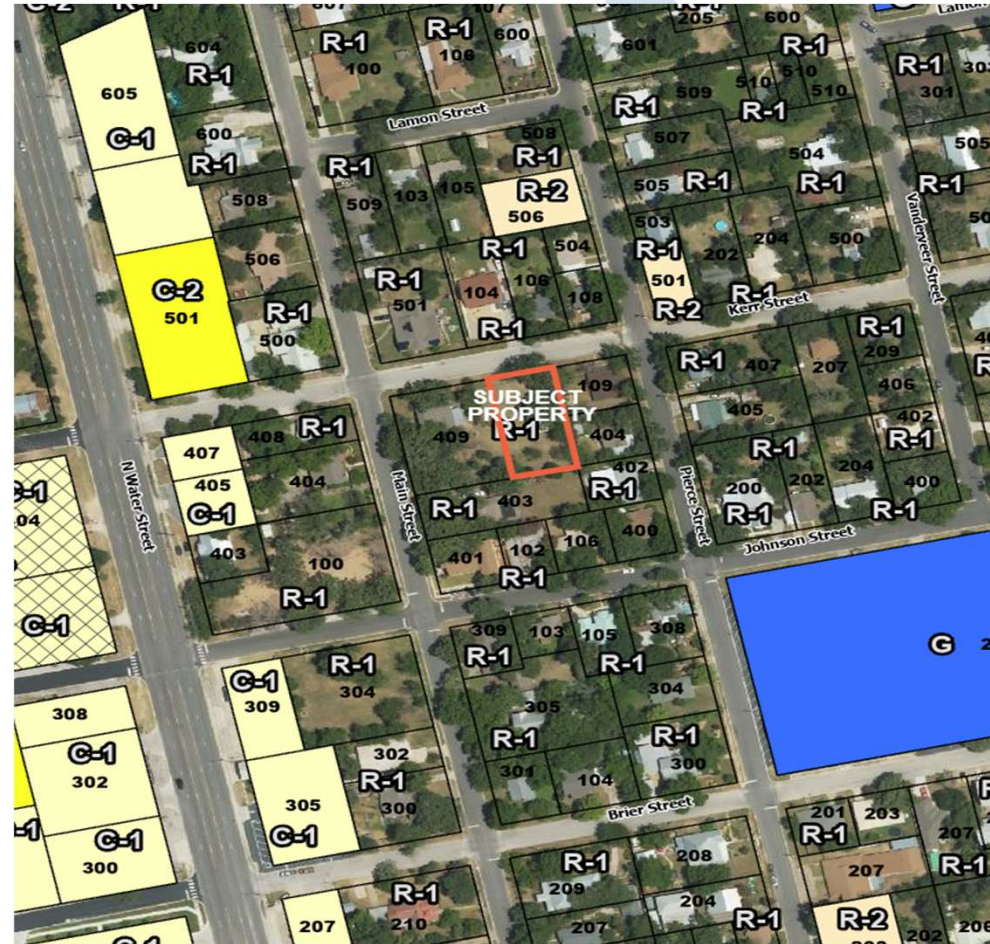

Information

A General Election will be held on May 2, 2026, for the purpose of electing:

- Three (3) City Council Members, At-Large, each to serve a full two-year term; and
- One (1) City Council Member, At-Large, to serve the remainder of an unexpired term ending by election on May 1, 2027.

The election will be conducted in accordance with the Texas Election Code and applicable laws of the State of Texas.

Council Members Tommy Gaut and Cindia Talamantez are completing their first terms of office and are eligible for re-election. Council Member Philip Thurman is completing his third and final term. Each of these Council positions carries a two-year term, with terms set to expire in May 2028.

In addition, the resignation of Council Member Tres Clinton has resulted in a vacancy on the City Council. This position shall be filled for the remainder of the unexpired term ending by election on May 1, 2027.

The offices of City Council Member for a full two-year term and City Council Member to fill the remainder of an unexpired term are separate and distinct offices under the Texas Election Code. A person may file an application for only one (1) City Council position in this election and may not file for both a full two-year term and the unexpired term.

Fiscal Impact

The total estimated election expenses are not expected to exceed \$2,000.00.

RESOLUTION R2026-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, ORDERING A GENERAL ELECTION TO BE HELD ON MAY 2, 2026, TO ELECT THREE (3) CITY COUNCIL MEMBERS FOR FULL TWO-YEAR TERMS AND ONE (1) CITY COUNCIL MEMBER TO FILL AN UNEXPIRED TERM; ESTABLISHING THE ELECTION PROCEDURE; AND PROVIDING FOR RELATED MATTERS

WHEREAS, on May 2, 2026 there shall be elected the following officials for this City: three (3) City Council Members for full two-year terms and one (1) City Council Member to fill the remainder of an unexpired term ending by election on May 1, 2027; and

WHEREAS, the Texas Election Code is applicable to said election and this resolution establishes procedures consistent with the Code and designates the voting place for the election; and

WHEREAS, the City of Burnet, Texas (hereinafter the "City") has made provision to contract with Burnet County to conduct the City's general election, pursuant to *Chapter 31, Tex. Elec. Code*, and *Chapter 791, Tex. Gov't Code* (the "Election Agreement" or "contract"), jointly with Burnet Independent School District and any other political subdivisions that hold elections on the same day in all or part of the same territory of the City, as authorized in *Chapter 271, Tex. Elec. Code*;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS

SECTION 1. General Election. The General Election of the City shall be held on Saturday, May 2, 2026, for the purpose of electing:

- Three (3) City Council Members, At-Large, each to serve a full two-year term; and
- One (1) City Council Member, At-Large, to serve the remainder of an unexpired term ending by election on May 1, 2027.

Candidates at the election for the above offices shall file their application to become candidates with the City Secretary of the City of Burnet, at City Hall, 301 East Jackson, Burnet, Texas 78611, between 8:00 a.m. on January 14, 2026 and 5:00 p.m. on February 13, 2026. All applications for candidacy shall be on a form as prescribed by the *Tex. Elec. Code*. The order in which the names of the candidates for each office are to be printed on the ballot shall be determined by a drawing conducted by the City Secretary.

The offices of City Council Member for a full two-year term and City Council Member to fill the remainder of an unexpired term are separate and distinct offices under the Texas Election Code. A person may file an application for only one (1) City Council position in this election and may not file for both a full two-year term and the unexpired term.

SECTION 2. Notice of the election shall be given and the election shall be held in compliance with the provisions of the *Tex. Elec. Code* in all respects. The ballots for the election shall comply with the *Tex. Elec. Code* and be in the form provided by the City to the Burnet County Clerk for use on the voting devices and ballots used by Burnet County.

SECTION 3. The Burnet County Clerk and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election, shall hold and conduct the election in the manner provided by contract with the City and the law governing the holding of general elections by home rule cities of the State of Texas; and the official ballots, together with such other election materials as are required by the *Tex. Elec. Code*, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.

SECTION 4. Early voting, both by personal appearance and by mail, will be conducted by the Burnet County Clerk, who is designated and appointed as the Early Voting Clerk, in accordance with the *Texas Election Code*. Early voting by personal appearance shall be conducted at the times, places, and locations authorized by state law and the Burnet County Clerk. Early voting shall commence on Tuesday, April 20, 2026 and continue through Tuesday, April 28, 2026. Early voting shall also be held at any time and location authorized by the Burnet County Clerk.

SECTION 5. The polling place for each such election precinct shall be the polling place established by Burnet County for such election precincts in Burnet County and voting by residents of the City. The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m. The returns for precincts in Burnet County will be provided by precinct and the Burnet County Clerk shall tabulate and provide the election returns for the election.

SECTION 6. The City Secretary, or designee, is instructed to aid the Burnet County Clerk in the acquisition and furnishing of all election supplies and materials necessary to conduct the election as provided by the Election Agreement. The City Secretary is further authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Tex. Elec. Code* and *City Charter*; provided that, pursuant to the Election Agreement between Burnet County and the City, the Burnet County Clerk shall have the duty and be responsible for organizing and conducting the election in compliance with the *Tex. Elec. Code*; and for providing all services specified to be provided in the Election Agreement. The Burnet County Clerk shall give the notices required by the *Tex. Elec. Code* to be given for the election not required to be given by the City under the Election Agreement.

SECTION 7. The presiding judges, alternate presiding judges and clerks for the election shall be selected and appointed by Burnet County and its appointees in compliance with the requirements of state law, and such judges and clerks so selected by Burnet County and its appointees are hereby designated and appointed by the city council as the election officers, judges and clerks, respectively, for the holding of said general election. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law. The city council will further confirm and appoint the election judges and alternate election judges that are appointed by Burnet County for the election.

SECTION 8. Notice of the election shall be given by posting a notice containing a substantial copy of this resolution on the bulletin board used for posting notice of meetings of the governing body at the City Hall and at the aforesaid election day polling places not later than the twenty-first (21st) day before the election, and by publishing said Notice of Election at least one time, not earlier than thirty (30) days no later than ten (10) days prior to said election, in a newspaper of general circulation in the City. The notice that is posted, and the notice that is published in a newspaper of general circulation within the city, will be written in both English and Spanish.

SECTION 9. The election shall be held and conducted by the Burnet County Clerk in compliance with state law and the Election Agreement. This resolution shall be in force and effect from and after its passage on the date shown below.

SECTION 10. It is hereby officially found and determined that this meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Open Meetings Act, *Chapter 551, Texas Government Code*.

Information

Under Local Government Code (LGC) 2254, the State of Texas requires local governments to select professional services—such as surveying, engineering, and architecture—based on qualifications first, followed by price negotiations.

The City currently needs surveying and environmental services to assist with the NRCS buyout program for flooded properties, including commercial, residential properties, and vacant properties. This procurement also provides an opportunity to engage surveying and environmental services for future projects.

A Request for Qualifications (RFQ) was issued in December, and several statements of qualifications (SOQs) were received before the December 29, 2025, 11:00 AM deadline. Staff have reviewed the submissions and recommend the attached ranking. Several of the firms either submitted qualifications for Environmental services only or surveying services only, or general qualifications using sub-consultants for either specialty. Two of the firms failed to provide a hard copy as requested by the RFQ and were not considered.

The seven SOQs were ranked and are presented herein. Among these, Quatro Consultants demonstrated the strongest qualifications, extensive history with the City, and best fit to support the City's needs based on the basis of demonstrated competence and experience.

This agenda item authorizes the selection of the recommended firm and empowers the City Manager to execute a professional services contract. If the contract exceeds the legal limit or an amount not budgeted or approved by Council, it will be brought before the City Council for approval.

Fiscal Impact

All expenses related to the design are expected to be covered by the individual project budget allocation.

WHEREAS, the City issued a Request for Qualifications and received nine Statements of Qualifications by the December 29, 2025, deadline for Surveying and Environmental Services; and

WHEREAS, two of the nine Statements of Qualifications were submitted electronically rather than in physical hard-copy format as required by the RFQ and, therefore, were deemed non-responsive and were not evaluated; and

WHEREAS, City staff evaluated and ranked the remaining seven responsive Statements of Qualifications in accordance with the criteria set forth in the RFQ; and

WHEREAS, the City Council desires to accept the City staff recommendation ranking of the statements of qualifications and selection of a surveying and environmental firm services to assist the City on other forthcoming projects; and

WHEREAS, the City staff ranked the submittals and determined that Quatro Consultants demonstrated the strongest qualifications and best fit to support the City's needs based on demonstrated competence and experience; and

WHEREAS, after considering City staff's recommendation, public testimony presented at the public meeting where this resolution was read for the Surveying and Environmental Services for the City of Burnet, the City Council deems the Quatro Consultants Statement of Qualifications to be the most qualified on basis of demonstrated competence and experience and beneficial to the City on impending and other forthcoming projects.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT:

Section One. Findings. The recitals set out above are hereby approved and incorporated herein for all purposes.

Section Two. Selection and Award. City Council finds and determines the following:

- The Quatro Consultants statement of qualifications **is the most qualified**; and
- The Quatro Consultants is hereby selected as the Surveying and Environmental Services (firm) statement of qualifications proposal is hereby selected subject to the provisions set out in Section Three below.

Section Three. Authorization. The City Manager is hereby authorized and directed to execute an instrument substantially similar to the Professional Services Contract

approved in Section Two above, for a contract amount not to exceed council budgeted amounts - and to take such further actions and execute such ancillary documents as may be reasonably necessary to facilitate the purpose of this resolution.

Section Four. Open Meetings. It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

Section Five. Effective Date. That this resolution shall take effect immediately upon its passage, and approval as prescribed by law; provided that the city manager shall comply with the time restriction stated in Section Three.

Seven SOQs were evaluated by staff and ranked based on several criteria that demonstrated competence and experience, and results are attached.



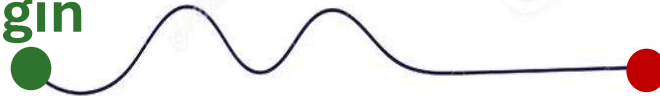

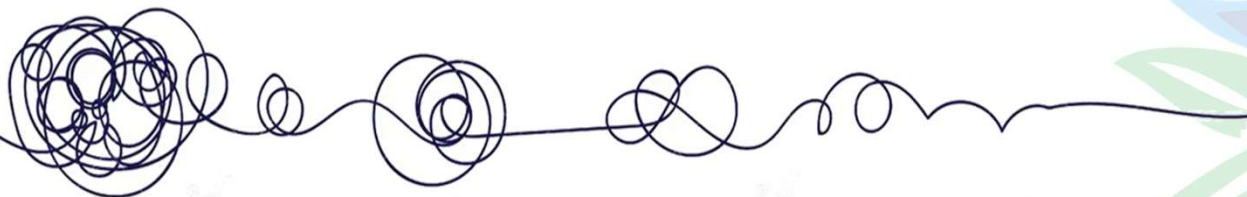

What is FEMA Public Assistance

- FEMA Public Assistance (PA) helps local governments recover from declared disasters
 - Reimburses eligible costs for:
 - Emergency response
 - Debris removal
 - Repair or replacement of damaged public facilities
- FEMA does not pay upfront- costs are reimbursed after review, approval, and the project is completed
- **FEMA reimburses 75%** of eligible disaster recovery costs
- The **City is responsible for 25%** of eligible costs



TDEM's Role (Texas Division of Emergency Management)

- Acts as the State partner between the City and FEMA
- Provides technical assistance and guidance throughout the process
- TDEM is the City's primary day-to-day contact
- Funding will flow from FEMA → TDEM → City



FEMA Projects

- A group of disaster-related damages that are similar in type, location, and scope of work, and are combined for funding, review, and reimbursement
- The City of Burnet has identified **17 FEMA Projects** and all of them are classified as “Small Projects” except one
- A Small Project is one where the total eligible **cost is less than \$1,062,900**
 - Simplified Processing
 - Actual costs are not reconciled dollar-for-dollar at closeout
 - If the City completes the approved work for less than the estimate, the City keeps the savings and FEMA does not reconcile the final cost
 - On the flipside- the City is also responsible for any cost overruns



FEMA Categories

17 FEMA Projects Divided Among 7 Categories

- Category A: Debris Removal **1 Project**
- Category B: Emergency Protective Measures **1 Project**
- Category C: Roads and Bridges **3 Projects**
- Category D: Water Control Facilities **1 Project**
- Category E: Buildings and Equipment **1 Project**
- Category F: Utilities **3 Projects**
- Category G: Parks and Other Public Facilities **7 Projects**
- Category Z: Administrative and Management Costs
 - Category Z includes the costs of managing FEMA projects, and since it is limited to 5% of the total eligible recovery costs, it can only be finalized after all FEMA projects are complete

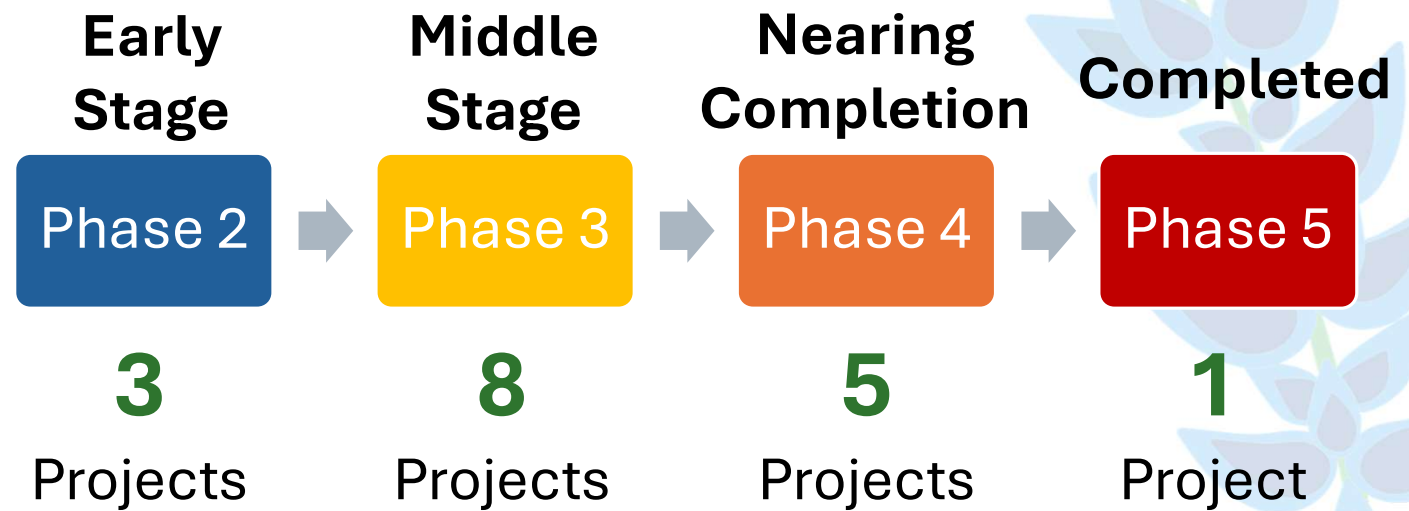
