<u>CALL TO ORDER</u>: The meeting was called to order by Board President Cary Johnson at 3:00 p.m. and a quorum was established.

CONSENT AGENDA:

<u>Approval of the September 17, 2024, BEDC Regular Meeting minutes:</u> Board Member David Vaughn moved to approve the consent agenda as presented. Board Member Philip Thurman seconded. The motion carried unanimously.

ACTION ITEMS:

Discuss and consider action: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE BURNET ECONOMIC DEVELOPMENT CORPORATION AUTHORIZING THE SALE OF REAL PROPERTY LOCATED AT 229 SOUTH PIERCE STREET BURNET, TEXAS, TO BURTEX HOLDINGS, LLC: Board Member Philip Thurman made a motion to authorize resolution BEDC R2024-04 as presented. Board Member David Vaughn seconded the motion. The motion carried unanimously.

Discuss and consider action: A RESOLUTION OF THE BURNET ECONOMIC DEVELOPMENT CORPORATION OF THE CITY OF BURNET, TEXAS AUTHORIZING REIMBURSEMENT OF THE CONSTRUCTION INCENTIVE AND OVERPAYMENT TO SEA MOUNTAIN VENTURES, LLC FOR THE NEW TRACTOR SUPPLY STORE: Board Member Keith McBurnett made a motion to approve resolution BEDC R2024-05 as presented. Board Member Philip Thurman seconded the motion. The motion carried unanimously.

Main Street, formerly known as Flights. Building owner, Phil Cordova, has the building up for sale. The Board discussed whether this is a project that the EDC could undertake at this time. Board Member Thurman is going to reach out to Mr. Cordova to gather further information.
