# Financial Report – Executive Summary FYTD September 2025



Overall, the City's major unrestricted funds (excluding golf) ended the year with a bottom line of \$3,077,065.

# **General Fund**

The General Fund ended the year with a profit of \$1,728,733. Their total revenues ended the period above budget at 103% mainly because of strong primary revenue collections.

The General Fund's primary revenues make up 80% of their total revenues and include:

- o **Property tax collections** ended the period at 100% of budget and increased by \$390,069 over last year.
- Sales tax collections ended the period at 103% of budget and increased by \$177,645 over last year.
- o **EMS transfer collections** ended the period at 106% of budget and decreased by \$20,778 over last year.
- o **Transfers In from other funds** ended the period at 101% of budget and increased by \$197,933 over last year.

Total expenditures ended the year under budget at 96%.

# **Golf Course**

The Golf Course ended the period with a profit of \$540,887 which is an increase of \$14,327 over last year.

Total revenues ended the period at 115% of the annual budget. Compared to last year, revenues have increased by \$353,272 mainly because of the green fee and membership rate increases that have gone into effect. In addition, the course saw a 3% increase in green fee rounds over last year.

Total operating expenses ended the year just under budget at 99%.

# **Electric Fund**

The Electric fund ended the period with a profit of \$683,022, which is an increase of \$92,186 over last year. Total revenues ended the period at 101% of the budget. Compared to last year, net electric sales have increased by \$289,076 or 7% mainly because of the change to the purchased

power cost adjustment that went into effect in August of 2024 which now allows the City to factor in power loss when calculating energy charges (see Ordinance 2024-32).

Total expenses ended the year under budget at 97% mainly due to savings in personnel costs from vacancies earlier in the year.

# **Water and Wastewater Fund**

The Water/Wastewater fund ended the period with a profit of \$665,310 which is an increase of \$265,405 over last year.

Total revenues ended the period at 110% of budget and increased \$491,316 over last year. Water and Wastewater sales increased because of a 10% rate increase went into effect on June 1, 2025 and an 11% increase in water consumption. In addition, Use of Impact Fees increased \$115,000 over last year.

Total expenses ended the period at 101% of the budget and increased by \$225,910 over last year. The majority of the increase is in personnel costs because last year, the department had several vacancies. This year, the department has been fully staffed for the majority of the fiscal year, and personnel costs are on track with budget. In addition, the fund is seeing increases in the cost of water, contractual services, and transfers for self-funded equipment over the last year.

# **Airport (Restricted Fund)**

The Airport Fund ended the period with a profit of \$157,092 and is in great shape compared to the budget. Their total revenues ended the year at 109% of budget and total expenses ended the year at 90% of budget.

# **Cash Reserves**

Total "Unrestricted" cash reserve balance for the City as of September 30, 2025, was \$7,153,654. That is **\$2,343,654** above our 90-day required reserve amount.

Total "Restricted by Council" cash reserve balance for the City as of September 30, 2025, was **\$4,001,826.** 

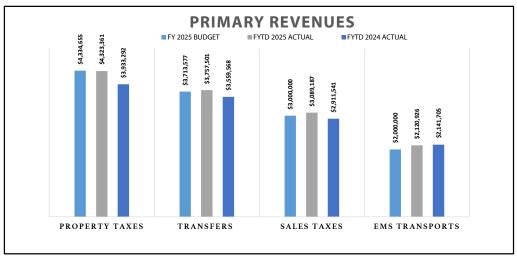


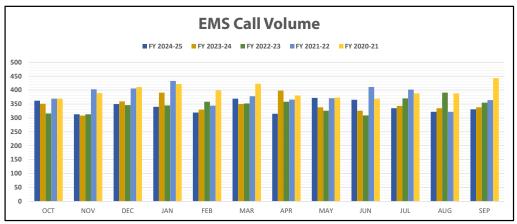

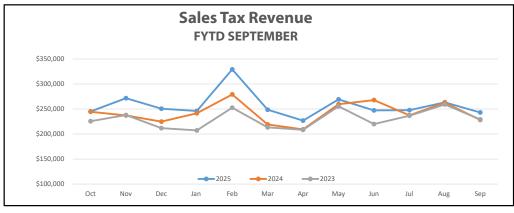

# NOTES AND KEY VARIANCES - BUDGET vs ACTUAL (On a straight line basis, 100% of year is complete) REVENUES

AD VALOREM/PROPERTY TAXES came in as expected which was an increase of over \$390K from last year. The majority of property tax collections were received in January.

SALES TAXES increased 6% from last year and included one time audit payments of \$68,140. The top five industries include Limited Service Eating Places, Other Nonstore Retailers (Gas Stations), Grocery Stores, Resin and Synthetics (Manufacturing) and Building Materials Stores (Retail).

INTERFUND TRANSFERS consist mainly of transfers from the Utility Funds (including Return on Investment (ROI) from Electric and In Lieu of Taxes from Water and Wastewater). Collections finished the year at 101% of budget.

EMS TRANSFER REVENUES were down slightly from last year but finished the year 6% above budget. In total, EMS call volume is down about 2% from last year.

FRANCHISE AND OTHER REVENUES finished the year above budget mainly because of increased delinquent property tax collections and related penalties and interest. Together they totaled almost \$156K.

COURT FINES AND FEES increased significantly over last year and finished the year at 140% in part because there was an increase in the number of moving violations being cited this year which typically results in higher revenue collections.

GRANTS AND DONATIONS ended the year above budget because the Fire Department was awarded \$9,912.35 in July for their participation in the Capital Area Trauma Regional Advisory Council grant program.

LICENSES AND PERMITS ended the year 57% over budget because of increasing construction inspection fees and permit revenues being generated from construction in new subdivisions (Creekfall III and Delaware Springs 25). In addition, subdivision plat fee revenues increased this year.

CHARGES FOR SERVICES include: BEDC payments for Services, Interlocal Revenue from SRO program, ESD fire coverage, Burnet County and Bertram EMS coverage, and sanitation collection revenue. All of which ended the year on track with budget.

OTHER REVENUES include several sources that ended the year above budget and include interest income, insurance claim payments, sale of cemetery lots, PD gun sales, and EMS standby revenues.

#### NOTES AND KEY VARIANCES - BUDGET vs ACTUAL (On a straight line basis. 100% of year is complete) EXPENDITURES

#### CITY COUNCIL

Council Supplies and Materials include Budget/Council workshop expenses which have been increased this year for Strategic Planning and the setting of Council Priorities along with recurring biweekly council luncheons.

Council Designated Expenses include Travel and Training which is running above budget because of the early registrations paid for next year's TML conference in October.

GENERAL ADMIN, CITY SECRETARY, FINANCE, AND HR. In FY2025, began tracking City Secretary, Finance, and HR expenses separately from Administrative.

Admin Supplies and Materials ended the year above budget mainly because of increased postage costs and computer supplies. The increase is being offset by other savings in the fund.

Admin Contractual Services ended the year above budget in part because of higher than budgeted legal services and attorney fees which are being offset by savings in admin personnel costs.

Admin Transfers to cover golf admin expenses ended the year above budget because golf revenues are outperforming budget which increases the admin allocation calculation.

Finance Department Supplies and Materials ended the year above budget mainly because of the purchase of office and computer supplies, and furniture for new staff, along with purchase of 1099 and W2 supplies needed in October.

Finance Department Contractual Services ended the year over budget mainly because of the reclass of audit fees. Originally, audit fees were budgeted in the admin department but moving forward will be accounted for in the finance department for better tracking.

Finance Department Designated Expenses include non-capital supplies which ended the year above budget because of the purchase of a new computer and laptop for added staff in October. In addition, travel and training expenses have come in higher than budgeted because of added staff attending GFOAT.

HR Supplies and Materials ended the year over budget mainly because of the purchase of new monitor, camera, and keyboard needed for director plus bulk purchases of folders, labels and other office supplies. The increase is being offset by savings in other line items within the fund.

HR Contractual Services ended the year above budget mainly because consulting fees for benefits were reclassed to the HR budget for better tracking and because of professional services used for ACA 1095 printing in February.

HR Designated Expenses ended the year over budget mainly because of increasing employee programs and the purchase of a new computer for the department.

#### **EXPENDITURES (Less transfers to capital/other):**

#### MUNICIPAL COUR

Court Supplies and Materials expenses ended the year above budget because of increased operating supplies needed for court community programs and outreach.

Court Designated Expenses ended the year above budget mainly because they include credit card service charge expenses which are directly related to Municipal Court Fines which outperformed budget. Municipal Court Fine collections ended the year at 140% of budget.

POLICE DEPARTMENT, ANIMAL CONTROL, K9 UNIT, AND CODE ENFORCEMENT. In FY2025, began tracking animal control, K9, and code enforcement.

Police Repairs and Maintenance expenses ended the year above budget mainly because of a fleet accident repair which is being offset with insurance claim revenues less a \$1,000 deductible, and significant repairs to Unit 19-03 including cooling system repairs.

Police Capital Outlay expenses were incurred for purchase of an evidence dryer, additional vehicle outfitting needs and a new water heater installed at the Police Department.

Animal Control personnel costs ended the year above budget mainly because employee health insurance was underbudgeted.

Animal Control department Supplies and Materials ended the year above budget mainly because of increased fuel charge outs.

Animal Control department Repairs and Maintenance ended the year above budget mainly because of new flooring required for kennel area to pass inspection.

K-9 Personnel Services ended the year higher than expected because of the unbudgeted overtime expense related to K-9 duties.

Code Enforcement Supplies and Materials ended the year higher than expected because of increased fuel costs and operating supplies needed. Code Enforcement Designated expenses include non-capital supplies which ended the year higher than expected because the code enforcement computer had to be replaced.

#### FIRE/EM

Contractual Service Expenses include communications and utilities which ended the year above budget along with professional services due to consultant fees paid for an unexpected one-time Medicare audit.

Other Designated Expenses include purchase of bunker gear which ended the year over budget due to need to purchase smaller sized bunker gear for new employees.

Capital Outlay ended the year over budget because of insulation work for the ATV shed, upgraded bumpers for Med 1 and Med 3, and the purchase of a new back up ambulance generator. This backup generator will be used when an in service ambulance generator is in need of repair or service so that the ambulance does not have to go out of service.

#### STREETS

Street Department Capital Outlay is over budget because a "Wheel Balancer" and "Tire Changing" machine were purchased for the City Shop and the cost was allocated among the Public Works departments that will benefit from the new machines including Streets.

#### **CITY SHOP**

City Shop Repairs and Maintenance ended the year over budget, mainly because of needed ice machine repairs and fuel master system maintenance.

City Shop Contractual Services ended the year over budget mainly because custodial care costs for public works increased more than expected. City Shop Designated expenses include non capital supplies which ended the year above budget because of the purchase of a laptop needed for mechanic.

## PW ADMIN This department was removed for FY2025 due to staffing changes.

#### PARKS

Parks Department Contractual Services ended the year above budget mainly because utilities increased due to increased water usage and water leak at Haley Nelson.

Parks Department Designated Expenses ended the year above budget because of increases in Travel & Training costs mainly because the Assistant Parks Superintendent participated in the Local Government Leaders program; and also increased insurance expense to cover deductibles for insurance claims.

Parks Department Capital Outlay is over budget because of the purchase of a new mower needed for new City Hall and because a "Wheel Balancer" and "Tire Changing" machine were purchased for the City Shop and the cost was allocated among the Public Works departments that will benefit from the new machines including Parks.

#### **DEVELOPMENT SERVICES**

Development Services Personnel expenses ended the year below budget because the Building Official position has been vacant all year.

Contractual Services include "Building Construction Services" which ended the year over budget. Because the Building Official position is vacant, the department has been hiring a third party to perform required building inspections. Salary savings are helping to offset this increased expense.

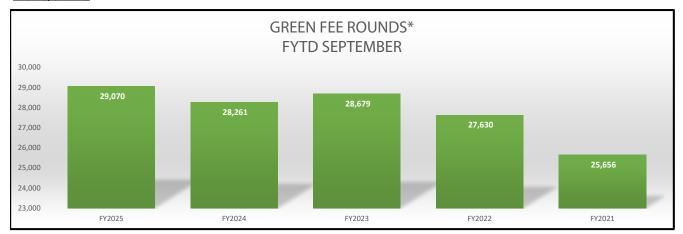

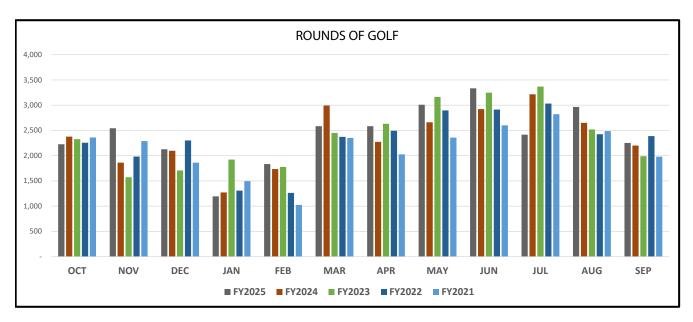

# NOTES AND KEY VARIANCES - BUDGET vs ACTUAL (On a straight line basis, 100% of year is complete) REVENUES

RATE INCREASES: <u>During the prior year</u>, rate increases went into effect in April 2024 (Ordinance 2024-09) and September 2024 (Ordinance 2024-33). The September rate increase increased the weekend/holiday green fee by \$3.00, merged the Friday rate into the weekend rate, and increased member rates by 10%. The April rate increase increased the green fee rate by \$2.00 and the cart rate by \$2.00. <u>During the current year</u>, a rate increase went into effect in April 2025 (Ordinance 2025-19) that increased green fees by \$2.00, range ball buckets by \$2.00, and the player development monthly fee by \$2.00.

MEMBER CHARGES for annual dues are collected in October and semi-annual dues are collected in April. Revenues have outperformed budget and increased from last year due to a small increase in number of members this year and because of the member rate increase that went into effect in September 2024.

#### **EXPENSES**

Supplies and Materials ended the year above budget mainly because of increased chemical and fertilizer costs and increased fuel consumption.

Repairs and Maintenance expenses ended the year above budget mainly because of increases in sand and sod needs and costs.

Contractual Services ended the year above budget mainly because of higher than expected utility bills.

Designated Expenses ended the year above budget mainly because of increasing service charges for credit card processing which is directly related to increasing revenues, and increasing employee programs for staff.

Admin allocation is offset by the Transfer from GF less \$4,167 monthly (or \$50,000 annually). It is calculated based on revenues and is therefore higher than budgeted because revenues have outperformed budget.

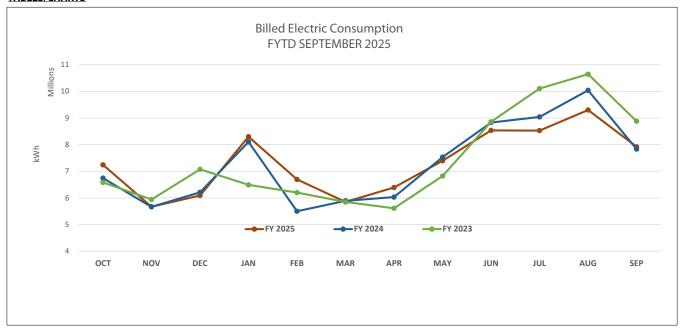

# NOTES AND KEY VARIANCES - BUDGET vs ACTUAL (On a straight line basis, 100% of year is complete)

NET ELECTRIC SALES - ended the year as expected with the budget. Compared to last year, they have increased 6.8% mainly because of the change to the purchased power cost adjustment that went into effect in August of 2024 which now allows the City to factor in power loss when calculating energy charges. Billed consumption was consistent with last year.

POLE RENTAL FEES - were invoiced in February and received in full in April.

OTHER REVENUES - ended the year below budget mainly because interest income was lower than projected for the fund. Compared to last year, other revenues are down because electric connect revenues are now being accounted for in the capital project fund and because interest income is down. Interest rates have dropped from an average of about 5.3% last year to 4.3% as of September.

TRANSFERS FROM HOT AND BEDC- were received to cover capital expenditures for Christmas decorations.

#### **EXPENSES**

PERSONNEL EXPENSES ended the year under budget mainly because of savings due to vacancies through March. As of April, the department was fully staffed and has remained so.

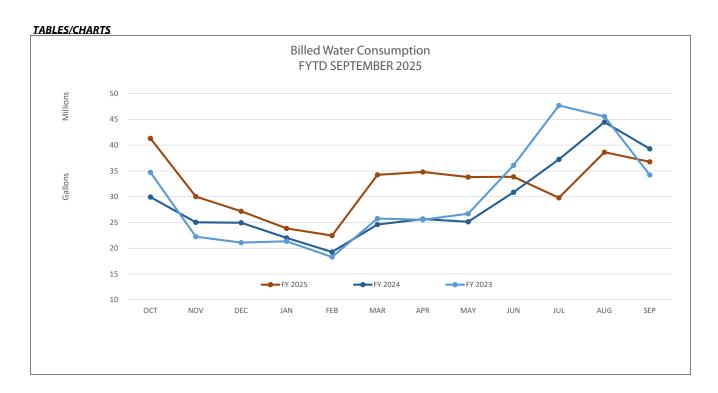
REPAIRS AND MAINTENANCE ended the year above budget mainly because of equipment maintenance costs that included annual dielectric testing of all trucks, rubber goods, and hot sticks performed in June and software maintenance costs for Elster which included SMA billing from prior periods.

# NOTES AND KEY VARIANCES - BUDGET vs ACTUAL (On a straight line basis, 100% of year is complete) REVENUES

WATER/WW SALES -Compared to budget, both Water and WW ended the year above budget and have increased compared to last year. Water sales have increased by \$269,551 because billed water consumption is up 11% and a 10% rate increase went into effect on June 1st.

SEWER CONNECTS have been moved from the operating fund to the capital project fund to match revenues with the related expenses.

CREDIT CARD FEE revenue increase is directly related to increase in Water/Sewer sales and bulk water sales.

OTHER REVENUE is tracking ahead of last year because of increased bulk water sales.

USE OF IMPACT FEES is budgeted to help offset debt service expense. We originally budgeted to only use \$75K but council approved using additional impact fees this year. Therefore, the amount was increased to \$190K.

USE OF FUND BALANCE is being used to offset start up costs for Hay Operations less any hay sale revenue.

#### FXPFNSFS

**Change in Net Position** 

COST OF WATER ended the year above the budget mainly because of increased consumption over last year. Per the Water Superintendant the City is using more surface water versus ground water and billed water consumption is up 11% over this time last year. In addition, LCRA increased their water rates from \$155 per acre foot to \$165 per acre foot in January.

HAY OPERATIONS are new this year and costs are expected to be covered by future revenues. Council has approved the use of fund balance/reserves to cover the initial start up expenses not covered by revenues

CAPITAL OUTLAY is above budget mainly because the department spent \$11K to replace the push camera used to inspect sewer lateral lines, \$6K to replace the AC at Inks Lake Water Treatment Plant and almost \$11K to installnew 6" valve.

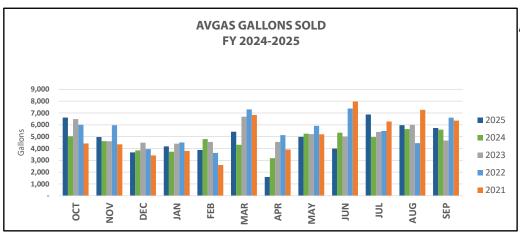

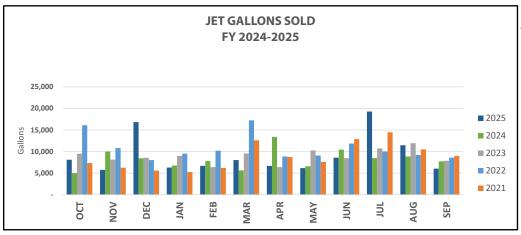

FLOWAGE FEES are received from the FBO and account for 6% of the Airport's total revenues. They are calculated at the rate of .07 for Avgas and .20 for Jet fuel

multiplied by the number of gallons sold each month by the FBO.

CAF LEASE is revenue received from the CAF hangar rental which is on track with budget but has increased significantly from last year because they entered a new agreement

THRU THE FENCE LEASE revenue is received annually from 3 different lessees.

INTEREST INCOME was underbudgeted for the year. The majority of reserved funds were not spent on capital projects until the end of the fiscal year.

#### **EXPENSES**

ACCOUNTING CHANGE FOR PERSONNEL SERVICES: During the prior year a portion of the Airport Manager's and Park's department salaries were allocated directly to the Airport. This year, that expense has been replaced by a budgeted Transfer Salary Allocation,

R&M EXPENSES ended the year slightly above budget because of hangar lighting upgrades and water heater repairs.

OTHER DESIGNATED EXPENSES ended the year above budget because of increasing insurance costs.

# 5.1) Chamber of Commerce Quarterly Report: T. McFerin:

Chamber Director Teryl McFerin outlined the Chamber's primary goals, which include strengthening membership and visibility, championing development, and fostering community partnerships. She also reflected on several successful events hosted by the Chamber over the past quarter, including luncheons, after-hours networking gatherings, and "Coffee and Conversation" sessions.

Looking ahead, Mrs. McFerin announced that a State of Burnet County Luncheon is scheduled for January 6<sup>th</sup>. The event is a team effort between the Burnet and Marble Falls Chambers of Commerce, showing a strong spirit of working together across the region.

In support of tourism development, Mrs. McFerin has initiated the application process to earn Burnet the designation of a "Tourism-Friendly Texas Certified Community," a state-level program that

recognizes cities committed to enhancing and promoting tourism across Texas.

He also stated that the bathrooms at the fields need to be addressed, with the main priority being to make them ADA compliant. In addition, there is electrical work that needs to be repaired.

Mr. Vaughn reported that the Texas Division of Emergency Management (TDEM) is making significant progress with brush cleanup and haul-off efforts. As of this date, approximately 75,000 cubic yards of brush have been removed.

He also stated that the lights at Hamilton Creek still need to be addressed. Due to the presence of old electrical lines in the undersized conduit, the project will require a substantial amount of work and expense. City staff will look into solar lighting as a possible solution.

City Manager Vaughn presented a sample letter to be sent to citizens identified by FEMA as living in a floodway or floodplain area. He requested input from the Council regarding the content of the letter.

# <u>Information</u>

The subject property is an undeveloped lot located at the southwest corner of East Pecan Street and South Rhomberg Street. It is currently zoned as Single-family residential – District "R-1" and abuts an undeveloped property zoned multi-family. The applicant is requesting to rezone the property to Manufactured Home District "M-1" to allow for the placement of a manufactured home, citing the cost of constructing a traditional site-built home as the primary reason for the request.

The proposed zoning district permits manufactured and site-built homes, with a minimum living area of 1,100 square feet on lots of at least 7,600 square feet. Each lot must be developed to the same standards as a lot zoned "R-1" and provide adequate off-street parking and landscaping. Additionally, manufactured homes must be securely anchored and pass all required building inspections prior to the issuance of a certificate of occupancy and must be fully skirted within 90 days of installation. It should be noted that "mobile homes" built prior to the HUD Code of June 15, 1976, are prohibited.

The property is served by all City water, sewer, and electric utilities and is not located within a special flood hazard area.

The surrounding neighborhood consists of a mix of site-built and manufactured homes. In recent years, the City Council, through the *My Town Housing Program*, has promoted the development of affordable, long-lasting single-family homes in this area. Some of the properties zoned "M-1" were developed under this program with site-built homes that contribute to the overall stability and quality of the neighborhood.

# **Public Notification**

Written notices were mailed to 14 surrounding property owners within 200 feet of the subject property. There have been zero responses in favor and zero responses in opposition.

**Section Six. Severability.** This Ordinance is severable as provided in City Code Section 1-7, as same may be amended, recodified or otherwise revised.

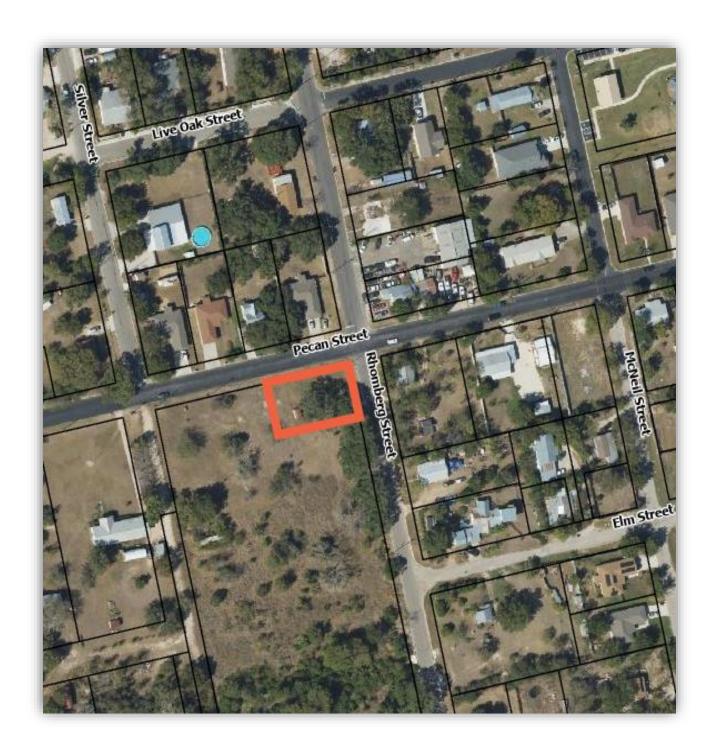

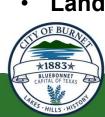

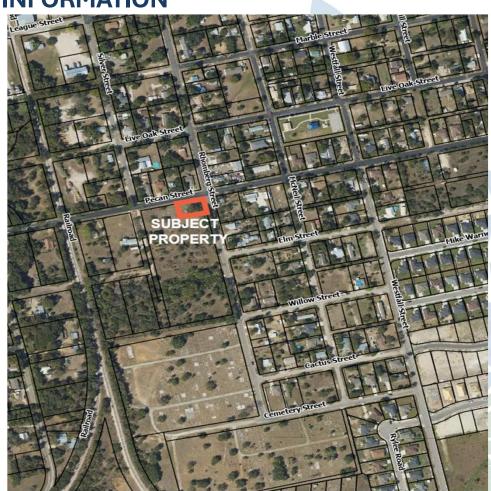

The total project cost is \$5,000, to be shared equally between the City of Burnet and Burnet County Tourism. The City's portion of \$2,500 will be funded from the General Fund.

Both the City and County will retain full and equal rights to use, share, and distribute the completed video for tourism, marketing, and community engagement purposes.

Burnet County has made minor revisions to the original Memorandum of Understanding approved under Resolution No. R2025-77. This revised MOU clarifies administrative details and requires City Council approval of the updated version. The new resolution, R2025-81, amends and replaces the prior resolution in its entirety.

The City's cost is \$2,500.

# **Information**

The City of Burnet was awarded a FY2024 HUD Community Project Funding (CPF) grant for the US-281 Pedestrian Bridge Project.

As part of project development, completion of an Environmental Assessment (EA) under 24 CFR Part 58 is required prior to HUD's Release of Funds (ROF). In addition, supporting survey and appraisal work is needed to evaluate potential property acquisition associated with the bridge approach or right-of-way.

On August 26, 2025, the City Council approved an Environmental Services Engineering Contract with Pape-Dawson Engineers to perform the EA and related compliance activities. The City's CPF Grant Agreement and Action Plan have been approved, but CPF funds cannot be drawn until the environmental review is complete and HUD issues the ROF.

The FY2024 CPF Grant Guide and 2 CFR Part 200 allow reimbursement of eligible "soft costs," including environmental review, survey, and appraisal expenses incurred after execution of the grant agreement and within the approved project scope. To maintain project momentum, staff recommends using local funds for these activities and seeking reimbursement up to \$100,000 from the CPF grant once the environmental review is complete and the ROF has been issued.

# **Fiscal Impact**

Project-related costs (including but not limited to: environmental assessment, survey, and appraisal costs) will be paid from local funds within the General Fund, not to exceed

\$100,000, and will be reimbursed from CPF grant funds following HUD approval. There is no anticipated net fiscal impact to the City.

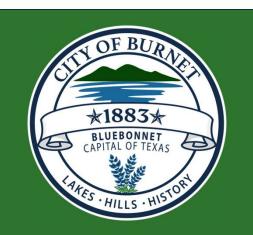

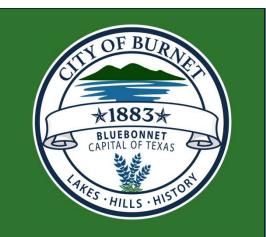

The purchase of two 2026 Chevrolet PPVs will provide for ongoing rotation of fleet vehicles and replace two vehicles operating in patrol. The vehicles being replaced will be held in our pool as spares to use when other vehicles are out of service.

The switch to trucks has been advantageous with the four-wheel drive capability during inclement weather we have experienced over the past few years, and there has been no noticeable increase in maintenance or fuel costs.

#### Fiscal Impact

The estimated cost of the vehicles is \$112,336. Upfitting for the vehicles is approximately \$80,000 and will be completed in-house versus sending the vehicles out to an upfitter. This practice results in savings of approximately \$7,000 per vehicle.

#### **Recommendation**

Staff recommends approval of the purchase of two 2026 Chevrolet PPVs to replace patrol vehicles.

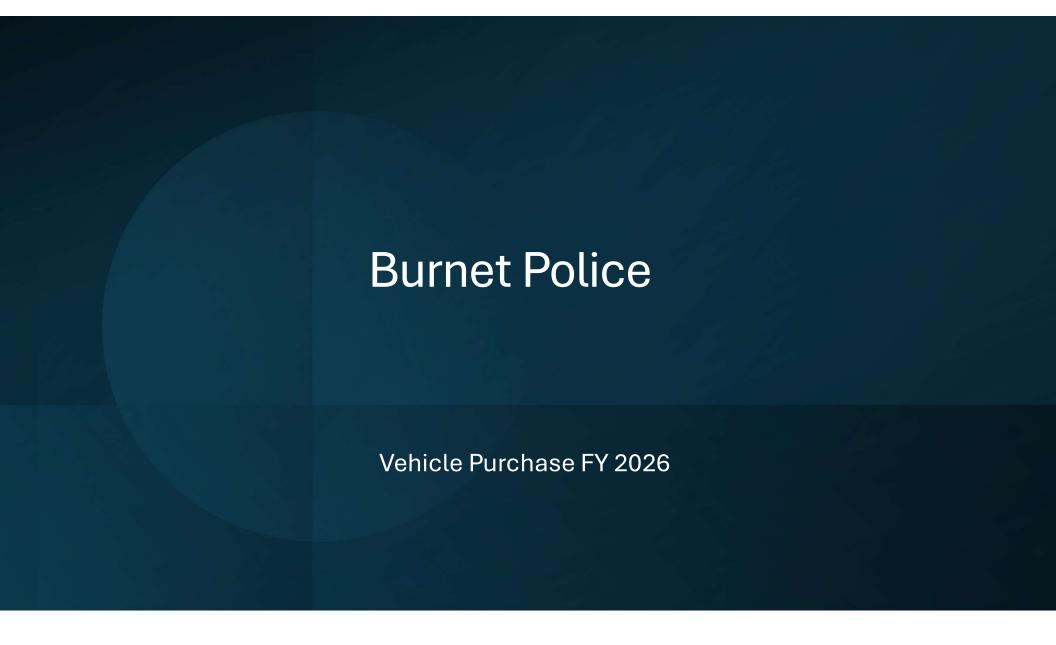

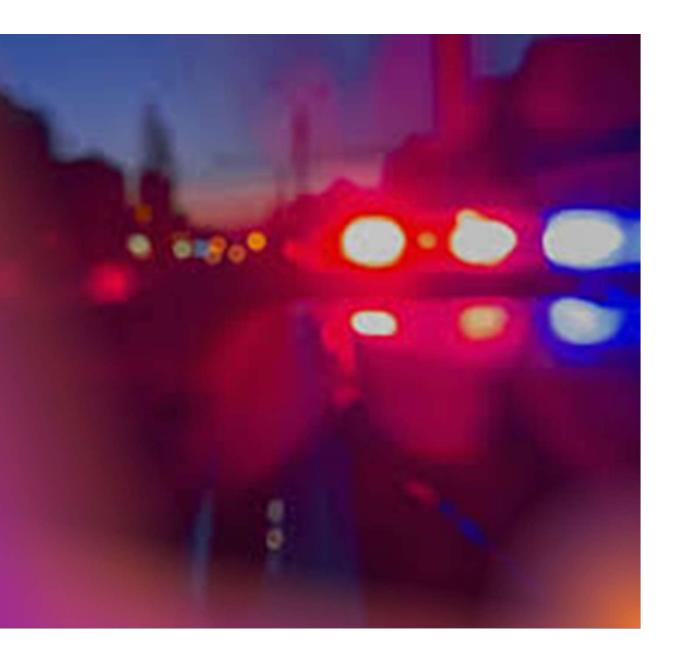

#### <u>Information</u>

The current fire alarm system at the Central Fire Station is no longer functional and requires replacement to ensure the safety and protection of personnel, equipment, and facilities. Staff recommends approval to purchase and install a new Fire-Lite fire alarm system from San Saba Fire Safety Equipment, Inc.

The proposed work includes:

- Use of existing wiring, power booster panel, and notification devices to reduce costs.
- Installation of a new Fire-Lite control panel and cellular communicator for remote monitoring.
- Inclusion of one year of monitoring service at no additional charge.
- Complete testing and inspection with the Fire Marshal to ensure compliance.
- On-site training for available staff during testing.
- One-year warranty on all replaced components.

#### **Fiscal Impact**

The cost of the fire alarm system is \$18,850 and will be funded through General Fund Cash Reserves.

A RESOLUTION AUTHORIZING THE CITY MANAGER TO UTILIZE BUDGETED FLOOD REPAIR FUNDS FOR THE REPAIR, REPLACEMENT, AND/OR UPGRADE OF CITY OWNED EQUIPMENT, FACILITIES, AND INFRASTRUCTURE

#### **Information**

The City Council supports a "build back better" approach for the repair and replacement of equipment, facilities, and public infrastructure that was damaged by the July 2025 flooding event. The City Manager is working to identify opportunities to integrate upgrades, design improvements, and ADA-compliant modifications into the repair process and is seeking Council's approval to use budgeted funds for flood damage repairs to include upgrades.

Upgrades greater than \$10,000 will require approval by the Finance Committee.

#### Fiscal Impact

Total upgrade costs will not exceed \$500,000 and will be included in the amounts already appropriated for flood damage repairs in the 2025-2026 capital budget.

#### Recommendation

Staff recommends approval of Resolution No. R2025-82 as presented.

#### **RESOLUTION NO. R2025-82**

A RESOLUTION AUTHORIZING THE CITY MANAGER TO UTILIZE BUDGETED FLOOD REPAIR FUNDS FOR THE REPAIR, REPLACEMENT, AND/OR UPGRADE OF CITY OWNED EQUIPMENT, FACILITIES, AND INFRASTRUCTURE

**WHEREAS**, the City of Burnet experienced significant flooding on July 5<sup>th</sup>, 2025, resulting in damage to City-owned equipment, facilities, and public infrastructure; and

**WHEREAS,** the City Council has previously appropriated funds in the 2025-2026 Capital Budget for the repair and replacement of damaged equipment, facilities, and infrastructure; and

**WHEREAS**, the City recognizes the importance of not only restoring damaged infrastructure but also improving its resilience against future flooding and ensuring that all facilities meet the standards established under the Americans with Disabilities Act (ADA); and

**WHEREAS**, the City Manager has identified opportunities to integrate upgrades, design improvements, and ADA-compliant modifications into the repair process without exceeding the total amount already appropriated for these purposes; and

**WHEREAS**, incorporating these improvements at the time of repair promotes efficiency, fiscal responsibility, public safety, and accessibility for all residents;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, AS FOLLOWS:

**Section One. Findings.** The recitals set out above are hereby approved and incorporated herein for all purposes.

**Section Two. Approval.** The Council does hereby approve the use of budgeted flood damage repair funds up to \$500,000 for upgrades to flood damaged property and any upgrade cost that exceeds \$10,000 must be approved by the Finance Committee.

**Section Three. Authorization.** The City Manager and the Finance Director are authorized and directed to take those actions that are reasonably necessary to facilitate the purpose of this Resolution.

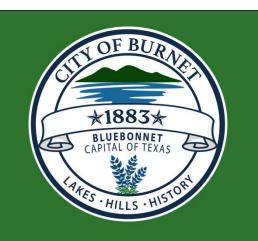
**Section Four. Reporting.** Upon request by the Finance Committee, the City Manager shall provide a report to the Finance Committee detailing any proposed upgrades to flood-damaged property with a cost greater than \$10,000 including the scope of work, costs, and improvements for approval prior to moving forward with repairs or replacements.

**Section Five. Open Meetings.** It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

**Section Six. Effective Date.** That this resolution shall take effect immediately upon its passage, and approval as prescribed by law.

#### **Information**

This item comes before you at the request of the County Judge. As background, it should be noted that the County and City previously entered into an agreement (ILA) pursuant to the Texas Interlocal Cooperation Act authorizing the City's presiding and associate judges (currently Judge Tamara Tinney and Associate Judge Kristen Tice) to also serve as the Burnet County Jail Magistrate and Associate Magistrate. Recent legislation (codified as TCCP 17.027(a)(2)) outlines conditions when a magistrate is not authorized to conduct the magistration of an arrested person. However, this limitation does not apply to municipal court judges. The County Attorney has requested the original ILA be amended to reflect that for the purposes of TCCP 17.027(a)(2) magistration shall be performed by Judge Tinney or Judge Tice in their capacity as municipal court judge and not county magistrates.

This item was approved by Commissioners Court last week.

#### **Fiscal Impact**

There is no direct fiscal impact to the City of Burnet.

#### **Recommendation**

Staff recommends approval of the interlocal agreement as presented.

#### INTERLOCAL AGREEMENT BETWEEN BURNET COUNTY AND THE CITY OF BURNET

AGREEMENT ACKNOWLEDGING AND OUTLINING THE DUAL ROLE OF THE MAGISTRATE FOR CITY OF BURNET AND THE BURNET COUNTY JAIL MAGISTRATE WHEN PERFORMING MAGISTRATION DUTIES AT THE BURNET COUNTY JAIL

WHEREAS, the Texas Interlocal Cooperation Act (Tex. Gov't Code Ch. 791) permits local governments to contract which one another to carry out governmental functions and services; and,

WHEREAS, Burnet County is a local government responsible for the maintenance of a county jail for the housing of accused persons arrested within Burnet County; and,

WHEREAS, all persons arrested of a crime have the legal right (Tex. Code of Crim Procedure Art. 14.06) to be taken within 48 hours before a magistrate of the county of arrest or any other magistrate of any other county of the State of Texas to be provided warnings (Tex. Code of Crim Procedure Art. 15.17); and,

WHEREAS, Burnet County is authorized by Texas statue (Tex. Gov. Code 54.1501 – 54.1505 & recognized under Tex. Code of Crim Procedure Ch 2A.151(6) (B)) to appoint a Burnet County Jail Magistrate to provide warnings (Tex. Code of Crim Procedure Art. 15.17), amongst other magistrate duties, to individuals arrested of a crime inside of Burnet County; and,

WHEREAS, the City of Burnet is a municipality located within the confines of Burnet County. Inside said city, arrests of accused individuals occur frequently, and such persons are routinely taken and potentially housed via an unrelated interlocal agreement between the same parties at the Burnet County Jail; and,

WHEREAS, the City of Burnet is authorized to maintain a municipal court (Tex. Gov't Code Ch. 29 & 30). A Texas municipal court judge is recognized to be a Texas magistrate (Tex. Code of Crim Procedure Ch 2A.151 (14)); and,

WHEREAS, the City of Burnet and Burnet County previously entered into an interlocal agreement authorizing a Burnet County Jail Magistrate to also serve in the role of an Associate City Magistrate for the City of Burnet; and,

WHEREAS, Texas Code of Criminal Procedure 17.027(a)(2) outlines specific conditions where a Texas Gov't Code Ch 54 authorized magistrate may not conduct the magistration of an arrested individual; and,

WHEREAS, the prohibitions outlined under Texas Code of Criminal Procedure 17.027(a)(2) do not apply to a municipal court judge, as such magistrates are not statutorily created under Tex. Gov. Code Ch 54 but under Tex. Gov't Code Ch 29 & 30; and,

WHEREAS, it is the intent of the parties to formalize an understanding that shall apply when an individual holds the positions of the Burnet County Jail Magistrate and as either the City of Burnet Municipal Judge or an Associate Judge of the City of Burnet Municipal Court; and, WHEREAS, the parties agree that when conducting a magistration of an arrested individual, a Burnet County Jail Magistrate shall simultaneously serve as the Burnet Municipal Judge or Associate Judge, thus serving both capacities in a singular judicial proceeding.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

- The previously entered interlocal agreement authorizing an employed Burnet County Jail
  Magistrate to also serve as an Associate City Magistrate in the City of Burnet, dated
  February 14, 2017 and attached hereto as Attachment A for reference purposes, is
  hereby recognized to continue in full force and effect.
- 2. At any time that a Burnet County Jail Magistrate (currently Judge Tamara Tinney and Judge Kristen Tice) is also employed or appointed to serve as either a City of Burnet Municipal Judge (currently Judge Tamara Tinney) or as an Associate Judge for the City of Burnet Municipal Court (currently Judge Kristen Tice), then said person(s) shall be recognized as simultaneously exercising their authority vested under Texas Government Code Ch. 54 and under Texas Government Code Ch 29 when conducting a magistration and/or conducting a bond setting of an arrested individual.
- 3. This agreement becomes effective upon execution by both parties and shall remain in effect until terminated by either party with 45 days' written notice to be provided by the other party. Unless said written termination occurs, any time that a Burnet County Jail Magistrate ceases to simultaneously hold the position of either a City of Burnet Municipal Judge or Associate Judge, then this agreement shall survive as dormant until said precedent conditions recur.
- 4. These authorizations are recognized by the parties as a benefit to each, increasing efficiency and cost savings for Burnet County and the City of Burnet.

IN WITNESS WHEREOF, the governing bodies of both Burnet County and the City of Burnet have approved and adopted this Agreement and have caused its execution.

# INTERLOCAL AGREEMENT BETWEEN BURNET COUNTY AND THE CITY OF BURNET

AGREEMENT PROVIDING FOR A MAGISTRATE SERVICES BY THE CITY OF BURNET AT THE BURNET COUNTY JAIL FOR THE BENEFIT OF ALL CITIZENS OF BURNET COUNTY, INCLUDING THOSE IN THE CITY OF BURNET

#### RECITALS

WHEREAS, the Texas Inter-local Cooperation Act permits local governments to contract among themselves for the performance of "governmental functions and services."

WHEREAS, Burnet County is a local government responsible for the maintenance of a county jail for the housing of accused persons arrested within Burnet County.

WHEREAS, All persons arrested of a crime have a legal right via Texas Code of Criminal Procedure Art. 14.06 to be taken within 48 hours after arrest before a magistrate of the county of arrest or any other magistrate of any other county of the State of Texas. Said persons shall be provided warning described by Article 15.17 by the magistrate, a duty placed upon all magistrates as described by this same article.

WHEREAS, Article 2.10 of the Texas Code of Criminal Procedure identifies the duty of a magistrate and under Article 2.09 of the same, a judge of a municipal court of an incorporated city is identified as magistrate.

WHEREAS, Article 4.01 of the Texas Code of Criminal Procedure gives justice courts and municipal courts the jurisdiction to handle criminal actions. Further, that Article 4.11 and Article 4.14 of the same describe the jurisdiction of justice courts and municipal courts. Further, Article 4.15 of the same indicates that these courts may try criminal cases over which they have jurisdiction.

WHEREAS, Chapter 6 and Chapter 7 of the Texas Code of Criminal Procedure outlines duties of magistrates to prevent offenses upon hearing a threat and the proceedings before a magistrate to prevent offenses. Further, Article 17.292 of the same identifies the issuance of emergency protective orders by a magistrate.

WHEREAS, the City of Burnet, Texas is a municipality located within the confines of Burnet County. Further, that the arrest of accused individuals within the city limits of Burnet occurs frequently. Said persons are taken and potentially housed, via an unrelated inter-local agreement by the same parties of this agreement, at the Burnet County Jail.

The parties to this Agreement hereby agree as follows:

#### **AGREEMEMT**

- 1. The City shall appoint an Associate City Magistrate to assist in magistrate services at the Burnet County Jail and provide services to the City of Burnet. The selection of the individual to serve as the City of Burnet's Associate Municipal Judge is viewed as a benefit to the parties herein. This individual will provide magistrate services for the Burnet County Jail and be available to the City of Burnet for disposition of cases for the Municipal Court at the jail. This individual will serve as the jail magistrate for Burnet County and therefore all expenses incurred will be paid by Burnet County, no expenses will be incurred by the City of Burnet. Burnet County will be responsible for choosing the individual to fill the position.
- 2. This change is made in the interest of judicial economy. The magistrate at the Burnet County Jail signs a significant number of warrants in their capacity. Because the City of Burnet dispatches through the Burnet County Sheriff's Office, allowing Jail magistrate the authority to sign warrants as a City of Burnet municipal judge will allow for the entering of warrant information into the Burnet County Odyssey system. This alleviates a linking problem with data into the integrated system.
- 3. Any additional time required by City of Burnet Court Clerks to enter documents into the Court records due to this agreement is recognized to be offset by the benefit of having an additional municipal judge to process pleas and judgments on behalf of the City of Burnet at the Burnet County Jail. The City of Burnet benefits from agreement by ensuring that its City warrants can be properly processed into the Burnet County Odyssey system and by having a second magistrate available for city business at the Burnet County Jail.
- 4. The jail magistrate shall serve under the supervision of the senior presiding municipal judge of Granite Shoals who may consult with the senior presiding municipal judge of Burnet. When only the City of Burnet business is involved at the Burnet County Jail, the Jail magistrate shall be under the supervision of the senior presiding municipal judge of Burnet.
- 5. Further, all parties agree that the magistrate identified in this agreement shall be bonded for \$ 5,000.00. Such costs of bonding will be incurred by Burnet County. Burnet County agrees to accept legal responsibility for acts committed by the associate judge done on behalf of Burnet County.
- 6. The identified magistrate shall have the authority to accept documents regarding the plea of any defendant accused of a class "C" misdemeanor crime housed at the Burnet County Jail only if allowed by the justice of the peace court or municipal court having jurisdiction of the case. Such documents shall be forwarded to the judge having jurisdiction of the case at his/her office so that he/she may pronounce sentence and judgment. If such

defendant is under the jurisdiction of the Municipal Court of Burnet, then the Jail magistrate may pronounce sentence and judgment at the Burnet County Jail as it is physically located within the confines of the City of Burnet.

#### **TERM OF AGREEMENT**

The term of this agreement is from February 14, 2017 until December 31, 2017, after which the agreement shall renew automatically for a term of one year unless terminated. Either party may terminate the agreement at the end of the term without cause by notifying the other party not later than 45 days prior to the end of the term. Furthermore, any party may terminate this agreement at any time by presentment of notice of intent to terminate in writing to the other party. If so, the contract shall cease 45 days after said notice is given and received.

IN WITNESS WHEREOF, the governing bodies of both the County and the City have approved and adopted this Agreement and have caused this Agreement to be executed. It shall become effective upon the date that both parties have signed this Agreement.

## Background

- This item is presented at the request of the County Attorney.
- Currently, the Honorable Tamera Tinney sits as municipal court presiding judge and as county jail magistrate; and the Honorable Kristen Tice sits as municipal court associate judge and as county jail associate magistrate.
- The purpose of this item is to amend the Interlocal Agreement (ILA) with the County regarding the municipal court judge and associate judge's role as county jail magistrates.
- The genesis for the proposed amendment to the ILA is recent legislation codified as TCCP 17.027(a)(2)), that:
  - Outlines conditions when a magistrate is not authorized to conduct the magistration of an arrested person; but
  - Does not place such limitation on municipal court judges.





### Purpose of ILA Amendment

- Reaffirms and updates the 2017 agreement.
- Reflect that it is the City and County's intent, that for the purposes of TCCP 17.027(a)(2), magistration shall be performed by Judge Tinney or Judge Tice in their capacity as municipal court judge and not county magistrates.
- The ILA Amendment was approved by Commissioners Court last week.

**WHEREAS**, the City of Burnet, Texas Fiscal Year 2024-2025 Budget was adopted by Ordinance 2024-35 within the time and in the manner required by State Law; and

WHEREAS, the City of Burnet, Texas has reviewed the Budget; and

**WHEREAS**, the City Council of the City of Burnet, Texas has considered the status of the Capital Improvement Projects for the rest of the fiscal year; and

**WHEREAS**, the City Council of the City of Burnet, Texas hereby finds and determines that it is prudent to amend the line items due to unforeseen situations that have occurred in the City; and

**WHEREAS**, the City Council of the City of Burnet, Texas further finds that these amendments will serve in the public interest; and

**WHEREAS**, the City Council of the City of Burnet, Texas finds and determines that the change in the Budget for the stated municipal purpose is warranted and necessary, and that the amendment of the Budget to fund these line items is due to unforeseen situations and a matter of public necessity warranting action at this time, and

**WHEREAS**, the Local Government Code Section 102.010 allows for changes in the budget for municipal purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

**Section One. Findings.** The facts and matters set out above are found to be true and correct.

**Section Two. Purpose.** The City of Burnet, Texas, Fiscal Year 2024-2025 Budget is hereby amended to reflect the effect of unforeseen circumstances, as reflected in Attachment "A".

**Section Three. Savings/Repealing Clause.** All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed ordinance, nor shall

the repeal prevent a prosecution from being commenced for any violation if occurring prior to the repeal of the ordinance. Any remaining portions of said ordinances shall remain in full force and effect.

**Section Four. Severability.** It is hereby declared to be the intention of the City Council that if any of the sections, paragraphs, sentences, clauses, and phrases of the Ordinance shall be declared unconstitutional or invalid by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this Ordinance of unconstitutional or invalid phrases, clauses, sentences, paragraphs, or sections.
