AN ORDINANCE OF THE CITY OF BURNET, TEXAS, EXTENDING THE DECLARATION OF A LOCAL STATE OF DISASTER RESULTING FROM EXTREME FLOODING; PROVIDING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY

Information

On July 6, 2025, the Mayor Pro Tem of the City of Burnet issued a local disaster declaration in response to extreme flooding throughout the City, particularly in areas along Hamilton Creek and other creeks and low-lying areas. The declaration was made under the authority of Texas Government Code §418.108(a), which allows a local official to declare a disaster for up to seven days.

To maintain the legal authority granted under the disaster declaration- including emergency procurement, coordination with state and federal agencies, and eligibility for disaster assistance- §418.108(b) requires the governing body to formally extend the declaration beyond seven days.

This ordinance continues the local state of disaster until such time as the City Council determines that emergency conditions no longer exist. It is adopted as an emergency measure and takes effect immediately upon passage, with formal effectiveness beginning July 13, 2025.

Fiscal Impact

None at this time. Future expenditures related to emergency response or recovery efforts may require separate Council approval.

Recommendation

Staff recommends approval of Ordinance No. 2025-32 as presented.

ORDINANCE NO. 2025-32

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, EXTENDING THE DECLARATION OF A LOCAL STATE OF DISASTER RESULTING FROM EXTREME FLOODING; PROVIDING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY

WHEREAS, on July 6, 2025, the Mayor Pro Tem issued a proclamation declaring a state of disaster for the City of Burnet resulting from

extreme flooding throughout the City of Burnet, especially in areas along Hamilton Creek, as well as other creeks and low-lying areas around the City, and;

WHEREAS, the conditions necessitating declaration of a state of disaster continue to exist and is of such severity and magnitude that an effective response is beyond the capability of the City of Burnet to control; and

WHEREAS, §418.108(b) of the Texas Government Code provides that a local state of disaster may not be continued for a period of excess of seven days without the consent of the governing body of the political subdivision;

NOW THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

- 1. That the state of disaster proclaimed for the City of Burnet by the Mayor Pro Tem on July 6, 2025, shall continue until terminated by order of the City Council.
- 2. This ordinance is passed as an emergency measure and pursuant to local authority for emergency measures and shall become effective on the 13th day of July, 2025.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, AUTHORIZING THE CITY MANAGER TO EXPEND UP TO \$500,000 FOR PROCUREMENTS MADE TO PRESERVE THE PROPERTY OF THE CITY; PROTECT THE PUBLIC HEALTH OR SAFETY OF THE CITY'S RESIDENTS AND/OR TO REPAIR UNFORESEEN DAMAGE TO PUBLIC MACHINERY, EQUIPMENT, OR OTHER PROPERTY IN RESPONSE TO STORM AND FLOOD DAMAGE CAUSED BY THE EXTREME WEATHER EVENT OF JULY 4TH WEEKEND

Information

This resolution is made in accordance with the mayor's declaration of emergency and authorizes the city manager to make expenditure of public funds to preserve and protecting public health, safety, life, and property imperiled by storm and flood damage.

Expenditures made under this resolution are exempt from state competitive bidding requirements.

This resolution requires the city manager to keep records of all expenditures and periodically make reports to city council.

Fiscal Impact

This resolution is contingent on City Council adopting a companion ordinance authorizing \$500,000.00 to be budgeted for emergency expenditures.

Recommendation

Staff recommends the approval and adoption of Resolution R2025-61 as presented.

RESOLUTION NO. R2025-61

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, AUTHORIZING THE CITY MANAGER TO EXPEND UP TO \$500,000 FOR PROCUREMENTS MADE TO PRESERVE THE PROPERTY OF THE CITY; PROTECT THE PUBLIC HEALTH OR SAFETY OF THE CITY'S RESIDENTS AND/OR TO REPAIR UNFORESEEN DAMAGE TO PUBLIC MACHINERY, EQUIPMENT, OR OTHER PROPERTY IN RESPONSE TO STORM AND FLOOD DAMAGE CAUSED BY THE EXTREME WEATHER EVENT OF JULY 4TH WEEKEND

WHEREAS, heavy rains over the July 4th weekend caused severe flooding, substantial property damage, physical injuries and loss of life; and

WHEREAS, the devastation caused by this severe weather event has caused Mayor Wideman to issue a Declaration of Emergency on July 7, 2025; and

WHEREAS, City Council finds, determines, and declares this severe weather event is a public calamity that has imperiled public health and safety and has caused substantial damage to personal and real property assets of the City of Burnet; and

WHEREAS, City Council finds, determines, and declares that pursuant to Sec. 38-31, City Code, this resolution is a memorialization of City Council's authorization to expend funds in carrying out emergency management activities; and

WHEREAS, this resolution is authorized under the City Charter and the laws and constitution of the State of Texas, including Section 252.022(a)(1), (2), and (3) Texas Local Government Code

WHEREAS, City Council, finds, determines, and declares that the meeting at which this resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this resolution, was given as required by Chapter 551 of the Texas Government Code.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

Section one. Scope. This resolution addresses the damage and danger caused by the severe weather described in Mayor Wideman's July 7, 2025, declaration of disaster.

Section two. Authorization. The City's Finance Policy notwithstanding, the City Manager is hereby authorized and directed to expend up to \$500,000.00 to preserve public property, protect the public health or safety of the municipality's

residents, and or procurements necessary because of unforeseen damage to public machinery, equipment, or other property.

Section three. Bid Law Exemption. The City Manager's authority delegated in section two includes the authority to make procurements without regard to statutory bid laws upon the City Manager's determination that such procurement is exempt from the requirements of Texas Local Government Code Chapter 252 due to one of the following:

- the procurement is necessary because of a public calamity that requires the immediate appropriation of money to relieve the necessity of the municipality's residents or to preserve the property of the municipality; or
- the procurement is necessary to preserve or protect the public health or safety of the municipality's residents; or
- the procurement is necessary because of unforeseen damage to public machinery, equipment, or other property.

Section four. Procedures. The City Manager shall document each expenditure made under this resolution and regularly provide reports to City Council of expenditures made under this resolution.

Section five. Findings. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this resolution for all purposes and are adopted as a part of the judgment and findings of the Council.

ORDINANCE NO. 2025-33

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, AMENDING ORDINANCE 2024-35; THE ORIGINAL BUDGET ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024, AND ENDING SEPTEMBER 30, 2025, FOR THE CITY OF BURNET, TEXAS, FUNDING ACCOUNTS IN BUDGET DUE TO UNFORESEEN SITUATIONS; CONTAINING FINDINGS; PROVIDING FOR SAVINGS AND SEVERABILITY

WHEREAS, the City of Burnet, Texas Fiscal Year 2024-2025 Budget was adopted by Ordinance 2024-35 within the time and in the manner required by State Law; and

WHEREAS, the City Council of the City of Burnet, Texas has reviewed the Budget; and

WHEREAS, the City Council of the City of Burnet, Texas has considered the status of the Capital Improvement Projects for the rest of the fiscal year; and

WHEREAS, the City Council of the City of Burnet, Texas hereby finds and determines that it is prudent to amend the line items due to unforeseen situations that have occurred in the City; and

WHEREAS, the City Council of the City of Burnet, Texas further finds that these amendments will serve in the public interest; and

WHEREAS, the City Council of the City of Burnet, Texas finds and determines that the change in the Budget for the stated municipal purpose is warranted and necessary, and that the amendment of the Budget to fund these line items is due to unforeseen situations and a matter of public necessity warranting action at this time, and

WHEREAS, the Local Government Code Section 102.010 allows for changes in the budget for municipal purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

Section 1. Findings. The facts and matters set out above are found to be true and correct.

Section 2. Purpose. The City of Burnet, Texas, Fiscal Year 2024-2025 Budget is hereby amended to reflect the effect of unforeseen circumstances, as reflected in attachment "A".

Section 3. Savings/Repealing Clause. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed ordinance, nor shall the repeal prevent a prosecution from being commenced for any violation if occurring prior to

the repeal of the ordinance. Any remaining portions of said ordinances shall remain in full force and effect.

Section 4. Severability. It is hereby declared to be the intention of the City Council that if any of the sections, paragraphs, sentences, clauses, and phrases of the Ordinance shall be declared unconstitutional or invalid by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this Ordinance of unconstitutional or invalid phrases, clauses, sentences, paragraphs, or sections.

RESOLUTION NO. 2025-62

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, TEMPORARILY WAIVING BUILDING FEES FOR PROPERTIES AFFECTED BY THE JULY 4TH FLOOD EVENT

WHEREAS, heavy rains over the July 4th weekend (hereinafter the "Storm") caused severe flooding, substantial property damage, physical injuries and loss of life; and

WHEREAS, the devastation caused by the Storm has caused Mayor Wideman to issue a Declaration of Emergency on July 7, 2025; and

WHEREAS, City Council renewed the Declaration of Disaster by passage of Ordinance No. 2025-32; and

WHEREAS, City Council finds, determines, and declares that numerous city residents and businesses suffered property damage as a result of flooding and storm damage; and

WHEREAS, City Council finds, determines, and declares that because many of the damaged properties were not within the regulatory floodplain, and were not covered by flood insurance, the costs of repairing damaged property will fall solely on the property owners; and

WHEREAS, City Council finds, determines, and declares that because so many city residents and businesses suffered monetary losses due to the Storm; the waiver of building permit fees is beneficial to public health, safety, and welfare; and

WHEREAS, City Council, finds, determines, and declares that the meeting at which this resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this resolution, was given as required by Chapter 551 of the Texas Government Code.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

Section one. Scope. This resolution shall apply to all building, electrical, water, sewer, and related fees (hereinafter collectively "Fees") authorized under the City of Burnet Code of Ordinances.

Section two. Waiver. In accordance with Ordinance No. 2014-07 City Council adopts this resolution and authorizes the waiver of any Fee, or portion of any

Fee, associated with either (i) the repair of existing construction damaged by the Storm, or (2) new construction, replacing existing construction damaged by the Storm. This resolution expressly does not waive impact fees, fines or penalties.

Section three. Authorization. The City Manager is hereby authorized and directed to establish a process to accomplish the following:

- notify the public about this program;
- establish guidelines for participation in this program;
- create program applications, and related documents;
- establish a process for tracking participation in this program; and
- establish a process for reimbursement from insurance proceeds for those properties covered by an insurance policy.

Section three. Term. This resolution shall continue to be effective from the date of its approval until it is repealed by future resolution of this Council.

Section four. Findings. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this resolution for all purposes and are adopted as a part of the judgment and findings of the Council.
