

A Special Meeting is being called for February 5, 2026, at 6:00PM at 204 Pulaski Road Calumet City, Illinois 60409. The purpose of the meeting is for consideration of the following matters:

- 1) Motion to approve Bill List as it appears on the agenda of January 22, 2026.
- 2) Motion to approve Emergency Bill List as it appears on the agenda of January 22, 2026.
- 3) Motion to approve payroll as it appears on the agenda of January 22, 2026.
- 4) A discussion and possible action on directing legislative counsel to represent the interest of the Alderpersons and the City of Calumet City in the case of Ken Jones v Thaddeus Jones and Calumet City.
- 5) Discussion and possible action regarding a request for Legislative Counsel to draft an ordinance establishing a comprehensive municipal hiring policy, including but not limited to: required requests for qualifications, job descriptions, reporting structure, salary ranges, positions hired by the Mayor with or without City Council advice and consent, and positions requiring City Council approval following vetting. The draft ordinance shall consider existing City ordinances, applicable state statutes, and practices of similarly sized municipalities, and be referred to the Ordinance Committee for review.
- 6) Discussion and possible action regarding a request for Legislative Counsel to draft an updated ordinance establishing an Ethics Policy for elected officials, incorporating current state law requirements and modern best practices. Upon completion, the draft ordinance shall be referred to the Ordinance Committee.
- 7) Discussion and possible action regarding reimbursement to the City of Calumet City, pursuant to the Credit Card Policy, following November 4, 2025, vote determining that the Credit Card Policy was violated.
- 8) Discussion and possible action regarding a request for Legislative Counsel to draft an ordinance establishing guidelines for the use of City-owned vehicles, including eligibility for vehicle assignment, take-home privileges (if any), fuel usage and authorization, oversight and accountability measures, mileage logging, and reporting of vehicle use outside City limits. The draft ordinance shall be referred to the Ordinance Committee and Finance Committee.

- 9) Discussion and possible action regarding a request for Legislative Counsel to draft an ordinance codifying the duties and responsibilities of the elected City Clerk and City Collector, consistent with state law and the customary practices of similarly sized municipalities, including duties performed between 2011 and June 2021. The draft ordinance shall be referred to the Ordinance Committee.
- 10) Discussion and possible action regarding a request for Legislative Counsel to draft an ordinance establishing a comprehensive municipal work from home policy.
