With respect to positions that are not represented by a collective bargaining unit and are not otherwise subject to bargaining requirements, approved staffing changes shall take effect immediately.

With respect to bargaining-unit positions, no position abolition or reduction in compensation or benefits shall be implemented until the City has satisfied all applicable bargaining, contractual, civil-service, and statutory obligations and the City Council has taken any additional final action required by law.

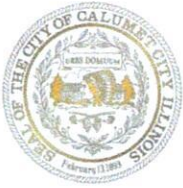
