#### **RESOLUTION NO. 25-10**

# A RESOLUTION APPROVING A CLASS 8 DESIGNATION AND ENTERPRISE ZONE INCENTIVES FOR 185 PLUMMER (THE BOGEY CLUB, LLC)

WHEREAS, Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City seeks to promote new investments, as part of its economic development strategy, and encourage the creation of new job opportunities for City residents and sources of revenue for the City; and

**WHEREAS**, the City seeks to encourage the continued investment and redevelopment of the property at 185 Plummer Avenue, Calumet City.

**BE IT RESOLVED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, THAT shall be, and is hereby, adopted as follows:

#### Section 1. BACKGROUND.

- A. Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs.
- B. The Bogey Group, LLC is purchasing 185 Plummer Avenue. ("Redevelopment Property") for redevelopment and use by tenant Uesco Industries, Inc. ("Developers")
- C. The Subject Property has been vacant since June 2024. The estimated/target occupancy/production date is October of 2025. By the time the Developers are able to make the necessary capital improvements and utilize and occupy the property the property will have been abandoned for more than twelve (12) months.
- D. The Developers, the Bogey Group, LLC and Uesco Industries, Inc., have proposed to redevelop the Property for industrial use. The redevelopment of the property is estimated to be at least \$645,000 in initial capital improvements (the "Project"). The building interior will be renovated, the office area will be remodeled, extensive electrical and mechanical repairs and improvements will be made, and the recessed dock will be restored by digging out the fill and making it operable again. If necessary the roof will be replaced at an additional estimated cost of \$100,000. Furthermore, the developer will invest in two permanent cranes, a paint booth, a foundation and runway for the business.

- E. Developers' Project will create ten (10) new full-time jobs in Cook County.
- F. The Property is located in the Calumet Region Enterprise Zone and is currently designated as an area by the City to be eligible for and approved by the Cook County Assessor for the Cook County Class 8 property tax incentives to promote redevelopment projects ("*Incentives*"). The Developer desires to obtain Incentives for the Property.
- G. The City seeks to encourage the redevelopment of vacant buildings and promote new businesses as part of its economic development strategy, which will create new job opportunities for City residents and sources of revenue for the City.
- H. The City is willing to assist the Developer by obtaining Incentives for the Property as of the Effective Date.
- I. The Corporate Authorities, after due and careful consideration, have concluded that a Class 8 Tax Incentive for the Subject Property is necessary and in the best interest of the City in order to promote the redevelopment and use of the Subject Property, which will in turn promote the public health, safety, and welfare and serve the best interests of the City and its residents.

#### Section 2. CLASS 8 TAX INCENTIVE APPROVAL.

The Mayor and City Council find that:

- 1. the Redevelopment Property is appropriate for a Class 8 Tax Incentive benefits pursuant to the Cook County Real Property Classification Ordinance, as amended;
- 2. the Class 8 Tax Incentive for the Redevelopment Property is necessary to encourage redevelopment and occupancy of the Redevelopment Property by the Developer, and that occupancy and use of the Redevelopment Property for the commercial purposes proposed in the Redevelopment Agreement is necessary and beneficial to the City's economy; and
- 3. the Mayor and the City Council approve, support and consent to the Class 8 Tax Incentive for the Redevelopment Property.

#### Section 3. RECORDATION.

The City Clerk is hereby directed to record a certified copy of this Resolution in the Office of the Cook County Recorder against the Redevelopment Property. Developer will bear the full cost for such recordation.

#### Section 4. EFFECTIVE DATE.

This Resolution will be effective upon passage by the City Council.

WHEREAS, pursuant to 35 ILCS 200/18-60, the City Council of the City of Calumet City on July 15th, 2024 approved and authorized the public display of a City of Calumet City Corporate Fund, a City of Calumet City Library Fund, a City of Calumet City IMRF Pension Fund, and a City of Calumet City Police and Fire Pension Funds Budget prepared in tentative form for said City for the fiscal year beginning May 1, 2024 and ending April 30, 2025; and

WHEREAS, the budgets for said City of Calumet City Corporate Fund, City of Calumet City Library Fund, City of Calumet City IMRF Pension Fund, and City of Calumet City Police and Fire Pension Funds (hereinafter referred to as the Corporate & Special Purpose Funds) were adopted by the City Council of the City of Calumet City at a legal meeting held on the 29th day of July, 2024; and

WHEREAS, the City of Calumet City has Debt Service Funds created for the payment of outstanding general obligation bonds and notes; and

WHEREAS, in accordance with said budgets and general obligation bond and note ordinances, the following amounts of money, in the aggregate, are estimated to be necessary to be raised by taxation for the 2024 tax year upon the taxable property of the City of Calumet City;

#### Ordinance No. 25-01

### AN ORDINANCE AMENDING CHAPTER 18 OF MUNICIPAL CODE OF THE CITY OF CALUMET CITY COOK COUNTY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a duly organized and validly existing home rule municipality created in accordance with the Illinois Constitution of 1970 (the "Constitution") and the laws of the State; and

WHEREAS, Article VII, Section 6 (c) of the Constitution provides: "If a home rule county ordinance conflicts with an ordinance of a municipality, the municipal ordinance shall prevail within its jurisdiction;" and

WHEREAS, the County of Cook, a home-rule county pursuant to Article VII, Section 6 of the Constitution, has proceeded to enact certain ordinances imposing certain regulations and reporting requirements to the Cook County Treasurer under Sec.2-243 of the Cook County Code pertaining to Taxing district debt and Tax Increment Financing District costs which codes conflict with the operations of the City and its ordinances all as hereinafter set forth; and, therefore, pursuant to the Constitution are not enforceable within the City boundaries.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet, Cook County, Illinois, as follows:

Section 1. Article VIII, Chapter 18 of the Municipal Code of the City of Calumet as hereby amended by adding the following new Article VII:

Section 1-1. Tax Increment Financing

Pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et. seq. (the "*TIF Act*"), the City is authorized to designate "redevelopment project areas" as such terms is defined in the TIF Act.

Section 1-2. Cook County Reporting Requirements.

As mandated by the TIF Act, the City shall comply solely with all reporting requirements to the State Comptroller or as otherwise may be required by the State from time to time for each designated redevelopment project area. Any reporting

requirements imposed by the County of Cook as set forth in Section 2-243(c) of the Cook County Code regarding the disclosure of any undertaking of the City's designation of a "redevelopment project area"; or, the administration and implementation of the City's redevelopment plan pursuant to the TIF Act are deemed in conflict herewith

Section 2. Effective Date. This Ordinance shall be in full force and effect from and after its passage, by a simple majority vote of the Mayor and City Council, approval, publication and posting as provided by law.

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") has heretofore issued its General Obligation Bonds, Series 2015B (the "Bonds"), in accordance with the provisions of Ordinance No. 15-47 (the "Bond Ordinance") heretofore passed by the City Council (the "Corporate Authorities") of the City on November 12, 2015; and

WHEREAS, the Corporate Authorities did in and by the Bond Ordinance levy a direct annual tax sufficient to pay the principal of and interest on the Bonds, and, in particular, taxes were levied in the amount of \$624,000.00 for the year 2024 for the Bonds (the "2024 Levy for the Bonds"); and

WHEREAS, the City will have other lawfully available monies in the appropriate account or fund pursuant to the Bond Ordinance for the purpose of paying the principal of and interest on the Bonds up to and including December 31, 2025, which is the period for which the 2024 Levy for the Bonds was made; and

WHEREAS, it is necessary that the 2024 Levy for the Bonds be abated:

NOW THEREFORE, be it ordained by the City Council of the City of Calumet City, Cook County, Illinois, as follows:

SECTION 1: The 2024 Levy for the Bonds is hereby abated in its entirety.

SECTION 2: Forthwith upon the adoption and approval of this Ordinance, the City Clerk shall file a certified copy hereof in the office of the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said taxes levied for the year 2024 (viz., the 2024 Levy for the Bonds) in accordance with the provisions hereof.

SECTION 3: This Ordinance shall supersede all ordinances, resolutions or other proceedings heretofore taken in conflict with the terms hereof, and this Ordinance shall be in full force and effect immediately upon its passage and approval.
