#### CITY COUNCIL REPORTS

Mayor Jones Mayor Jones stated "I will be issuing a veto on the action taken at the

December 04<sup>th</sup> meeting and so the power described in Section 2-94 of the City of Calumet City do hereby grant the Mayor the power to issue a veto. So I'm vetoing the motion made by Alderman Patton and seconded by Alderwoman Wilson that motion stated as spoke as of city council action on December 04th the following motion was made and approved; Alderman Patton moved seconded by Alderman Wilson to direct the city attorney to dismiss Case No. CH5512 with immediate effect. So this veto is being issued for three reasons: First, the city council does not have the authority under Illinois law and also under Section 2-49 of the municipal code whereas it states the Mayor Shall direct all legal work on behalf of the city. Such legal work shall be assigned by the Mayor to the City Attorney." Second, under Illinois State Law, 65 ILCS 5/3.1-40-30, which states only "The Mayor shall preside at all meetings of the city council. This does not preclude the city council from calling Special Meetings but the Mayor must preside over all meetings, there are only two individuals who can call a meeting to order; myself and the deputy

Mayor which is 4th ward Alderman Ramonde Williams its clear in

law. In future meetings I would advise the city council to be sure that this is followed. So no Special Meetings can be called to order or be held only by the presiding Mayor and also by the Deputy Mayor. So the veto will be returned for those reasons the steps and procedures for veto are as follows: either of the four Alderman who voted in favor of the motion wants to submit a request in writing to my office by Monday December 16th to override the veto: this request must state this is a request to override the veto action taken tonight. If received the matter will be placed on the December 23<sup>rd</sup> agenda that's our next city council meeting. The override motion must received 5 votes in order to survive. If no requests are received from my office by close of business on Monday December 16<sup>th</sup>, then my veto action that I take today will be the final action on this matter and the lawsuit will proceed as intended. Those are the actions and I will send this to the council just so the council has this along with my veto message that I am issuing today."

### **NEW BUSINESS**

#1: Veto of Action Taken at the December 04, 2024 Special Meeting

Mayor Thaddeus Jones, with powers described in section 2-194 of the City of Calumet City do hereby issue a Veto of the motion made by Alderman Patton and Seconded by Alderman Wilson. "As of the City Council Action of December 04, 2024, the following motion was made and approved: Alderman Patton moved, seconded by Alderman Wilson to direct the City Attorney to dismiss Case No.CH 5512 with immediate effect."

This veto is being issued for three reasons. First, the city council does not have the authority under Illinois law and also under Section 2-492 "Mayor Shall direct all legal work on behalf of the city. Such legal work shall be assigned by the Mayor to the City Attorney." Second, under Illinois State Law, 65 ILCS 5/3.1-40-30, which states only "The Mayor shall preside at all meetings of the city council."

Therefore, the meeting held on December 4, 2025, is hereby deemed an illegally held meeting.

#### DIVISION 40. CITY COUNCIL

(65 ILCS 5/3.1-40-30) (from Ch. 24, par. 3.1-40-30) Sec. 3.1-40-30. Mayor presides. The mayor shall preside at all meetings of the city council. Except as provided in Articles 4 and 5 of this Code, the mayor shall not vote on any ordinance, resolution, or motion except the following: (i) where the vote of the alderpersons has resulted in a tie; (ii) where one-half of the alderpersons elected have voted in favor of an ordinance, resolution, or motion even though there is no tie vote; or (iii) where a vote greater than a majority of the corporate authorities is required by this Code or an ordinance to adopt an ordinance, resolution, or motion. Nothing in this Section shall deprive an acting mayor or mayor pro temp from voting in the capacity as an alderperson, but he or she shall not be entitled to another vote in the capacity as acting mayor or mayor pro temp.

#2: Office of the Open Meeting Act

Attorney General Kwame Raoul and the Office of the Open Meetings Act denial of Alderman James Patton letter falsely claiming an illegal meeting occurred regarding the quick take action for River Oaks mall—2024 PAC 83525. No official action is needed.

Alderman Patton Requested a Point of Personal Privilege

Alderman Patton stated "I just want to clarify for number #2 I know it says no action needed so I'm not sure why its under action items. That would be my first point on that but secondly, I want to clarify the language here it says that I sent a letter falsely claiming an illegal meeting occurred and that the officer of the open meetings act denied my request. When in fact the officer of the open meetings act from the Attorney General's office told me was that they recognize there was a violation of the open meeting act as a matter of fact I'm reading right now from their letter to me that says that this office notes that the best practice is to post a meeting agenda more than 48 hours before the start time of a meeting even if the meeting begins late. The public is entitled to a reasonable expectation that open meetings generally start on time and therefore that the meeting agenda will be posted at least 48 hours before a meeting is scheduled to begin. This office reminds the board to be mindful of its obligation to timely post special meetings on its website in accordance with section 202B. So this item as stated in this agenda 1. shouldn't be in this section cause it says no action is needed even though its under action items; #2 the language in here is completely false and I would ask that my colleagues vote to remove this item from the agenda completely."

"So you want to remove an action that doesn't require a action."

"I'd like it stricken from the record cause it's a lie.

# "I just read you what the AG's office said; so your thing here on the Alderman Patton agenda that you wrote is a lie. You said that the AG's office denied my request falsely claiming an illegal meeting occurred. They recognized the meeting was not posted on time. Your excuse that the meeting was late was not recognized as a valid response. What you wrote here for number 2 was a lie. I'm asking my colleagues to strike it from the record." "Alderman Patton, but Alderman they denied your request, your Mayor Jones request at the meeting was two fold your request was that you were going to file a complaint with the attorney generals office and your second request was that you were going to return the money to the city council. So they denied your request Alderman, and I'm sure you haven't returned the money to the City Treasurer." "They did not deny my request and my request to the Attorney Alderman Patton Generals office had nothing to do with the money. I said on the council floor that I would happily forego my pay for that meeting." "Okay have you turned the money over to the City Treasurer." Mayor Jones "I'm not sure if I was paid for it or not Mayor, I don't pay attention." Alderman Patton "Ok did you write a check to the City of Calumet City for that Mayor Jones meeting that you said was illegal." "I said on the council floor that I would forego my money whether I Alderman Patton got paid for it or not I don't know." "A check was issued to you did you write a check back to Calumet Mayor Jones City?" "You defer a check was written to me we can have this conversation Alderman Patton later."

expectation that meetings will start on time and be posted on time. So we can go back and forth about this all night. I'm asking my colleagues to strike number 2 from the agenda because its technically

false and defamatory to me."

# RESOLUTION NO. 24-50

# A RESOLUTION APPROVING RENEWAL OF CLASS 8 STATUS PURSUANT TO THE COOK COUNTY REAL PROPERTY CLASSIFICATION ORDINANCE AS AMENDED FOR CERTAIN REAL ESTATE LOCATED AT 1777 RIVER OAKS DRIVE IN CALUMET CITY

WHEREAS, the City of Calumet ("City") desires to promote the development of industry in the City; and

WHEREAS, the Cook County Assessor is operating under an ordinance enacted by the Cook County Board of Commissioners, and amended from time to time, the most recent amendment becoming effective as of November 4, 2014, which has instituted a program to encourage industrial and commercial development in Cook County known as the Cook County Real Property Classification Ordinance; and

WHEREAS, November 4, 2015, the City Council unanimously adopted a resolution in support of a Class 8 Incentive for Napleton River Oaks Cadillac, at 1777 River Oaks Drive, in the City; and,

WHEREAS, the Class 8 Incentive was subsequently approved by the County of Cook, and assigned a control number of 8433; and

WHEREAS, the Cook County Board has allowed renewals of the Class 8 industrial real estate tax incentive; and

WHEREAS, an application for renewal may be filed any time during and up to the last day of the incentive period; and

WHEREAS, in order to renew the Cook County Class 8 classification, a Resolution must be passed by the municipality in which the business is located and filed at the time the classification change is sought.

WHEREAS, Napleton River Oaks Cadillac, Inc. ("Napleton Cadillac") has applied for or is applying for renewal of the Class 8 property status pursuant to said aforementioned ordinance, for certain real estate located at 1777 River Oaks Drive, Calumet City, Cook County, Illinois, with the Property Index Numbers 29-24-200-090-0000; and

WHEREAS, the City has determined that the industrial use of the property is necessary and beneficial to the local economy as provided for in said ordinance;

NOW, THEREFORE, be it ordained by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, in the exercise of Calumet City's home rule powers as follows:

**SECTION 1:** The forgoing recitals are hereby incorporated into this ordinance herein as findings of the corporate authorities of the City of Calumet City.

SECTION 2: That the request of Napleton Cadillac to have certain real estate located at 1777 River Oaks Drive, Calumet City, Cook County, Illinois, legally described as follows, and with the Property Index Number 29-24-200-090-0000, declared eligible for an extension of its Class 8 status pursuant to the Cook County Real Property Classification Ordinance as amended November 4, 2014, is hereby approved in that this Board has determined that commercial use of the property is necessary and beneficial to the local economy.

# Legal Description

LOT 1 IN NAPLETON CADILLAC/LINCOLN RESUBDIVISION BEING A RESUBDIVISION OF LOT 1 IN HOFFMAN AND NAPLETON RESUBDIVISION OF LOTS 1 AND 2 OF BARA AND HOFFMAN RESUBDIVISION OF LOT 1 IN THE RESUBDIVISION OF LOT 2 IN RIVER OAKS WEST UNIT NO. 2, IN THE NORTHEAST ½ OF SECTION 24, TOWNSHIP 36 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS
