ADOPTION OF THE UPDATE OF THE COOK COUNTY MULTI- JURISDICTIONAL HAZARD MITIGATION PLAN

WHEREAS, the <u>City of Calumet City</u> recognizes the threat that natural hazards pose to people and property within our community; and

WHEREAS, the <u>City of Calumet City</u> recognizes the importance of reducing or eliminating vulnerability to disasters caused by natural hazards for the overall good and welfare of the community, and

WHEREAS, on October 10, 2000, the U.S. Congress passed the Disaster Mitigation Act of 2000 ("Act") which provides the legal framework for the Federal Emergency Management Agency (FEMA) mitigation, planning requirements for state, local, and tribal governments as a condition of mitigation grant assistance emphasizing the need for pre-disaster mitigation of potential hazards; and

WHEREAS, as a condition of future funding for mitigation projects, the Act requires jurisdictions to prepare and adopt a hazard mitigation plan to identify and address certain vulnerabilities that exist prior to and during a disaster; and

WHEREAS, FEMA supports pre- and post-disaster grant funding through the Hazard Mitigation Assistance Grant program, which has as a condition of funding eligibility, a requirement for jurisdictions to prepare and adopt a hazard mitigation plan; and

WHEREAS, to maintain continued eligibility for FEMA mitigation grant assistance programs the Act requires a hazard mitigation plan be updated every five years; and

WHEREAS, in accordance with the Act's requirements, 125 Cook County jurisdictions engaged in the FEMA-prescribed mitigation planning process to prepare the 2024 Cook County Multi-Jurisdictional Hazard Mitigation Plan and its associated local hazard mitigation plan annexes; and

WHEREAS, the 2024 Plan has been approved by the Illinois Emergency Management Agency and Federal Emergency Management Agency, Region V; and

NOW, THEREFORE, BE IT RESOLVED,

- The <u>City of Calumet City</u> hereby accepts, approves and adopts in its entirety, Volume 1, the Countywide Mitigation Actions in Volume 2; and the <u>City of Calumet City</u> Jurisdictional Annex of Volume 2 of the 2024 Cook County Multi-Jurisdictional Hazard Mitigation Plan.
- 2. The <u>City of Calumet City</u> will continue to participate in updating and revising the 2024 Plan, with another plan review and revision occurring within a five-year cycle. Designated staff will provide annual progress reports on the status of implementation of the 2024 Plan to the president of the City Council.

A RESOLUTION IN MEMORY OF THE LIFE OF LEONARD KIELTYKA

WHEREAS, the City of Calumet City ("City") is an Illinois home rule unit of local government; and

WHEREAS, the City has lost a valued member and leader of the City and its community on October 4, 2024 with the untimely and unfortunate death of Leonard Kieltyka at the age of 86 years old; and

WHEREAS, Leonard Kieltyka was born on June 4, 1938; and

WHEREAS, Leonard Kieltyka attended Chicago Vocational High School, and subsequently served in the United States Army from 1958 to 1960; and

WHEREAS, on August 16, 1972, Leonard Kieltyka began his distinguished career with the Calumet City Police Department, which includes serving as a patrol officer, a youth officer, a crime prevention officer, an accident investigator, and achieving the rank of sergeant, lieutenant, captain, and subsequently culminating to his promotion to Chief of Police in May of 1993; and

WHEREAS, during his illustrious career in the Calumet City police department, Leonard Kieltyka, colloquially known as "officer friendly," left an indelible mark of the Calumet City community; and

WHEREAS, Leonard Kieltyka was instrumental in establishing the police cadet program, supervised the juvenile division, served as the commanding officer of training and crime prevention, as the director of administrative services, and as the commander of the patrol division; and

WHEREAS, Leonard Kieltyka received numerous awards and recognitions from several community groups for his service, including being honored as Calumet City's Officer of the Year in 1975; and

WHEREAS, after 23 years of venerable service, Leonard Kieltyka retired from the Calumet City Police Department in 1995; and

WHEREAS, during his off time, Leonard Kieltyka enjoyed fishing, playing pool, wood working, horseback riding, golfing, and snow skiing; and

WHEREAS, Leonard Kieltyka is survived by his loving wife of 58 years, Joyce Kieltyka, his daughters Lorri (Mark) Hart, and Lisa (Steve) Belli, his sisters Joyce (Rich) Przybyslawski, and Diane (Jay) Stanwich, his sister-in-law Gerry Kainrath, his grandchildren William, Joshua, Christopher, Zachary and Connor, and his several nieces and nephews; and

WHEREAS, the death of Leonard Kieltyka has left the City and the community deeply saddened.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and City Council of the City of Calumet City hereby extend our sincerest condolences to Leonard Kieltyka's family and friends, and extend our sincere gratitude for the life, legacy, and contributions of Leonard Kieltyka to the City and its community.
