AN ORDINANCE AMENDING ARTICLE II OF CHAPTER 38 "HEALTH AND SANITATION" OF THE MUNICIPAL CODE OF CALUMET CITY

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of the City of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities have determined it is in the best interest of the health, safety, morals and welfare of the citizens of the City to update and amend Chapter 38, Health and Sanitation.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, AS FOLLOWS:

Section 1. That the City hereby incorporates all of the recitals above into this Ordinance as if fully set forth herein.

Section 2. That Article II "RESERVED" of Chapter 38 "Health and Sanitation" of the Calumet City Municipal Code is hereby amended to add the underlined text and delete the stricken text as indicated:

Chapter 38 - HEALTH AND SANITATION

ARTICLE II. - RESERVED CARE AND DISPOSITION OF HUMAN REMAINS

Sec. 38-31. Discovery. Any person who discovers the body of a dead human being, or any part thereof, shall immediately communicate to the medical examiner of the county the fact of such discovery, the place where and time when the same was discovered, where the same is or may be found, and any facts known by which the said body may be identified, or the cause of death ascertained.

Sec. 38-32. Funeral establishment as a public morgue.

No funeral director shall allow any establishment used, operated, or maintained by him in the funeral directing business to be used as a public morgue. If any dead human body is brought to any establishment, and if arrangements are not made for the burial or cremation of such body within 100 hours from and after the hour of death, the body shall be taken by the funeral director to the county morgue, or placed by him in one of the cemetery receiving vaults.

Sec. 38-33. Burial and cremation permits.

The Illinois Vital Records Act, as well as all rules and regulations promulgated and amended from time to time by the Illinois Department of Public Health under authority of that Act, governs as to death certificates and permits to transport, bury, entomb, disinter and dispose of dead bodies.

Sec. 38-34. Establishment or enlargement of cemetery.

It shall be unlawful for any person to establish, enlarge, or alter the boundaries of any cemetery within the city, or within one mile thereof, unless authorized by an ordinance of the city council.

Sec. 38-35. Burial within city.

It shall be unlawful to inter or bury any dead human body or part thereof in any place within the city other than a duly established cemetery.

Sec. 38-36. Enforcement

Citations of this Article may be issued by any city inspector or police officer. Proceedings to enforce violations of this article may be initiated and conducted in accordance with and pursuant to the provisions of the city ordinance providing for administrative adjudication of code violations or by any other means provided by law.

Sec. 38-37. Violation - Penalty.

Any person who violates, or who resists the enforcement of, any of the provisions of this article shall be fined not less than \$1,000.00 nor more than \$7,500.00 for each offense. Each day that a violation is permitted to exist shall constitute a separate offense.

Secs. 38-348-38-90. - Reserved.

Section 3: Superseder. In the event a conflict exists between the terms of this Ordinance and any other ordinance or resolution of the City, the terms of this Ordinance shall govern.

Section 4: Severability. This Ordinance and every provision thereof shall be considered severable and the invalidity of any section clause, paragraph, sentence or provision of this Ordinance will not affect the validity of any other portion of this Ordinance.

Section 5: Effective Date. This Ordinance shall be in full force and effect upon its passage and publication in pamphlet form, in accordance with law, and the provisions of the Calumet City's Municipal Code amended herein shall be reprinted with the changes.

ORDINANCE NO. 24-10

AN ORDINANCE AMENDING CHAPTER 90, ARTICLE V, DIVISION 1 OF THE CALUMET CITY MUNICIPAL CODE – HANDICAPPED PARKING

WHEREAS, the City of Calumet City ("City") is an Illinois home rule municipality organized and operating pursuant to the Constitution and laws of the State of Illinois.

WHEREAS, the City of Calumet City is authorized to pass and enforce all necessary police ordinances (65 ILCS 5/11-1-1), and to regulate the standing or parking of vehicles on streets and highways under the jurisdiction of the City (625 ILCS 5/11-208(a)(1)).

WHEREAS, the corporate authorities of the City of Calumet City desire to amend Chapter 90, Article V, Division 1, Section 90-317(g) of the City of Calumet City Municipal Code of Ordinances to designate 620 Price Avenue, Calumet City, Illinois 60409, as restricted handicap parking areas in the City.

WHEREAS, the corporate authorities of the City of Calumet find that amending Chapter 90, Article V, Division 1, Section 90-317(g) of the City of Calumet City Municipal Code of Ordinances promotes the best interests of the health, safety, and welfare of the City of Calumet City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, as follows:

<u>Section 1.</u> The forgoing recitals are hereby incorporated into this Ordinance herein as findings of the corporate authorities of the City of Calumet City.

Section 2. Chapter 90, Article V, Division 1, Section 90-317(g) of the City of Calumet City Municipal Code of Ordinances is hereby amended as follows (additions in **bold and double-underlined**):

Section 90-317. - Handicapped parking.

(g) Signed areas. The following areas are hereby designated as restricted handicapped parking areas by the city council, and appropriate signs shall be posted clearly indicating such areas:

WHEREAS, Karen Yarbough obtained her Bachelors Degree in Business Management from Chicago State University and received her Masters in Inner City Studies from North Eastern Illinois. Karen Yarbrough was a dedicated member of her Sorority Alpha Kapa Alpha, and

WHEREAS, Karen Yarbrough united with husband Henderson Yarbrough; former Maywood Village Trustee and Village President. From their union came six children and twelve grandchildren.

WHEREAS, Clerk Yarbrough had a great spirit, she filled every room she entered with energy and her memorable smile. Clerk Yarbrough exuded accuracy, efficiency and was innovative when it came to anything she was tasked with. Karen Yarbough was deeply loved and well-respected by her family, friends, colleagues, and members of the community; and

WHEREAS, Karen Yarbrough was the founder and CEO of Hathaway Insurance Agency, where she worked for thirty years. She served as president of the Maywood Chamber of Commerce and on the boards of United Way of Suburban Chicago and the Oak Park YMCA and

WHEREAS, Karen Yarbrough as a State Representative served on several house committees, including being chairwoman of the Housing Urban Development, vice-chairwoman of the House Insurance Committee, and the Environmental Health Committee, Appropriations-Public Safety Committee, and the Computer Technology Committee. Yarbrough was a member of the Illinois Legislative Black Caucus and;

WHEREAS, while holding the seat as Illinois State Representative; Karen Yarbrough spearheaded the Smoke Free Illinois Bill and worked tirelessly to get it passed. Karen Yarbrough championed abolishing the Death penalty in Illinois which was one of the most difficult times in her career and;

WHEREAS, after the 2008 Housing Crash Karen Yarbrough became inspired by her knowledge of the mortgage industry and the residents that needed her help. She focused on the race to become the next Cook County Recorder of Deeds. Karen Yarbrough concentrated on the Recorder of Deeds office because that's where she saw change needed to be implemented. Karen Yarbrough was elected as the Cook County Recorder of Deeds in 2012. Karen Yarbrough had a heart for the people of Cook County and fought against predatory lending and housing issues and;

WHEREAS; Karen Yarbrough focused on the issues that plagued the Cook County Recorder of Deeds office which were fraud, foreclosure, vacant properties, squatters, and lowered property values. Karen Yarbrough implemented programs that made the Cook County Recorder Department a national leader in property fraud awareness. Yarbrough implemented a review process to invalidate fraudulent recordings. Karen Yarbrough increased the number of registrants

from 500 to over 30,000 for the Free Property Fraud Alert Program. Karen Yarbrough's motto was Accuracy Efficiency, and Advocacy; and

WHEREAS, Cook County Clerk Karen Yarbrough promoted services for Cook County Veterans and opened an office where they could record their discharge paperwork and be provided with resources. Karen Yarbrough started a Military & Veteran Discount Program; and

WHEREAS, On November 6, 2018, Yarbrough ran unopposed and was elected as the Clerk of Cook County, becoming the first woman and African-American to be elected in that position. She took office on December 3, 2018 and served until her death on April 7, 2024; and

WHEREAS, Cook County Clerk Karen Yarbrough saw a need during Covid to merge the duties of the Recorder of Deeds, and the Cook County Clerks office; and

WHEREAS, Cook County Clerk Karen Yarbrough streamlined the election process. She worked tirelessly to make the voters registration process more efficient. Under her watch the Mail in Ballot program has elevated immensely. Cook County Clerk Karen Yarbrough had elections in cook county running smoothly and;

WHEREAS, Karen Yarbrough provided trainings for the City Clerk's within Cook County so that they could be knowledgeable and successful. The County Clerk made herself accessible to aid and assist any Cook County City Clerk. Cook County Clerk Karen Yarbrough initiated Property After Death Seminars and encouraged City Clerks to invite her team out to educate their city's residents. Karen Yarbrough included the City Clerk's in on any Outreach programs she may have been working on; and

WHEREAS, Cook County Clerk Karen Yarbrough lived a life of service as a State Representative, Recorder of Deeds, and Clerk of Cook County. and;

WHEREAS, Cook County Clerk Karen Yarbrough received the Woman of Excellence Award from the Calumet City Council presented by City Clerk Dr. Nyota T. Figgs in 2022; and

WHEREAS, Cook County Clerk Karen Yarbrough mentored Calumet City Clerk Dr.

Nyota T. Figgs in friendship, leadership, politically and in sisterhood; and

WHEREAS, Karen Yarbough was deeply loved and well-respected by her family, friends, colleagues, and members of the community; and
