BE IT RESOLVED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, THAT:

**A RESOLUTION
APPROVING A CLASS 8 DESIGNATION AND ENTERPRISE ZONE
INCENTIVES FOR 602 STATE STREET**

(BYERLEY INVESTMENT GROUP, LLC)

shall be, and is hereby, adopted as follows:

Section 1. BACKGROUND.

A. The City is a home rule unit of local government by virtue of the provisions of the Illinois Constitution of 1970.

B. Byerley Investment Group, LLC, (herein after "*Developer*") has purchased the property at 602 State Street in Calumet City (*herein after "Subject Property."*)

C. Developer had previously petitioned the City for a Class 8 Designation and Enterprise Zone. On April 11, 2024, the City approved Resolution No. 24-12, "A Resolution Approving a Class 8 Designation and Enterprise Zone Incentives for 602 State Street." Developers have since learned that the Subject Property was vacant just short of twelve (12) months and are now seeking a Class 8 Designation for Special Circumstances.

D. The Subject Property is in need of extensive updates and had been vacant for eleven (11) months at the time of purchase.

E. The Developer desires to redevelop the Subject Property for manufacturing water treatment equipment (the "*Project*").

F. The improvements to the Subject Property will involve a complete interior renovation, new docks, roof, HVAC and re-asphalting the property.

G. The Developer anticipates that the Project will cost approximately five million dollars (\$5,000,000) in capital improvements to the Subject Property.

H. Developer already employs one hundred and sixty (160) individuals in Cook County. The Project is anticipated to employ fifteen to twenty (15-20) additional employees. Bringing new jobs to the City will increase the City's tax base.

I. Developer is seeking a class 8 exemption with special circumstances as the Subject Property had been vacant, for less than (12) months. The Property needs extensive improvements, and without a Class 8 Exemption, it will not be financially feasible for Developer to make such improvements. Given the difficulty of sustaining businesses in the area, and that the property will remain vacant without the Class 8 Exemption, special circumstances exist for which to deem the Subject Property abandoned for purposes of the Class 8 Exemption

J. The Subject Property is currently located in the Calumet Region Enterprise Zone and is currently designated as an area by the City to be eligible for and approved by the Cook County Assessor for the Cook County Class 8 property tax incentives to promote redevelopment projects ("Incentives"). The Developer desires to obtain Incentives for the Subject Property.

K. The City seeks to promote new businesses as part of its economic development strategy, which will create new job opportunities for City residents and sources of revenue for the City.

L. The City is willing to assist the Developer by obtaining Incentives for the Property as of the Effective Date.

M. The Corporate Authorities, after due and careful consideration, have concluded that a Class 8 Tax Incentive for the Subject Property is necessary and in the best interest of the City in order to promote the redevelopment and use of the Subject Property, which will in turn promote the public health, safety, and welfare and serve the best interests of the City and its residents.

Section 2. **CLASS 8 TAX INCENTIVE APPROVAL.**

A. The Mayor and City Council find that:

1. the Subject Property is appropriate for Class 8 Tax Incentive benefits pursuant to the Cook County Real Property Classification Ordinance, as amended; and
2. the Class 8 Tax Incentive for the Subject Property is necessary to encourage redevelopment and occupancy of the Subject Property by the Developer, and that occupancy and use of the Subject Property is beneficial to the City's economy; and
3. the Mayor and the City Council approve, support and consent to the Class 8 Tax Incentive for the Subject Property.

Section 3. **RECORDATION.**

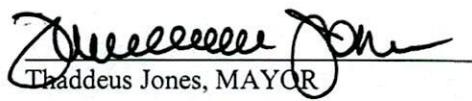

Section 4. **EFFECTIVE DATE.**

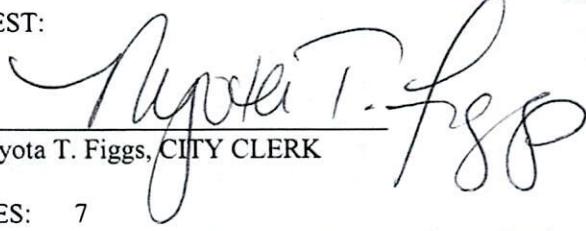

We are paying a lot of money to a lot of people and I don’t see the work. I am hesitant to... I understand these people have already been paid but we may need to meet to open up the Salary Ordinance and correct it based off of the job description and have a conversation with the HR director. I am also concerned that we have new IT employees here; same concern from last time, they were under a contract that we did not extend but now they’re employees. So now I’m concerned about that and needing to find out what the legality surrounding that is. That’s it. That’s my discussion.”
