Mr. Garcia thanked the council for supporting Schrum Memorial Middle Schools 7th and 8th grade boys basketball team.

Chairman Williams Deviated from the Regular Order of **Business**

Public Safety Chairman deviated from the regular order of business for a presentation from the ESDA Director Kenny Jones

ESDA Presentation By Kenny Jones

ESDA Director Kenny Jones presented a spreadsheet to the council detailing the dailey duties of ESDA officers. Director Jones commented on a Trauma Care training taken with the Police Department. Director Jones listed ESDA employee job functions; which include securing City Hall, Calumet City Library, Markham Courthouse runs, and providing assistance to Calumet City Police and Fire Departments when needed.

Crossing Guard Safety Plan

There was a detailed discussion of the crossing guard contract. The topics discussed were liability, costs, and fiscal responsibilities.

Police Chief Kolosh

Police Chief Kolosh commented on the liabilities Crossing Guard Services would take if they were hired to provide crossing guards in Calumet City.

Alderman Patton

Alderman Patton commented on the importance of having a meeting with Calumet City School Boards and Attorney Stillman before making a decision regarding contracting with Crossing Guard Services.

Fire Chief Bachert

Fire Chief Bachert reported on the hiring of three new firefighters/paramedics. Chief Bachert commented on the goal of having 54 employees in the Fire Department. Chief Bachert announced that Prairie State is offering a free Firefighter and Paramedic course; each certification is a semester long. Chief Bachert reported that a request for a new Ambulance will be on the April 25, 2024 agenda that is not expected to be delivered until 2026 due to a back log.

Chief of Police Report

Police Chief Kevin Kolosh gave a report regarding crime in the City of Calumet City for 2024. Chief Kolosh reported 3 homicides, a 252% increase in recovered firearms, shooting incidents are down 24% in 2024, 2 reported car jackings, car thefts have decreased, retail theft has increased, there has been 2,201traffic stops in 2024 thus far. Police Chief Kolosh concluded his report by informing the council that citations are down 24%.

Police Summer Plan Assistant Chief Kwiatowski presented the Calumet City Police Summer Plan and gave details regarding the goals for the Police Officers biking around the city.

Assistant Chief Black reported on the new devices, and cameras that have been placed around the city to help prevent crime.
