Williams

Mayor Pro Tem Alderman Williams led a discussion regarding the invoice and explanation of the \$140.84 for Café Borgia that appeared on a previous bill listing for payment. Mayor Pro Tem Williams reported that the \$140.84 bill was from a lunch outing with the union. Mayor Pro Tem Alderman Williams also reported that the \$545.00 invoice for Bills Grill was for the food at The Breast Cancer Walk and for Bills Grill's grand opening.

## Discussion and Action Regarding Café Borgia And Bills Grill

Alderwoman Wilson stated “Café Borgia this \$140.84 the explanation as Mayor Pro Tem stated was to take the union out to lunch, however this is the smallest amount we’ve seen per credit card bills from January 2025 to October 2025. Café Borgia bills are almost \$3,000.00 on the city credit card. So, I am requesting that we do not pay this amount. That will be one of those expenditures that I am going to request be reimbursed by the Mayor. Bills Grill for \$545.00 the explanation was for the Breast Cancer Walk and their Grand Opening. The Breast Cancer Walk was held at a local school not at Bills Grill. I understand they had a grand opening that same day we normally do not pay for people’s grand openings. If you are a business coming to Calumet City thank you for choosing Calumet City to open but all of that is the responsibility of business owner not the taxpayers of Calumet City.”

"I'd just like to add to that, in light of issues, pending credit card issues and expenditure issues. I, myself, cannot support this expenditure

seeing that there is no supplementing documentation for purchase.”

"It's not just that, one we did not use that DJ because we were there, all of us. Two it is more than just that it's one for Wednesday October 29<sup>th</sup> and in the bills, it says Return to Soul with performance of light performance of light jazz and R&B flavor and it goes on to talk about the keyboardist, the bass, and saxophonist and it says that it was already paid and it was PayPal and it was paid to Mr. Harper. The other invoice was November 18<sup>th</sup> this first one was at Greenhouse on 1340 Ring Road. The other one is Greenhouse and this one was November 18<sup>th</sup> same thing, so there's another \$650.00 invoice and that's one this is two; then there's another that's December the 10<sup>th</sup> 3:00 p.m. to 5:00 p.m. and it's at River Oaks Townhome 1 Chestnut Court that's three. Then we have another that is December the 17<sup>th</sup> and it says the

same thing with the performance and the time is from 3:00 p.m. to 5:00 p.m. and it's Craig Harper and it says something about PayPal. I don't know if it's been paid but it looks as if it has, but again I can't verify that. So that is four different things of different events that the city held and it's apparent that there is a lot going on and we need to deal with this but it's apparent too that we can have events and nobody knows but certain people. If it's a personal event I understand that or if you are doing it for your ward, but these are city events. And some of us are at these events. What it is for me is that it's unfair that I see that as you campaigning for your own benefit instead of every city member being invited to this stuff. I know people don't want to hear us talk about this and I'm getting beat up on both sides. I'm voting because I know this is what I was elected to do. I may not move at your speed and I may not move at his, but we need to stop this, we do. I mean if we do these things to make the staff that we pay these high salaries to let us know what's going on here; to keep us all engaged and in the loop."

Return to Regular Order of Business Alderwoman Wilson moved, seconded by Alderwoman Harvey to return to the regular order of business at 7:21 p.m.

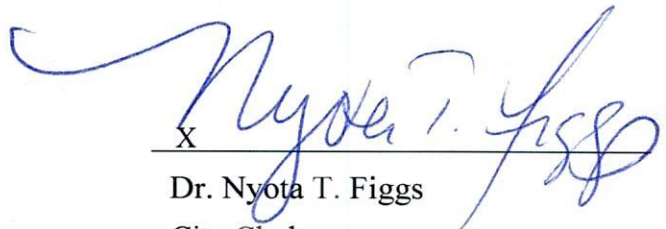
