## Two (2) Items for the 1/04/2021 CITY COUNCIL MEETING:

# 1. Why do Comments/Questions to the City Council not get answered or even posted into the PUBLIC COMMENTS FOLLOW UP section of the City Website?

### 2. NW Lake Road and NW Sierra Street Traffic Signal:

This item was listed as a \$2.5M line item as part of the \$78M in the Failed Prop 2 in the 2019 Election.

This item is now listed as #8 on the City of Camas 2020-2025 Six Year Street Priorities.

Steve Wall said earlier this year that it was considered a "Priority Project".

It is not listed in the 2021/2022 Capital Decision Package.

We all understand the budgeting process and that if you don't ask for it and put the line item in the 2021/2022 Capital Decision Package then it will not happen in the next 2 years minimum.

You have to ask for it to get it approved.

The status on this project was asked of Steve Wall in an email 11/02/2020.

Neither my sister nor mom are able to drive and being able to walk parts of Camas is really important to our family. And being able to go for daily walks has been a lifesafer for many of us during this year of Covid. Yesterday the weather was surprisingly good and it was wonderful to see so many residents out enjoying our trails and sidewalks. My wife and I made it downtown and we were encouraged to see the new wayfinding signage along 1st and 2nd Avenues. Thank you for that addition.

Some quick thoughts on protecting and improving walkability in Camas:

- Nudge property owners to keep sidewalks and ROWs clear
- Consider joining the <u>20's Plenty</u> campaign to lower auto speeds and increase pedestrian safety <u>http://www.20splenty.org/</u>
- Look for easy connections to existing trails or sidewalk networks
- Consider road diets for NW 6th Ave on the west end of town and NE 3rd Ave on the east (both roadways could be reduced to one lane in each direction opening up opportunities for bike lanes, left turn lanes, parking, and much improved safety)
- Make walkability a key design principal for any new development especially downtown and near downtown (the lab property in particular is likely to develop sooner rather than later and is likely to be a key connection)
