## Dear Council Member,

This note is prompted by a report in the detailing proposed salary increases for non-represented personnel. The proposed 4.5% COLA is appropriate due to the current level of inflation that will likely last through 2022 and into 2023.

I read the proposed salary increases with increasing concern. I understand the consultants survey reflects salaries they consider to be at current levels for similar cities. As a percentage and as whole dollars, implementing them because of the report is not a fiscally sound policy. If there was significant staff turnover (I don't consider the recent Mayor and City Manager relative), then some adjustment might be in order.

It is a well accepted management mantra that for the most part people do not leave for money, they leave because of leadership dissatisfaction. In cases, where job responsibilities change, an adjustment is reasonable. Absent staff turnover, significant increases simply because of a report is not enough justification.

An argument might be made that by not adjusting salaries to the recommended salary levels will result in job dissatisfaction. This could be true unless staff has been apprised of the report and its limitations. What was published in the paper were from and to numbers without comment. Salary surveys are a recruiter's dream.

Not being privy to discussions, I would encourage city management to review each position's job description and determine where there can be increased responsibilities or recognition of performance that went unnoticed. A plan to adjust work responsibilities to a sequence of salary increases until the desired salary for the particular job is reached becomes an action plan that can be budgeted year after year. Simply saying the survey says and handing out cash belongs on TV, not in City governance. Respectively,
