#### **MINUTES TO BE APPROVED**

2. Fire Department Promotional List Extension Request

Chief Swinhart explained that the current BC promotional list is expiring soon, and the department does not have the available time or qualified staff to hold another promotional exam. Chief requests a six-month extension to the current list.

It was moved by Goodpaster, seconded by Burrows, that the current promotional list's expiration date be extended by 6 months. The motion carried unanimously.

Secretary Jones gave a brief overview of the Code Enforcement hiring process and submitted the list of candidates for approval.
