**BACKGROUND:** Universal JiuJitsu is located at 217 NE 4<sup>th</sup> Ave. The gym offers martial art lessons that vary from 1-hour to 1.5-hours. Parking on NE Adams Street and NE 4<sup>th</sup> Avenue is designated as 2-hour limit.

**SUMMARY:** Mel Locke, owner of Universal JiuJitsu, is requesting parking time limit to increase to 2.5-hours on NE Adams St. and NE 5<sup>th</sup> Avenue. 2-hour parking is currently the predominant parking designation in the downtown core. In their written request it is stated that "Most customers are shopping and or patronizing more than one business that takes up more than 2 hours. Also, now that MESA took 5 spots on 4th street with their outside tent, it's even more important that the time spot is extended."

**BACKGROUND:** Prashant Gupta, managing partner of Camas Boutique Hotel, had requested that the two 10-minute parking spaces in front of the hotel on NE 4<sup>th</sup> Avenue be designated as a loading zone. The Parking Advisory Committee (PAC) recommended the proposed redesignation to a loading zone to Council.

**SUMMARY:** This item was presented at Council Workshop on February 22. Council was not in support of designating a loading zone on 4<sup>th</sup> Avenue and has remanded to PAC to consider a potential one-spot loading zone location on one of the side streets.

NE Cedar Street has an existing Loading Zone spot (9 am - 6 pm Mon - Fri) on the west side. There is a Handicap spot on the east side closest to the hotel.


