SUMMARY:

On March 26, 2025 sealed bids were opened for the 2025 Citywide Hot Mix Asphalt (HMA) Repair contract. The engineering estimate was \$1,229,500. The City received five bids. The apparent low bidder, Granite Construction Company, provided a contract price of \$959,200. The second low bidder, Lakeside Industries, provided a contract price of \$1,030,444. The bid tabulations are attached for reference.

As noted in the Bid Tabulations, the apparent low bidder, Granite Construction Company, did not submit one document on the bid submittal checklist. At the time of bid opening Granite Construction did not provide a full and complete copy of their Memorandum of Understanding (MOU) issued by Homeland security. After the bid opening staff verified that Granite Construction Company does have a current MOU in place with Dept. Homeland Security effective April 20, 2020 (Company ID1579509). Granite submitted the MOU after the bid opening.

Council will be asked to decide whether Granite Construction's bid proposal has a minor or major irregularity. If Council deems that Granite Construction's bid has a major irregularity, Granite's bid must be rejected. If Council rules the irregularity as minor, Council must decide whether to accept or reject Granite's bid.

RECOMMENDATION:

Option:	Result:
If Council determines the omission is a minor irregularity , Council has two main options:	Council may waive the minor irregularity and determine Granite Construction's bid to be responsive. Council may award to Granite Construction for \$959,200.
	Council may reject Granite Construction's bid as non-responsive due to the minor irregularity and award to Lakeside Industries for \$1,030,444
If Council determines that the omission is a major irregularity :	Council must reject the low bid from Granite Construction Company determining it to be non-responsive. Council may award bid to Lakeside Industries for \$1,030,444.
The Council can reject all bids	Direct staff to readvertise for bids

Council has several options when considering potential award of a bid as outlined below:

POTENTIAL CHALLENGES: If all bids are rejected the project will need to be readvertised and a new bid opening scheduled. This delay could have impacts to schedule and pricing. Asphalt repairs can only be made during suitable weather (typically June-September).

BUDGET IMPACT: This project is fully funded by the Pavement Preservation Fund.

MEMORANDUM

RE:	Bid irregularity – Citywide HMA Repairs Project
DATE:	April 3, 2025

The apparent low bidder, Granite Contruction Company, submitted a bid that varies from the instructions. Specifically, the specifications require that a copy of the E-Verify Program MOU be provided with the bid proposal. I understand the MOU showing their enrollment in the E-Verify Program was provided by to the City soon after the bid opening and the MOU shows enrollment by the contractor. Lakeside Industries, the second low bidder, has given preliminary indications they will contest the award to Granite, which will be discussed below.

The first step when the City obtains bids that vary from the bid specifications in some respect is to ascertain whether those irregularities are substantial and material or whether they are minor in nature. A material irregularity is defined as an irregularity giving the bidder a substantial advantage or benefit not enjoyed by other bidders. Any bid containing a material irregularity must be rejected. On the other hand, if the irregularity is deemed to be minor, then the City may either reject the bid, or waive the irregularity and accept the bid. *East Side Disposal Company v. Mercer Island*, 9 Wn. App. 667 (1973); *Gostovich v. West Richland*, Wn. 2d 583 (1969); and *Farmer Construction v. State*, 98 Wn. 2d 600 (1983).

In determining whether there is an undue advantage conferred upon a bidder, the courts principally look to whether the defect is such as would allow the bidder to avoid performing the contract. A bidder is found to have a substantial advantage if it has the option of deciding whether to perform or not, depending on how the other bids are submitted. In *AAB Electric v. Stevenson Public Schools*, 6 Wn. App. 887 (1971), the low bidder neglected to sign its bid. The school board awarded the contract to the second bidder, and the school board's action was upheld by the court, because the bidder, not having signed its bid, was in a position where it could decide whether or not to accept the award and perform the work. The court held that the omitted signature could only be considered to be a material defect, because the bid was not binding upon the bidder until properly signed by its corporate officers.

In both *East Side Disposal* and *Farmer Construction*, the low bidders signed the bid bond, but neglected to sign the bid proposal. The court in both cases held that the failure to sign the bid proposal was a minor irregularity that could be waived. The court held that, if it appears from

examination of all the writings that the writing which was signed by the party to be charged was signed with the intention that it refer to the unsigned writing, and that the writings are so connected by internal reference an assigned writing to the unsigned one, they may be said to constitute one paper relating to the same contract. Thus, the irregularity was deemed minor, because the bidder could not get out of the contract, and the city had the option to accept the low bid and waive the irregularity, or to reject the low bid on the basis of the irregularity.

It is clear from reading the cases that questions of whether a bid variance is material are questions for the city council. *R.W. Rhine Company v. Tacoma*, 13 Wn. App. 597 (1975). So long as the council's determination is made in good faith, it should be upheld by the court.

Thus, in this case, the City Council would need to make the following determinations:

1. Is the irregularity in the bid substantial or minor? If it is substantial, then the bid must be rejected.

2. If you determine that the irregularity is minor, then you must decide whether to waive the irregularity and accept the bid, or to reject the bid on the basis of the minor irregularity.

3. Please note that the City always reserves the right to reject all bids and rebid the project.

As to the failure to submit the MOU, this appears to be a record keeping function which, while required, does not rise to the level of a substantial issue preventing the apparent low bidder from entering into the contract. Accordingly, the discretion as to whether to waive this irregularity as well is within the discretion of the Council. For guidance here the Council should note that this *exact same issue* arose in 2019, with the parties reversed. In that case Lakeside did not timely submit the MOU and Granite was the second low bidder. The Memorandum from that case has been provided here as well. In that case the Council also waived the irregularity and awarded the bid to Lakeside.

Accordingly, whether to waive this irregularity in the bid is within the discretion of the Council. If the Council determines that the irregularity is minor, then when deciding whether or not to waive the irregularity, it should remember that the purpose of competitive bidding is to provide for public contracts to be performed satisfactorily and efficiently, at the least cost to the public, while avoiding fraud and favoritism in the awarding of such contracts.

BACKGROUND: Staff presented proposed changes to City Council at the December 2, 2024 workshop related to utility billing. General information was provided at this meeting, highlighting some upcoming changes for utility billing including changing to monthly utility billing and allowing tenant billing. These code changes were presented to City Council at the March 17, 2025 Workshop for review.

SUMMARY: Ordinance 25-003 revises Camas Municipal Code (CMC) Chapters 13.40, 13.44 and 13.64 for these changes.

BENEFITS TO THE COMMUNITY: A monthly utility bill provides several benefits to citizens, as we will be able to identify any potential leaks sooner with more frequent readings, monthly bills will be smaller than the current bi-monthly bill which means more stable and predictable bills, and smaller bills will lead to fewer disconnections for non-payment. Additionally, the ability for tenants to sign up for their own utilities will make for a more efficient utility billing process.

POTENTIAL CHALLENGES: The changes to the utility billing calendar may be a challenge as citizens get accustomed to a different billing cadence.

BUDGET IMPACT: These changes do not have any budget impact. However, a monthly billing cadence will improve the cash flow for the utility funds.

RECOMMENDATION: Staff recommends that Council consider the adoption of Ordinance No 25-003.

ORDINANCE NO. 25-003

AN ORDINANCE OF THE CITY OF CAMAS, WASHINGTON, RELATED TO UTILITY BILLING AND AMENDING CHAPTERS 13.40, 13.44, AND 13.64 OF THE CAMAS MUNICIPAL CODE.

THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

Section 13.40.020, Subsection B – Meter – Reading is hereby amended to provide as

follows:

B. Other than regularly scheduled reading of water meters, water meters may be read by the city on the day a notice of change of tenancy or ownership is delivered to the city or as close as possible to such day as required in CMC 13.44.040.

Section II

Section 13.44.010, Subsections A. and D. - Charges – Metered Service – Billing intervals

is hereby amended to provide as follows:

A. All residential and most commercial water services shall be billed at regular intervals and shall be due and payable on the twenty-first day of each month following billing. Such billings shall be delinquent on the twenty-sixth day of the month following billing.

D. There shall be a penalty on all delinquent accounts assessed at the rate of five percent of the outstanding balance.

Section III

Section 13.44.015, Subsection B. - Billing Liability – Rental Properties is hereby amended

to provide as follows:

B. Except as hereinafter provided, all billings for utility services provided by the city shall be mailed to the record owner of the subject property at the record owner's address. In the event that billings are sent to a tenant or agent of the owner, the billing will become the responsibility of the tenant or agent as well as the property owner, and each can be held jointly and severally liable for such billing.

Section IV

Section 13.44.020, Subsection A. – Nonpayment – Shutoff – Hearing – Disconnection

Fees is hereby amended to provide as follows:

A. Whenever any charge for furnishing water and/or sewer services to any premises is not paid in full by the twenty-sixth day of the month following billing, the finance department shall give notice to the person or persons billed for such services at the address shown in the city's billing records of the city's intent to discontinue service if payment is not made. Such notice shall contain the following information:

1. The amount of the charges owing;

2. A statement that the person billed may request a hearing to contest the amount or validity of the charges;

3. A statement that if the charges are not paid in full or a hearing requested within ten days of the notice, the city will disconnect the service of water to such premises.

Section V

Section 13.44.040, Subsection A. - Service Termination is hereby amended to provide as

follows:

A. Each customer about to vacate any premises supplied with water service by the city shall give notice of their intended removal at least two days prior thereto; specifying the date change-in-ownership or tenancy actually occurred, otherwise, they will be responsible for all water supplied to the premises until the city water department has notice of such removal.

Section VI

Section **13.64.060** – Sewer Volume Charges is hereby amended to provide as follows:

The sewer volume charges for each residential customer from November 1 through February 28 shall be based upon that customer's actual water consumption during that period. The four billing cycles between November 1 through February 28 shall be the customer's "four billing cycle water consumption history." The sewer volume charges for each residential unit for the remainder of the year shall be based on the average water consumption in the previous "four billing cycle water consumption history." Zero water consumption in any of the four water consumption history billing periods shall not constitute a "complete four billing cycle water consumption history."

A. Residential customers that have a "complete four billing cycle water consumption history" as specified above shall be charged the applicable inside city or outside city monthly sewer charge and volume charge as set forth in the chart in Section 13.64.010 above.

B. Residential customers that do not have a "complete four billing cycle water consumption history" as specified above, shall be charged the applicable inside city or outside city monthly service charge set forth in Section 13.64.010 and a volume charge equivalent to seven hundred cubic feet of water usage as the monthly sewer billing rate.

C. Residential customers may apply for a reduction in sewer rates when, due to a qualifying leak as defined in Section 13.44.030, the sewer charge is substantially increased. The amount of the reduction shall be calculated in the same manner as a water leak credit as set forth in Section 13.44.030.

Section VII

This ordinance shall take force and be in effect five (5) days from and after its publication

according to law.
