Ellen Burton introduced Chris Witkowski, the new City of Camas Parks & Recreation Director. Witkowski gave a brief history of his previous work in Parks & Recreation.

Rachal stated that the cove will be closed at Lacamas Lake for Clark County algae testing. Witkowski provided a department staff update including updates on summer special events.


