Question 1: Why do you want to serve on the City Council?

- 1) I Have Deep Roots With a Vested Interest in Effectively Representing Ward 1: Over the past 55 years, I have been a lifelong resident of Camas and Washougal. I grew up in Ward 1, and over the course of many decades I have developed deep relationships with my Ward 1 community and have become well-known in Ward 1 as a positive and supportive neighbor. With my deep roots and long-standing relationships with many Ward 1 constituents, I will effectively represent and advocate for the needs and well-being of all people living in Ward 1.
- 1 Have Recent Election Experience That Can Make City Government More Effective: While my deep history with Ward 1 is important to be effective on City Council, I understand that Camas City Councilors must look at issues through (at least) two sets of glasses one set that focuses on the needs and concerns of the Ward of which they represent, but also a second set that comprehensively looks at issues on behalf of all Camasonians to ensure each and every one of its citizens are fairly represented. Last year, I ran for the Ward 1, Position 2 on Camas City Council. In the General Election I narrowly came in second place, supported by 48.5% of the voters of Camas, earning 3,700 votes only 200 shy of winning last year's Ward 1 election. During my recent campaign, I heard from many Camas citizens throughout all three Wards about what is most important to them, their families and their community. My six-month campaign journey afforded me unique perspective and insight as to what is of utmost concern to our entire electorate right now. My current, comprehensive, and deeply personal perspective of our electorate is unlike any other candidate in the vacancy appointment process. Whether on a porch step, family room couch or dining room table while I was door knocking throughout Camas, I actively heard the hopes, excitement and vision for the Camas our citizens want in the future. I strongly believe that the comprehensive and most up-to-date feedback I received during my campaign will be highly beneficial to the Camas City Council as, together, we tackle the many challenges that lie ahead of us.
- Being Appointed as Ward 1 Counselor Affords the City Council a Unique, Unprecedented Opportunity to Fully Represent the Entire 2021 Electorate: It is certainly worth noting that appointing me to the Ward 1, Position 1 vacancy gives the Camas City Council a very rare opportunity to have Ward 1 representation that reflects the votes and will of almost the entire Camas city electorate. In November 2021, Councilor Boerke received 51.28% of the general election vote and I received 48.42%. By appointing me to fill this vacant seat next to Councilor Boerke, Camas City Council would ensure that 99.7% the citizens' 2021 Ward 1 general election votes would be represented on the Council. In other words, the will of 7,682 voters will be collectively represented in Ward 1. I cannot recall a time in my 55-year history here where Camas held a general election with two or more candidates and the final result ended with 99.7% of the electorate getting their preferred candidate installed as City Councilor. Camasonians want better trust and collaboration between themselves and our local city government. Camas City Council, by using its 7 votes to fully represent and act upon the will of 7,682 citizens who have already voted on this issue, would go a long way to helping rebuild that trust our community so desperately needs right now.
- 4) The Future of Camas is Bright and Worth Working Hard For: Camas clearly wants to move beyond its' recent turbulent past and move towards a better tomorrow. I heard that everyday while on the campaign trail. Collectively, citizens regularly told me that they wanted to "Move Forward" and NOT elect or appoint officials who helped create or vocally supported the past issues that have led to mistrust or frustration throughout the electorate like the pool bond. Instead, they wanted to focus on a better tomorrow for Camas. A tomorrow that brings smart, sustainable growth that provides affordable housing, thoughtful transportation and infrastructure planning, and brings new, long-lasting living wage jobs to our community. A future that protects and celebrates the heritage of our small-town roots, but also embraces intelligent growth opportunities and redevelopment plans where they make sense for our community. A future created collaboratively between elected officials, city staff and the citizens in a transparent and effective manner. The Camas I shared time with during the past year knows we have significant challenges that face us, but believes that together we can successfully navigate those challenges to create a community we all can be proud of for decades to come. On behalf of all Camasonians, that is an impactful, powerful legacy I that am willing to tirelessly work for.
- 5) 30 Years of Small Business Experience Brings Diversity of Thought to Camas City Council. I bring three decades of Camas-grown, private-sector, small business experience to City Council. I bring real world experience in economic development strategy and attracting, retaining and developing labor. My experience owning a small business in Camas would be a very beneficial perspective to bring to Camas City Council. I personally know the challenges the pandemic brought to the small business community. I know how each of our small businesses throughout Camas are the lifeblood of our local economy and foundational to the heritage we have created and the future we will construct for tomorrow. I know with my small business experience I can be an effective sounding board and advocate for our Camas Chamber of Commerce and Downtown Camas Association. I believe the Camas City Council needs diversity of thought, backgrounds and experiences in order to truly represent the citizens of Camas. I also believe that I bring a diversity of thought and experience that would help the Council be more effective in its work.

Question 2: What experiences, talents or skills would you bring to the Council and community?

Refer to paragraphs 1-5 above to answer part of this question. However, more specifically, as a national executive recruiter and business owner for the past 27 years, my job requires me to be diversified in thought, ideas and cultures, and utilize a skillset to "think out of the box" in order to propose solutions that can encourage a diverse group of people to make the best decision for the common good of an organization. I will bring these skills to Camas to represent the people of Camas as well.

Also, I learned that I cannot be a successful business owner without understanding the need of teamwork, collaboration and helping others before helping myself – certainly throughout the pandemic which hit our community and small businesses so hard. I heard a saying a long while back that stuck with me, "A rising tide raises all boats." What that meant to me was that if I can help make others successful in their work around me, then I too would be successful in my work. We all rise to become better, more successful together. I think this work-ethic that I believe in would be very valuable to the Camas City Council. I understand that I cannot work alone, must collaborate, support and learn from my fellow Councilors and that together we will effectively and successfully manage the challenges ahead of us.

In working with and representing many different clients throughout my 27-year professional career, I have learned the important skill and ability to interact with many different types of people from all sorts of stations in life. I can easily have a complex business discussion with a CEO of a Fortune 500 company and then switch to having a plumbing discussion with a local custodian. Having the competency to effectively listen and communicate in many different types of situations and connect personally with many different people in many different environments is an important part of being a successful elected official.

As a business owner, I am task-oriented and results-driven. I hold myself and others accountable for achieving results, not the amount of activity or discussion generated. I think that is what the citizens of Camas hold local government accountable for as well. Camasonians expect and deserve results – completing projects on time and on or under budget, making timely policy decisions, and progressing forward towards a better, brighter tomorrow in a cadenced and reliable manner. I will do my part to make sure we achieve results together as a Council and do so in a timely manner that meets or beats the high expectations of our citizens.

Question 3: Explain your views on how the City of Camas should address budgetary difficulties.

As a Councilor, I would likely have access to the minute details of the budget. However, I am not a Councilor yet, so it's difficult to answer this question with a definitive answer. Honestly, I would collaborate with and learn from our City Staff who are the experts on our city budget, as well as learn from the other City Councilors and the City Administrator. I couldn't make fully informed budgetary decisions without first taking the time to learn from them, ask questions and be actively engaged. That said, below is an attempt to address this question from a citizen's point of view:

My initial assumption, from the question asked, is that the city is facing many large, critical capital expenses (like, for example, constructing new fire stations, wastewater treatment upgrades), evaluating many parks and recreation projects/upgrades (like, for example, the Crown Park upgrade, Legacy Lands Master Planning, T3 trailhead construction) and still having enough money left over to pay for important transportation and road improvements throughout the city. This is only a snapshot of the multitude of items before the Council for consideration in its bi-annual 2023-2024 Budget planning. So, a challenge may be that the Council has to balance these important needs with a current revenue base that might not adequately fund all the needs. Here are a few items that I would consider after careful consultation and in collaboration with City Staff and the Council:

- 1) Categorize all the needed and wanted cost items into prioritized buckets (Mission Critical, Compliance-Driven, and Nice to Have or something like that, there may be other buckets or other terminology used as well). Then use those buckets to create a short-term, medium-term and long-term budget calendar. That long-term budget calendar could, for example, be viewed in 1, 6 or 20 year increments and help inform the Council on whether revenues need to be raised in the short, medium or long term to meet the agreed-upon budget calendar. I believe that strategy fails without structure. Develop the short, medium and long-term strategy for executing these cost items and then build the bi-annual revenue structure to execute the strategy. Sometimes, that means revenue needs to increase, but sometimes it means it can hold constant or even go down if these cost items are spread out over time and properly sequenced. In short, prioritize the cost items, build a short, medium and long-term strategy to complete those cost items, and then build a revenue structure to effectively execute the strategy.
- 2) To develop new revenue, we should encourage and incentivize new businesses to come to Camas. It is common knowledge that businesses have left Camas in the recent past. We should consider, to the extent it isn't happening now, actively recruiting companies to relocate to Camas. I am a professional recruiter, I can definitely help we those efforts. And, as part of our recruiting efforts, we should consider using municipal incentives to encourage businesses to call Camas their new home like Tax Incremental Financing (TIFs) or any national or state grants that would help subsidize or incentivize relocating businesses to Washington State. Adding more businesses and creating new jobs here in Camas is an effective way to organically increase revenue in Camas.
- 3) To increase revenue, we should at least explore logical, common-sense revenue sources that many other cities in Washington already utilize. One example would be considering the implementation of a Transportation Benefit District (TBD) in Camas. TBDs are quasimunicipal or independent taxing districts that could impose a sales tax or vehicle license fee within Camas' boundaries to directly help pay for various transportation and road improvement projects in Camas. We could also consider Excess Property taxes and Local Improvement Districts, among other things. As a citizen and not a Councilor at this point, I am not in a position to say whether these should be implemented or not. However, as an "out of the box" problem solver and thinker, these are the types of things I would reasonably evaluate with my fellow Councilors to potentially help pay for the needed projects to help Camas achieve its vision for a better tomorrow.
- 4) As dedicated as I would be to finding reasonable and common-sense sources of revenue, I would work equally as hard to find ways to legally and reasonably cut city expenses. I would meet with the Financial Director, other City Staff and all Councilors to review our current expenditures and see where the city could legally and reasonably reduce costs or eliminate obsolete programs. But, again, I'm not a Councilor yet, so it is hard to evaluate whether such cuts exist and how they might impact city employees and the level of city services provided to its citizens. So, it would be premature to say what those cuts might be, if any.
- 5) Consider forming a finance/budget committee to liaison and communicate with citizens to better explain the process, why it is important and what the bi-annual budgets contain. I would consider inviting outside financial experts from the community to join this group which would be limited in size and time (such as a 6 month to one year term limit. I've found that people are much more likely to volunteer for something if their term has short and clear start and end dates)
- 6) Consider reaching out to other cities of similar size and learn from them about how they have successfully dealt with similar budget issues. Also, leverage state associations where we could learn from as well like the Association of Washington Cities (policy insight) and the Municipal Research Service Center (legal insight).

Question 4: In your opinion, excluding finances, what are the most significant challenges facing the City of Camas today?

Future growth. Growth is coming and it is a critical part of the Camas of tomorrow. If we do not have a sound strategy for supporting infrastructure (streets, traffic lights, utilities) to accommodate that growth while listening and acting upon the will of the citizens, that is a problem.

Possible solutions: 1) Northshore Sub-Area Plan. Ensure that the locally preferred design has the appropriate infrastructure to support the growth while also protecting the Legacy lands so that Camasonians can enjoy those lands/parks for decades to come. 2) Update to the Downtown Sub-Area Plan. There are many opportunities for smart, sustainable growth there. The Downtown can be home to a lot of affordable housing and mixed-use development and it already has roads and public transportation resources it can rely upon.

Problem - Economic Development. Businesses have left Camas and lowered our tax base. That is a problem.

Possible Solutions: 1) Bringing well-paying, sustainable and diversified jobs to Camas will boost our tax base. I believe the city would be well-served to focus on attracting a diversified commercial and industry base. Business industries fluctuate with economies. Example: Sharp, Sharp labs, UL, HP and Karcher. One solution to long-term economic growth in Camas is to encourage a diversified commercial and industry base so that short-term economic conditions/factors would not devastate a large portion of Camas' tax base. 2) Reduce our dependence on CREDC and other Economic Groups to attract companies to Camas. Camas needs to focus on someone who can recruit FOR Camas. Don't wait for companies to come to us; target specific companies and get on a plane and recruit them (this worked for Texas). Travel to those companies and actively recruit them. Bring them to Camas for tours and visioning workshops. Consider appointing a Staff Director or hire a Business Recruiter (base + commission) working hand in hand with the Marketing Director, Mayor, Administrator and Council.

There are other city buildings in need of work. These are not small projects; these are multi-million dollar projects that will need to occur over years. We need a short and long term plan, proposals for funding, and a plan to get community support for all of these projects.

Public Safety: We need more staff and equipment for our fire and police offers. I am encouraged some positions seem to be present in the last few budget cycles, but it is not nearly enough given the current size of our city and lack of growth in either public safety department to keep up with a growing city.

Growth/Affordable Housing: Growth is mandated by the CMA, and there are appropriate ways to manage how we maintain compliance. I am encouraged by the increased efforts for public engagement as it relates to the North Shore. I would like to see more discussions about diverse housing - such as ADU's and infill development in older neighborhoods that allow it. We need some sort of multi family houses for families that want to live in Camas but cannot afford a house.

Cover Letter

I was born and raised 5 miles west of Camas in East Vancouver. In 1996 I graduated from Mtn. View High School where I was editor of the school newspaper. Every 3 weeks in the wee hours of the morning, I would drive the large square box that held the final draft of what I always believed to be a masterpiece from 164th avenue down Highway 14 to Columbia Litho Printer, (now MinuteMan Press,) to go to press.

After high school and two years at Clark College, I spent 6 years moving around the country working as an insurance agent. I always felt like I was in search of where and what I wanted to be. I did well, and for the most part I enjoyed being a property casualty insurance agent. However, I never felt fulfilled. After I met my husband, we ended up in Portland where we bought a house. Soon after, we had our first child. In 2010, shortly after my son Benny was born, I felt the need to be closer to my roots. That is when we moved to Fishers Landing in East Vancouver.

Years later in 2014, I was a stay-at-home mom getting ready to have our third child. That is when my sister decided to open her bakery on 4th Ave in Camas. It was all hands-on deck, and I would help whenever I could. Eventually, I joined my sister full-time and began helping her run the business. One day, I went to Columbia Litho to get menus printed. I walked in and was instantly transported back to 1995. Pat Guard stood there before me with his twinkly eyes and his jolly smile. I remember my exact words to Pat... "You don't remember me, but I remember you." At that moment, I knew I was exactly where I was meant to be.

In 2016 it became clear my oldest son was on the Autism Spectrum. His second grade teacher advised us that one of the best things we could do for him would be to move to Camas. She thought that he would have more access to services and with smaller class sizes he would be able to get more individualized help from the teachers. This was a move I had already wanted to make. The teacher's advice simply sealed the deal. So, we began looking at houses.

We found a fantastic house near 19th on Franklin. Although it was a little out of our budget, we made it work. I quickly found myself feeling something I had never felt. For the first time in my life, I felt like I was home. I spent years searching for this feeling, and it was right under my nose the whole time.

I spent the next several years managing Cake Happy. The convenience of living a quarter mile from work and the fact that my sister was the owner allowed me to have a flexible schedule and bring my kids to the shop. The community embraced us all and I got to know so many residents and business owners during my time at Cake Happy.

We decided to close the Cake Happy storefront in 2021. I was heartbroken. This community, its residents and local business owners had become such a huge part of my life. I wasn't ready to give that up.

Shortly after our decision to close the storefront, I saw a post, the C-W Chamber had an opening for an administrative position. I immediately emailed Jennifer Senescu, the Director, to let her know I was interested. I couldn't imagine a more perfect fit. I loved being a part of Cake Happy, but it was never mine. I didn't choose it. It chose me. While at Cake Happy, my passion became this town, it's people and the small businesses I spent years collaborating and cultivating relationships with.

2. What experiences, talents or skills would you bring to the Council and community that you would like to highlight?

As a leader in our community, I believe I bring an inherent mix of understanding and wisdom, needed to govern. I would always value the insight and understanding of our citizens and staff in order to make informed decisions based in reality. I have been a manager who leads with my team, and I believe that is the heart of great leadership. I know the value of a team and our team not only involves our officials and staff but also our residents. As with any leadership position, it will not be possible to put everyone's ideas into practice, but it is our responsibility to make decisions we believe to be the in the best interests of our people. 3. Camas, like many Washington cities, is facing a structural deficit, where expenses grow faster than revenues, due to property tax limitation measures. Explain your views on how the City of Camas should address these budgetary difficulties. Specifically, discuss actions you might encourage to balance revenues and expenditures and the impacts of City services.

Creative governing is essential when it comes to bringing the best value for our resources. Understanding "business as usual" will not be good enough going forward is also key. As elected representatives we owe it to our citizens to be exhaustive when it comes to how we spend our resources. That means it may take more research and questions to find the best path forward. If we lean too heavily on visions laid out decades ago, we limit ourselves to what lay in front of us. In the same way we cannot discount the vision, we must be able to glean from all of what we have at our disposal and make it the very best version we can.

The city of Camas, Pre-pandemic was on a track, and successful keeping expenditures lower than revenue. In fact, we were better than we had planned for. As with all of our surrounding communities Covid caused enormous issues when it came to revenue and planning. The world was put on hold, and we needed to keep moving. I believe it is the job of our current leadership to get back on track and take up where we were, previous to 2019. While I know there needs to be some understanding when it comes to the difficulty of our current financial environment, I

also know it's time to roll up the sleeves and do the work needed for our citizens. In the short term it may mean holding off or slowing down big projects, but it is my belief we cannot let the momentum die as we move forward into a prosperous future. I want to see Lacamas lake clean and safe for our citizens and sooner rather than later. It's been far too long in the making. I also want to see the success of the North Shore project. I believe we are on the verge of something great here in Camas I simply believe we need to be diligent guardians and gate keeper in order to not push too quickly causing collapse.

4. In your opinion, excluding finances, what are the most significant challenges facing the City of Camas today? How would you propose to address these challenges?

I believe Lacamas lake is an enormous challenge that must be met with vigor. I live on the east side of the lake, and it is one of the most widely used resources we manage. We need to make these improvements more rapidly and make sure the waste running into our natural resource never happens again. The North Shore project must be a shining example on how to utilize land without endangering our precious natural resources.

We are also replacing some of the most important positions in our city including fire and police chiefs. The dedication shown by the individuals stepping down will be difficult to replace. I am glad we have a current leadership who know the importance of these decisions. In the past we have seen city management positions and others becoming a steppingstone to other positions outside of our community, I believe we must have a better vetting process in order to see these positions remain long-term.


5. What forms of Public Service or Volunteering have you been involved in? Provide details regarding the dates, roles, and responsibilities.

I have consistently felt that the City is moving in the right direction when it comes providing guided growth and services to residents. I have long wanted to serve on city council to help keep the forward momentum moving. I have reached a point in my career where I can consistently provide the time and energy necessary to be a productive member of City Council.
- 2. My career in public service started in 1985 when I began my journey as a volunteer firefighter. A few short years later, I was hired as a career firefighter. I served the citizens of Portland, Oregon for nearly 29 years and retired as the Chief of Emergency Operations. Since 2016, I have served as the Fire Chief at Clark-Cowlitz Fire Rescue (CCFR) in NW Clark/SW Cowlitz Counties. Throughout my journey, I have had numerous experiences and opportunities to learn about local government. As a Chief Officer at Portland Fire & Rescue, I regularly represented the organization to City Council and community groups. Balancing a city budget while managing new city needs, maintenance, and city services is a difficult decision for any group to take on a consistent basis. I see the Camas Strategic Plan as a great tool that council has used as a framework in the budget process. It lets citizens see an outline of planned improvements, while being a living document that is amendable with changes. I specifically see maintenance, where it makes long term financial sense, as a priority. Continued planned investment in core infrastructure is also an important issue to me, as growth in Camas is a main citizen concern.

An action I would encourage, includes increasing partnerships, agreement, and collaborations with other organizations that have similar goals to help spread out the initial costs and then maintenance. This includes non-profits as the park system keeps growing in size and costs. These are some of the most popular areas of our city and many local groups have an interest in

keeping them accessible. I would also take a hard look at the city's online sales tax revenue rate that has been becoming increasingly an important part of where modern Camas is headed. Lacking the big box retail stores within Camas is something that many in the community enjoy but also limits sales tax income that most cities have.

I believe that three major challenges facing the City of Camas today include managing/planning growth, increasing trust and participation of citizens and coming through with a solid plan for a wider variety of housing. As a member of the Camas planning and zoning committee I have seen first hand how important it is to get in front of predictable growth in our city. The subarea planning process has really shown many benefits and lets the community know what is roughly ahead. I believe highlighting the current building restrictions/codes that are important to the community and moving forward with new ideas on how to keep more original landscape would help make inevitable growth more palatable to citizens. Putting bigger signage with more detailed information, at the location being discussed, seems like an economical strategy to continue to get information out to the community and gain participation and feedback. Develop technology to include a scannable code to link to the available information and meetings, and pair this with a link on the front page of the city website on these locations that are featured upcoming topics.

Building trust and participation in the community is a priority to everyone who represents or works for the city of Camas. Having a city booth at more community gatherings will only help in getting information out. First Fridays seem like a great opportunity to have the city involved. I also like, for the home town feel, a community board. This board would announce meetings, changes and post a community schedule. Placed by the library, this would be highly visible to all those in downtown and add to a heritage feel.

A better mix of housing in Camas is something that is overdue and is leading to a lot of growth anxiety from the community. This has shown up in every community survey. Without more options, our longtime residents, city staff, teachers, and first responders are slowly trickling away from Camas. We need to prioritize this to keep the small, town Camas feel. Diversification, is a great way to keep a small community feeling its roots, and goes along way with retaining quality employees. There are many options on how to achieve this, and to be successful several should be explored and implemented. These include incentivizing smaller homes in the permit process, requiring larger developments to include varying sized homes, zoning changes, more mixed use zoning, and less conditional use permits, while adding more outright permitted land uses. Having an annual result check in, with actual permits issued would be the measuring stick on effectiveness.
