Subject: COMMENT ON LEGACY ACQUSITION

In this interesting time of virtual meetings I provide this public comment on the proposal to approve these purchases. I absolutely support their acquisition. Lacamas Lake and our trail system are one of the big reasons I moved here. Nonetheless, I have significant concern, and questions, of the public graphics supporting acquisition.

The slides infer the City of Camas would approve subdivisions as depicted showing substantial coverage of land by residential lot and building. Never mind trees and a watercourse (that somehow disappears beneath the subdivision). This in a city where people wonder if they can fell a dead tree on their property that is threatening a structure. Despite these significant constraints, including sensitive lands draining into a ecologically signifiant lake used for recreation, these subdivisions would be approved as depicted. I would also note that both of these depicted subdivisions depend on road access through undeveloped, and unapproved properties that have yet been subject to a public review process. It is not clear that these properties have confirmed access so support this level of development.

While perhaps I should, I'm not questioning the appraisal. For all I know the value of these properties for a handful of large estates, still closed off to the public, supports the appraisal. I do know depicting the result of a lengthy public development review as a "done deal" is not appropriate. This is especially the case when the properties involved are presently seeking approval of a sub-area plan that would formalize similar significant development on sensitive lands.

Is this depiction a "wink and nod" that the City of Camas presupposes approval of exactly what a developer would submit? The inference is there. I certainly hope this isn't the case.

Before the Council votes on these acquisitions, I request the City Attorney answer the following questions:

- (1) Does the depiction of development, specifically subdivision, in any manner imply or prejudge what the full City review of a development submittal would result in?"
- (2) Does depiction of these potential developments in any manner imply the City of Camas supports and considers approvable further development proposals on adjacent properties within the North Shore sub-area plan still going through a public planning process, let alone development review?
- (3) Do these subdivisions, as depicted, have approved access suitable for this intensity of development? Does this potential road access depend on expenditure of public money?
- (4) Finally, if subdivision of this land was considered feasible and achievable, where do services (water and sewage) come from and does it require expenditure of any public money to make this development possible?

In conclusion, I ask you if a common person looking at those maps, seeing that both rely on road access from the undeveloped North Shore, and seeing these in a City document, would reasonably conclude that decisions on North Shore development have been made? I surely hope this isn't the case. Moreover, it is this type of miscommunication with the public that led to the revolt against the Aquatic Center. Camas wants transparency.

Again I support the acquisition, but believe the justification for them cannot be circumvention of a public planning process. To preserve the sanctity of the City's future planning options, I request these answers in the public record before approval.

Subject: April 6 City Council Meeting-Opposed to purchase of new lands and round-about

I am strongly opposed to the plan to purchase new lands and also opposed to the enormous, unnecessary round-about, especially at this time of uncertainty.

- 1) We are in times of unprecedented crisis, both in health and the economy. This is NOT the time to use precious reserve funds for projects of questionable need.
- 2) Many people have lost their jobs or are in danger of losing their jobs soon.
- 3) Personally, my income has dropped significantly while my property tax has jumped 17%.
- 4) If we use reserve funds at all, they should be spent on necessary items to maintain what we already have: roads, parks, fire and police.
- 5) I am opposed to such significant decisions being done over Zoom. I use Zoom in my current job as I work from home, and its security failures have been well publicized.
- 6) I am strongly opposed to the enormous, complex round-about planned for Lake Road. It reminds me of a 2-lane round-about north of Gig Harbor, where I lived last year. One time I got trapped in the inner circle, and escaped with difficulty. An hour later I went back the same way, and found someone had crashed and traffic was backed up more than a half-mile in all directions. The planned roundabout here will be heavily used by brand-new 16 year old drivers going to CHS. I expect a steady supply of crashes and backups.
- 7) I am also strongly opposed to the City hiring a PR manager. The "pools" debacle last year was at least partially caused by insulation of the mayor and city council from the 90% of Camas Citizens who oppose such waste. A PR manager would simply increase this insulation.

PROCLAMATION OF CIVIL EMERGENCY CITY OF CAMAS, WASHINGTON

Whereas, Camas Municipal Code Section 2.48.020 provides that in the event an emergency occurs which causes or is tending to cause danger or injury to persons or damage to property to such an extent that extraordinary measures must be taken to protect the public health, safety and welfare then the Mayor may proclaim a civil emergency to exist; and

Whereas, in the interest of public safety and welfare, Washington state law under Chapter 38.52 RCW sets forth certain powers exercisable by municipalities in the event of emergencies; and

Whereas, Camas Municipal Code Chapter 8.56 sets forth additional procedures and powers related to Emergency Management; and

Whereas, on February 29, 2020, Governor Jay Inslee declared a state of emergency due to the public health emergency posed by the coronavirus 2019 (hereafter COVID-19); and

Whereas, on March 13, 2020, the Clark County Council announced a state of emergency resolution for Clark County regarding COVID-19. Similar emergency declarations have been issued in Washington, Multnomah, and Clackamas counties in the Portland metropolitan area; and

Whereas, on March 13, 2020, Governor Inslee ordered all K-12 public and private schools in Washington State to close by no later than March 17, 2020 and remained closed through April 24, 2020, further ordering on March 16, 2020 a statewide emergency proclamation to temporarily shut down restaurants, bars and entertainment and recreational facilities and ban all gatherings with over 50 participants, with all gatherings under 50 participants to be prohibited unless previously announced criteria for public health and social distancing are met; and

Whereas, on March 13, 2020, President Donald Trump declared a national emergency in the United States of America related to the COVID-19 outbreak; and

Whereas, as of March 14, 2020, the Washington State Department of Health reported a total of 642 confirmed cases of COVID-19 with 40 resulting deaths. As of March 14, 2020, at least 3 confirmed cases of COVID-19 have been reported in Clark County; and

Whereas, as reported by the Washington State Department of Health:

Public health experts agree that the true number of people who have been infected with COVID-19 in Washington greatly exceeds the number of COVID-19 infections that have been laboratory-confirmed. It is very difficult to know exactly how many people in Washington have been infected to date since most people with COVID-19 experience mild illness and the ability to get tested is still not widely available; and

Whereas, as Mayor of the City of Camas I have determined that it is necessary to proclaim the existence of a civil emergency and to take such actions as may be required to effectively utilize city resources in the protection of the public health, safety and welfare;

NOW, THEREFORE I, Barry McDonnell, Mayor of the City of Camas, Proclaim as follows:

- 1. I declare there is a civil emergency caused by COVID-19 in the City of Camas.
- 2. The civil emergency requires the implementation of those powers delineated in Chapter 2. 48 and 8.56 of the Camas Municipal Code and Chapter 38.52 RCW.
- 3. To the extent of such powers as granted by law, the City may enter into contracts and incur obligations, and take any other appropriate action necessary to address and respond to the emergency to protect the health and safety of persons and properties and to provide emergency assistance to persons affected by this emergency.
- 4. These powers will be exercised in light of the exigencies of the situation without regard to the formalities prescribed by State statutes and rules, or by City ordinance (except for mandatory constitutional requirements). These include but are not limited to budget law limitations, requirements for competitive bidding, publication of notices related to the performance of public work, entering into contracts, incurring of obligations, employment of temporary workers, rental of equipment, purchase of supplies and equipment, and the appropriation and expenditure of funds.
- 5. I delegate to the Department heads and their designees the authority to solicit quotes and estimates for contracts necessary to combat the emergency. Department heads may enter into contracts in an amount not to exceed Twenty-Five Thousand Dollars (\$25,000). Contracts over this amount will be signed by the Mayor.
- 6. Department heads are further authorized to reassign staff from their ordinary duties to work deemed necessary to address the emergency outside their normal job duties and to require work beyond normal working hours in the performance of duties deemed necessary to respond to the emergency.
- 7. Pursuant to Camas Municipal Code sections 2.48.020 and 8.56.080 a copy of this Proclamation shall be filed with the City Clerk, a copy delivered to the Director of Emergency Management, State Emergency Management, and the Governor and the news media within the City shall be advised, with copies of this Proclamation posted at public places as may heretofore be designated.
- 8. This Proclamation will take effect upon my signature and will remain in effect until modified or terminated pursuant to Camas Municipal Code Section 2.48.040.

SUPPLEMENT TO PROCLAMATION OF CIVIL EMERGENCY ISSUED MARCH 18, 2020 CITY OF CAMAS, WASHINGTON

The recitals as set forth in the Proclamation of Civil Emergency, City of Camas, Washington issued March 18, 2020 are hereby adopted by reference.

For and as supplement to said Proclamation, as Mayor of the City of Camas, do Proclaim as follows:

- 1. The City hereby implements a moratorium on the hiring of new employees with exceptions to be granted on a case-by-case basis by the Mayor.
- 2. City employee accrual of overtime shall be limited to emergency and unavoidable circumstances.
- 3. The City hereby implements a moratorium on the hiring of any seasonal staff with exceptions to be granted by the Mayor.
- 4. No employee or elected official business travel, conference attendance, or training shall be occur except as required by law, with limited exceptions as may be otherwise approved in advance.
- 5. All City departments shall maintain their ongoing strict adherence to established budgets.
- 6. City capital projects deemed non-essential will be placed on hold.

This Supplement to Proclamation of Civil Emergency shall take effect upon my signature and will remain in effect until modified or terminated pursuant to Camas Municipal Code 2.48.040.

RESOLUTION NO. 20-004

A RESOLUTION confirming the adoption of the 'Support Local and Save' program.

WHEREAS, Governor Jay Inslee in Amending Proclamation 20-23.1, strongly encouraged all utilities to take reasonable actions to mitigate the economic impacts of the COVID-19 pandemic on their utility customers caused by this crisis, including but not limited to: acting to prevent disconnection of services due to non-payment during the term of the state-wide emergency declaration; waiving late payments and fees; and using payment plans to fulfill customer outstanding balances. Governor further "strongly encourage municipal and public utility boards and commissions to delegate authority to senior utility executives to take any and all actions necessary or appropriate to mitigate the economic impacts to their utility customers to address the COVID-19 crisis"; and

WHERAS, the Attorney General of Washington on March 17, 2020 provided guidance on "Analyzing Issues Related to Gifts of Public Funds During the COVID-19 Pandemic". In this analysis, the Attorney General noted "protecting public health is without question a fundamental purpose of government" as well as the "promotion of the public welfare" provides a "strong basis for state and local governments to make expenditures for the primary purpose of protecting and promoting public health which may have an incidental benefit on private citizens and entities."

WHEREAS, RCW 35.92.020(5) authorizes cities to provide assistance to aid low-income persons in connection with services provided under RCW 35.92 and RCW 35.67.020(5) and Article 8 Section 7 of the state constitution permits "gifts" of public funds in support of "poor or infirm"; and

WHEREAS, disruptions to workers and small businesses are serious, as small businesses are the backbone of our economy, and provide the foundation of employment, services for the community, and revenue in order for cities and other public agencies to continue to provide essential services for the public welfare and benefit; and

WHEREAS, citizens are required to practice social distancing, which is a benefit to public health, but could present a detriment to ongoing business operations with the decrease in customer numbers; and

WHEREAS, state agencies and partners are working to swiftly respond to the economic impact that the COVID-19 pandemic is having on Washington State; and

WHEREAS, small business plays a vital role in the overall health and welfare of Camas' citizens; and

WHEREAS, resources are necessary to help small businesses survive and certain small businesses reasonably require public aid in order to survive; and

WHEREAS, incentives to Camas residents to support local small businesses will generate higher sales tax receipts to the City; and

WHEREAS, the Camas City Council recognizes that one of its essential functions is to promote public health by mitigating the economic impacts of the COVID-19 pandemic on their utility customers and the City Council has the authority to designate General Fund resources including sales tax toward such functions; and

WHEREAS, on April 10, 2020 the Mayor announced the adoption by the City Finance Department of a program known as 'Support Local and Save' relating to certain utility billing reductions as incentives for Camas residents to frequent local business;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CAMAS AS FOLLOWS:

Ι

The Camas City Council hereby confirms the adoption of the "Support Local and Save" program which encourages residents to shop and dine in local small businesses in the City pursuant to the terms as set forth within the attached Exhibit A.

II

The City Council shall at a future date within this fiscal year appropriate an increase in sales tax to fund utility billing discounts occasioned by the 'Support Local and Save' program

The 'Support Local and Save' program as adopted shall be in effect through the term of the Emergency Proclamation issued by the Mayor dated March 18, 2020.

Save receipts and get up to \$75 off your utility bill!



The new program, which begins April 11, is based on the City of Newberg, Oregon's Support Local Challenge. Here's how it works:

- Residents are encouraged to make shoppig and dining purchases from Camas merchants in the downtown area and throughout the city.
- Eligible purchases include gift cards, food, goods and services.
- Residents save their receipts showing the business name, date, and amount of purchase.
- Residents may submit to City of Camas a total of \$125 in receipts for a total savings of \$75.
- When they have a total of \$25 in receipts (this could be one receipt or multiple), they are eligible to receive \$15 off their utility bill.
- Residents can then email a scan or photo of the receipts to finance@cityofcamas.us, mail them to City of Camas Finance Department, 616 NE 4th Ave, Camas WA 98607, or drop them in the City Hall drop box.
- All receipts must be accompanied by the name on the utility account, account number, address and contact phone or email.
- Support Local & Save will begin on Sat., April 11, and run through May 4, the current end date of Governor Inslee's Stay Home, Stay Healthy proclamation; the City will reassess the program's duration as the COVID-19 situation evolves.
