MEETING SUMMARY

Welcome, Agenda Overview and Purpose

Steve Lorenz opened the meeting with a welcome and roll call. He reviewed the retreat purpose and agenda, stating that the meeting focus would be to:

- Establish an updated Parks and Recreation vision and mission statement.
- Review and discuss draft goals for the PROS Plan as informed by the community.
- Review and discuss a decision-making framework and process for making recommendations to staff on future policies and priorities.

Steve introduced Jeanne Lawson as one of the retreat facilitators. Jeanne introduced herself, Darren Cools and Adrienne DeDona with JLA Public Involvement. She then reviewed the meeting guidelines and tips for virtual meetings.

Adrienne asked the Commission and Council liaisons to introduce themselves and state why they joined the Commission and what they felt was the Commission's greatest accomplishment over the past couple of years. The following summarizes what was shared:

- Cassi Marshall joined the Commission because she feels like the parks are one of the
 best amenities in Camas. What's special about them is they are free of cost to the public
 and are beautiful. Cassi felt like the acquisition of legacy lands, though led by staff, was
 one of the greatest accomplishments. Also, broadening the scope of the program
 beyond just physical parks to include volunteerism, trails and other assets.
- Steve Lorenz has been on the Commission for about 20 years. He agreed that the
 legacy lands acquisition was the greatest accomplishment, noting that there is limited
 space in Camas proper. He said the legacy lands acquisition would provide park and
 open space for future generations. Steve added that he agreed the broader scope for

- the program as an accomplishment and noted that the addition of Lacamas Lodge was an asset.
- Brittany Grahn is newer to the Commission and has three young children. She's
 invested in the community and has been impressed with Cassi's work with the ivy
 league.
- David Dewey loves Camas. He feels the beautiful, natural open space makes Camas unique. David believes this should be preserved and maximized for the utility of the region. David added that the legacy lands acquisition was a great accomplishment, including the Green Mountain transaction. He noted that one of the other great accomplishments was that the Commission is very in-tune with and representative of the community.
- Jason Irving joined the Commission because it's important for him to get outdoors.
 Plus, it provides a good outlet for his professional work. He felt like the cohesion of the Commission as a group was their greatest accomplishment.
- Katy Daane felt that community involvement was important and she agrees that the Commission is connected with the community and respects their desires and needs through the improvement and growth of public spaces.
- Shannon Roberts agreed that the legacy lands acquisition was the greatest accomplishment, including the addition of Lacamas Lodge. She feels the parks are important to provide space for the community to relax, unwind and relieve stress.
- Ellen Burton felt the Commission's civility, alignment and focus was their greatest accomplishment.



Affirm Mission Statement

Adrienne provided some background and context for the purpose and definition of a mission and vision statement. She also shared the Commission's feedback from a pre-retreat survey about their mission statement. Adrienne then shared a draft mission statement developed by parks staff and the facilitators based upon the Commission's survey feedback. The following statement reflects the Commission's discussion and input at the retreat related to the draft mission statement (red denotes revisions):

Camas Parks and Recreation promotes a healthy and sustainable community by
listening and responding to the community's needs and desires, through protecting and
preserving its natural spaces, strengthening its to strengthen ecological health, and
developing and maintaining parks, trails and recreation programs that are welcoming for
all.

Establish Vision Statement

Adrienne reviewed community input from the PROS Plan outreach related to community values and revisited the PROS Plan Goal Themes established based on this input. She also shared an illustration based on the key take-aways from the Commission's input in the pre-retreat survey about their vision statement.


Adrienne shared two draft vision statement options developed by staff and the facilitators based upon the Commission's feedback in the pre-retreat survey. She instructed the Commission to work in two small groups to discuss and finesse the vision statement options. They could either start from scratch and create a new vision statement or refine one of the options given to them. The following reflects the Commission's discussion and input related to the vision statement (red denotes revisions):

 We envision Camas is as an energetic a thriving, cohesive community that honors enjoys a unique legacy of coordinated parks, trails, natural areas and diverse recreation opportunities highlighted complemented by our lakes, rivers and streams. Stewardship and thoughtful enhancement of these assets ensure a safe, healthy, active and balanced lifestyle for all.

Review and Discuss PROS Plan Goals

Steve Duh presented the PROS Plan Goal framework, functional areas and goal themes. He

shared some of the feedback provided by the Commission through the pre-retreat survey and how staff will be incorporating that feedback into the action items within the Goals framework. Steve also shared the PROS Plan map that will be used to illustrate the extent of the existing parks system, how the system is distributed to



show accessibility to nearby residents and where gaps may be in order to target future investments.

Steve explained that some of the feedback received by the Commission in the pre-retreat survey indicated a need for a focus on equity. Steve explained that the Goal Theme "welcoming for all" was intended to capture a broad focus on equity from a systematic approach. The focus includes equitable distribution of recreation opportunities, removal of physical access barriers, providing for ADA & universal accessibility, providing for all ages – all abilities – all incomes, increasing signage & communications in other languages, considering needs of all cultures, etc.

Steve asked the group if they had any questions or comments. The following summarizes the feedback and comments:

- The PROS Plan map should consider topography as it relates to access. For example, some steep slopes may make nearby facilities inaccessible to some.
- Are operations and maintenance costs included in the Capital Facilities Plan? Would like to make sure that long-term maintenance costs are associated with the budget process.

Trang reviewed next steps and indicated that staff would come back to the Commission with the draft PROS Plan for review and recommendation prior to adoption by the Council. The Commission would have additional opportunities to provide feedback on the Goals and Actions at that time.

Decision-Making as a Unit

Jeanne introduced the purpose and intended outcome for establishing a decision-framework. Trang reviewed three illustrative decision-making examples based on the three functional areas identified in the PROS Plan Goal matrix (administrative, project and program, and policy). Trang outlined the process, steps involved and points where the Commission would weigh-in and offer guidance and recommendations for these examples.

Commissioners indicated their appreciation for the overview and context. Their questions focused on the commission's role and responsibilities related to creating policies. Trang mentioned small group work could be used outside of regular commission meetings and/or working with a task force from the commission on specific efforts. Another question was brought up about advocacy and education of these efforts, and Trang supported Commissioners serving in an advocacy role if interested, such as using technology to disperse information or attending community meetings or presentations to share information and collect feedback.

Next Steps and Close

Adrienne reviewed the illustrations of the discussion from the retreat to recap the meeting, then asked the Commissioners to reflect on what they felt was most memorable or inspiring about the retreat. The following summarizes their feedback:

- Jason Irving The decision process Trang shared about how the Commission is involved in decision-making. It would have been helpful to see when first came on the Commission to understand my role and how I fit in. It will be beneficial to new Commissioners when they come on.
- Cassi Marshall Agreed with Jason and thanked Trang for bringing her expertise to the process. We are going to be much more impactful and effective moving forward

because of this decision process. What was most memorable from the meeting is the group, staff and Commission. There is a lot of heart and passion from the group for Parks and the community. We need the process to get anything done and it's a combination of process and heart.

- David The framework is key and it's helpful in understanding how we fit in and how we
 are going to work together to get things done. What's most memorable is the discussion
 and the different perspectives we bring to the table, though we are all pulling together in
 the same direction to get things done.
- Brittany The most memorable piece was during the visions statement breakout discussion. We didn't finish our vision statement, but we said we hoped the other group did because there was no doubt that we all share the same vision. We all want the same thing for the community. Thanked Trang for her expertise and what she brings to the table.
- Katy The most memorable moment was listening to all the collective input from the Commission. It's inspiring to get to listen to the inputs, ideas and thoughts from others. It brings it all together for her to form a full understanding.
- Steve Having Trang is a great addition. Her expertise can't be overstated. He
 thanked the facilitators. Steve felt the great effectiveness of the group was most
 memorable and how much they care about the community. He echoed the statements
 about the diverse backgrounds of the Commission, yet they come together as a group
 to make things better. Steve added that having a format and a matrix to hang ideas on
 from the Commission will help them get stuff done.

Steve indicated that staff would further refine the mission and vision statement as next steps to bring back the Commission for approval as well as further flesh out the PROS Plan.

Jason and Steve thanked the group for their time and participation and closed the meeting.
