Jim Golden, 1475 Woodland Drive, thanked the Council for their support of OPED. He said 2 restaurants are currently looking at Camden as a possible location and a short line railroad in the old International Paper has applied for an infrastructure grant.

Bishop Arnold, 518 Sharp, stated that there is a serious problem with young people and there needs to be a curfew. If there is a curfew, it needs to be better enforced.

Callie Hughey, 257 Madison, admonished the Mayor over the quality of seating in the Council Chambers, and the length of public notice for special meetings.

Sharon Akins, 345 Dallas, stated that her streetlight has been out since May and she would like it to be fixed. Also, when trees were knocked down by a storm, they were only cut up enough to clear the street and stacked to the side leaving only a trail to get down the street.

H. MAYOR'S REPORT

Mayor Young announced the October Employee of the Month, Henry L. Davis, a driver from Sanitation Collections, and the November Employee of the Month, Dana Peterson, Public Relations with the Police Department. Mayor Young also announced that the Attorney General's office had called and Cortney Parker will be named Ouachita County's Officer of the Year.

Mayor Young reminded everyone that there will be a budget workshop on Tuesday, November 28 at 6:00 p.m.

Kyle Gatling, Jason Fletcher and James Green presented updates and improvements at the airport. Business is increasing, and fuel sales account for approximately 54% of the airport revenue.

Discussion started with unauthorized withdrawals, went on to changes in Human Resources and the timekeeping system. Attorney Frey stated that the findings are the only items that must be discussed in the meeting, not the supplementals. Discussion continued with compensated absences.

Mayor Young reminded everyone of the budget meeting and asked everyone to sign a Christmas card. Bundles are being sent to our National Guard Unit who have been deployed and won't be home for Christmas.

Alderman Askew requested clarification on the lease agreement at Fairview Park. Attorney Frey stated that OCRC has a 30-year lease on the big field and a non-compete for baseball, ages 13 and up. He also said that the city still needs to request proposals from organizations to run the 12 and under program.

ORDINANCE NO. 12-23

AN ORDINANCE REPEALING ORDINANCE NO. 30-16 ASSESSING A LIEN ON CERTAIN PROPERTY LOCATED AT 2289 South Adams ST.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT ORDINANCE NO. 30-16 PASSED AND APPROVED ON Sept 13, 2016, IS HEREBY REPEALED IN ITS ENTIRETY AND THE FOLLOWING SUBSTITUTED THEREFOR:

WHEREAS, the City declared the structure located at 2289 South Adams St. Camden, Arkansas, Parcel No. 855-00004-000R, to be a nuisance to the provisions of Section 6-61, et, seq., Resolution No. 41-06; and

WHEREAS, the owner of the property failed to remove the structure as required by law and the City performed the removal of the structure.

WHEREAS, notice has been given to the property owner that a hearing will be held on Tuesday, November 14, 2023 at 7:00 p.m. to determine the status of the lien assessed to the property as required by law.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1: The net costs performed on the removal of the structure located at 2289 South Adams St, Camden, Arkansas, being located on said property, has been determined at a hearing before the City Council of the City of Camden to be the sum of \$476.90.

SECTION 2: The property concerned herewith, located at 2289 South Adams, is in the name of Travis Bradford. Mr. Bradford is offering \$95.38 to satisfy the lien. The City hereby sets a lien in the amount of \$95.38 to the property concerned herewith.

SECTION 3: That a certified copy of this Ordinance shall be transmitted to the Tax Collector of Ouachita County Arkansas, with the direction to place the above cost of removal and penalty on the tax books for the property described herein as delinquent taxes and collect the same according to law, with the amount so collected, less 3% thereof to be retained by the Collector for their costs, to be paid directly to the municipality as provided by law.

SECTION 4: BE IT FURTHER ORDAINED THAT this Ordinance shall take effect upon its passage and approval.

ORDINANCE NO. 15-23

AN ORDINANCE PROVIDING FOR THE ACCOUNTING OF THE PUBLIC SAFETY SALES AND USE TAX; AND FOR OTHER PURPOSES

WHEREAS, Ordinance Number 23-07 levied a three-fourths percent (3/4%) sales and use tax for public safety purposes within the City of Camden; and

WHEREAS, 42.5% of the revenues are currently being placed into line item 41304, "public safety fire sales tax" for the portion used to supplement fire department salaries; and

WHEREAS, 49.5% of the revenues are currently being placed into line item 41305, "public safety police sales tax" for the portion used to supplement police department salaries; and

WHEREAS, 8% of the revenues are currently being placed into line item 41306, "public safety capital outlay" for the portion used to supplement capital outlay purchases; and

WHEREAS, the City desires to specify additional accounting procedures for the public safety sales and use tax.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1. There shall be created a new operating fund identified as "Operating Fund Number 13, Public Safety Tax".

SECTION 2. All revenues received from the public safety sales tax shall be deposited into the newly created operating fund number 13.

SECTION 3. 42.5% of the funds in operating number 13 shall be transferred into the general operating fund, line item 41304, "public safety fire sales tax", to supplement fire department salaries.

SECTION 4. 49.5% of the funds in operating number 13 shall be transferred into the general operating fund, line item 41305, "public safety police sales tax", to supplement police department salaries.

SECTION 5. 8% of the funds in operating number 13 shall be transferred into the general operating funds, line item 41306, "public safety capital outlay", to supplement the purchase of capital equipment.

RESOLUTION NO. 71-23

A RESOLUTION PROVIDING FOR AND ADOPTING FOR THE CITY OF CAMDEN, ARKANSAS, AN ANNUAL OPERATING BUDGET FOR THE TWELVE MONTHS BEGINNING JANUARY 1, 2024, AND ENDING DECEMBER 31, 2024; APPROPRIATING MONEY FOR EACH AND EVERY ITEM OF EXPENDITURE THEREIN PROVIDED FOR; AND FOR OTHER PURPOSES.

WHEREAS, the City Council of the City of Camden has made a comprehensive study and review of the proposed Fiscal Year 2024 Operating Budget; and

WHEREAS, it is the opinion of the City Council that the schedules and exhibits of financial information prepared and reviewed revealing anticipated revenues and expenditures for all funds for the Fiscal Year 2024, including the various pay rate modifications, appear to be as accurate as possible for budgetary purposes.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1. This Resolution shall be known as the Budget Resolution for the City of Camden, Arkansas, for the twelve-month period beginning January 1, 2024, and ending December 31, 2024, reflecting estimated revenues and expenditures for all funds as set forth in the Fiscal Year 2024 Operating Budget Document, including the various pay rate modifications, for the City of Camden. Said Official Budget Document is hereby made an attachment to this Resolution and is incorporated herein as if fully set forth.

SECTION 2. This budget may be altered or revised by action of this governing body and unpledged funds may be subsequently appropriated to another purpose, except as prohibited by law.

SECTION 3. The Mayor or his duly authorized representative may approve for payment, out of funds appropriated by this budget or otherwise approved by the City Council for those purposes, or may disapprove any bills, debts, or liabilities asserted as claims against the City, up to a maximum amount allowed by Arkansas law and Ordinance 07-23 and the payment or disapproval of any bills, debts or liabilities exceeding that amount shall require the confirmation of this governing body.

SECTION 5. If any provision of this resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the resolution which can be given effect without the invalid provision or application, and to this end the provisions of this resolution are declared to be severable.

RESOLUTION NO. 72-23

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, AMENDING THE 2023 ANNUAL OPERATING BUDGET AND AUTHORIZING THE MAYOR TO PAY AN END-OF-YEAR BONUS TO EMPLOYEES AND ELECTED OFFICIALS.

WHEREAS, line item 01-14159420 of the 2023 operating budget included \$300,000.00 for capital outlay (buildings/pool); and

WHEREAS, the construction of improvements for the buildings at the pool did not occur in 2023; and

WHEREAS, the City Council desires to amend the budget by moving \$125,000.00 to reserves to pay for end of year bonuses; and

WHEREAS, Arkansas State Statue §14-42-120 allows for cities to pay its employees a monetary incentive at the discretion of the governing body; and

WHEREAS, the City Council, the official governing body of the City of Camden, wishes to show its appreciation for the hard work and dedication of the employees and elected officials of the City; and

WHEREAS, all full-time employees and elected officials should receive a bonus of \$900.00, and all part-time employees should receive a bonus of \$450.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1. The 2023 annual operating budget is hereby amended by decreasing line item 01-141-59420 by One-Hundred and Twenty-Five Thousand Dollars (\$125,000.00).

SECTION 2. The City Council hereby authorizes the Mayor to pay all full-time employees and elected officials a bonus of \$900.00 and all part-time employees a bonus of \$450.00.

SECTION 3. Payments will be prorated for recent hires, who will receive 100% if hired in the first quarter of 2023; 75% if hired in the second quarter of 2023; 50% if hired in the third quarter of 2023; and 25% if hired in the fourth quarter 2023.

<u>SECTION 4</u>. Full-time District Court employees that are paid half by the City and half by the County shall receive a bonus of \$450.00. Part-time District Court employees that are paid half by the City and half by the County shall receive a bonus of \$225.00.

<u>SECTION 5</u>. The bonus payments shall be subject to Medicare, Social Security, LOPFI and other mandatory withholdings.
