#### G. AUDIENCE PARTICIPATION

James Johnson, 416 Madison, thanked the fire department for their help during a health scare. Specifically recognizing Captain Kyle Rogers, Lieutenant Jason Wright and Assistant Chief Jarod Purifoy.

Bryan Smith, 223 North Street, complained about the landfill being closed during inclement weather.

Mike Sherman, 240 Adams, asked that the Sportsplex contract be renewed.

Anita McElfresh, 2810 Hawthorne, claimed she was assaulted by the police and said she had video proof.

Julian Lott, 412 Arkansas, called for a forensic audit.

Superintendent Roy Wesley, 205 Harding, called for more transparency on crime, and suggeted recognizing "Buckshot" Smith by naming a street after him.

Randy Sanders, 2810 Cherokee, stated that 4 way stops on Cherokee is a bad idea, if there were more police in the area, there would be less speeding.

#### H. MAYOR'S REPORT

Mayor Young introduced Jake Plyler and Blake Rogers with TRM&P CPA firm. They were there to answer questions about their proposal to take over the finances for the City. The cost will be \$5,250 a month plus time and travel if they have to attend a council meeting. They invited the Council to email them any questions they may have. Alderman Moore asked if they could do a forensic audit and was told that a full audit will be very expensive and TRM&P can not do it if they are working for the city.

Mayor Young announced that Legislative will be here August 26th.

The Mayor thanked David Richardson and Camden Water Utilities for their help at the transfer station, they saved the city quite a bit of money. The scales are in place the the landfill and all scale-hoiuse employees have been trained on doing tickets.

The Mayor, Police Chief and Assistant Chief met with the Housing Authority. Extra patrols through the complexes will begin soon. Three new officers have completed ALETA and are at work.

The Mayor announced that Commodity Distribution will be Wednesday and Thursday from 9:00 a.m. until 2:00 p.m.

Sections 1001 to 1008, 1010, and 1012) and in accordance with Section 102(2) of the National Environmental Policy Act of 1969, Public Law 91-190, as amended (42 U.S.C. 4321 et seq.).

#### **Purpose and Need for Action**


The proposed action's purpose is to reduce flood damage through the year 2076 in the city of Camden within the North Bayou-Two Bayou Watershed. Flooding of homes, businesses, roads, and cropland is a chronic issue in the planning area. The greatest need for flood damage reduction is in developed areas near large streams and rivers that suffer from flooding associated with both heavy local rainfall and backwater flooding. Municipal stormwater failures are due to insufficient stormwater carrying capacity, and backwater flooding is an unfortunate reality for communities situated on the banks of or near major rivers.


#### **Description of the Preferred Alternative**

Alternative C reduces the 100-year flood depth by up to 6 feet in the study area. It provides the third best benefit-cost ratio among the five alternatives developed to mitigate 100-year flood events. It reduces flooding for 209 structures in Camden, directly serving 267 people in the area, with an average Social Vulnerability Index of 0.64. Educating the public about flood impacts, mitigation, and preparedness is a nonstructural component of the preferred alternative.

#### Watershed Plan – EA Summary

The purpose of the proposed action is to provide flood damage reduction through the year 2076 in the city of Camden within the North Bayou-Two Bayou Watershed. The proposed action (Preferred Alternative) involves construction, dredging, widening, and extending channels, ditches, and swales, and the construction of two detention ponds. #### **ORDINANCE NO. 09-24**

#### AN ORDINANCE AMENDING SECTION 6, <u>BUILDING AND BUILDING REGULATIONS</u>, ARTICILE II, PLUMBING OF THE CITY OF CAMDEN, ARKANSAS, CODE OF ORDINANCES, ADOPTING BY REFERENCE THE 2018 ARKANSAS PLUMBING CODE AND THE 2018 ARKANSAS FUEL GAS CODE AND FOR OTHER PURPOSES

- WHEREAS, The City of Camden, Arkansas desires to adopt by reference the 2018 Edition of the Arkansas Plumbing Code with 2018 Revisions Appendixes B, C, D, E and F; and, the 2018 Edition of the Arkansas Fuel Gas Code with 2018 Appendixes A, B, C and D and, all subsequence editions as adopted by the State of Arkansas and,
- WHEREAS, The City has complied with Arkansas Code Ann. §§14-55-207 by publishing a notice of intent to adopt these technical codes by reference in a paper of general circulation within the municipality and three (3) copies of Codes have been available for inspection in the City Clerk's Office for the public prior to their adoption; and,
- WHEREAS, The Arkansas State Board of Health recently adopted the 2018 Arkansas Plumbing Code and the Arkansas Fuel Gas Code for the purpose of setting forth minimum uniform standards to be followed by the Arkansas Plumbing Industry; and WHEREAS, it is necessary, proper and in the best interest of the City of Camden, Arkansas to adopt an updated the City of Camden's Plumbing and Fuel Gas Code that is consistent with State Codes.

## NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

**SECTION 1.** Section 6-16 Plumbing Code Adopted; shall be amended to read as follows:

#### Section 6-16 Plumbing Code Adopted

There is hereby adopted by the City of Camden, Arkansas, for the purpose of establishing rules, regulations and specifications for the construction, installation and inspection of plumbing and drainage, including permits and penalties, that certain code known as the Arkansas Plumbing Code, 2018 Edition, Appendixes B,C,D, E and F, promulgated by the Arkansas State Board of Health, and that certain code known as the Arkansas Fuel Gas Code, 2018 Edition, Appendixes A,B,C, and D promulgated by the Arkansas State Board of Health, as well as subsequent editions as adopted by the State, herein together shall be known and referred to as the "Plumbing Code", save and except such portions as are hereafter deleted, modified or amended, of which no less than three (3) copies have been and are now filed in the office of the city clerk; and the same is hereby adopted and incorporated as fully as if set out at length herein.

SECTION 2. Section 6-18.1 Street Openings shall be added and read as follows:

Any Person, Firm, or corporation making excavation on or in a city street, alley, or right-of-way to install, repair, or replace plumbing, shall be incompliance with <u>SECTION 19 STREETS AND</u> <u>SIDEWALKS ARTICLE III EXIVATIONS</u>, of the City of Camden, Arkansas Code of Ordinances.

#### **SECTION 3.** Section 6-19 **Permits and Inspection Fees** Shall be amended to read as follows:

#### Section 6-19 Permits and Fees:

The following fees and changes shall be made and collected by the City Clerk or Clerks Designee before a permit shall be issued by the Code Enforcement Office pursuant to this article:

(1) The minimum charge for any plumbing permit for new work or remodeling shall be:

a.	Plumbing Permit (Not required if Building Permit has been issued) \$25.00
b.	Gas inspection, Pressure test\$15.00
с.	Sewer connections (New or Replaced) \$20.00
d.	Plumbing inspection, per fixture \$5.00
e.	Water heater new or replaced\$15.00.
f.	Water service inspection (New or Replaced) \$20.00
g.	RPZ installation inspection\$20.00

Plumbing re-inspection fees shall constitute an additional inspection fee set equal to amounts listed above.

The mayor is authorized to charge for plumbing inspections performed outside of the corporate limits of Camden at a rate not to exceed two (2) times the schedule of rates outlined above.

No permit shall have any force or effect unless it has attached to it a receipt or statement from the City Clerk's office showing the payment of any or all fees required by this section.

Further, should any plumbing work be commenced prior to the issuance of a permit, therefore, an additional fee of Fifty dollars (\$50.00) may be assessed and imposed as an additional permit and inspection fee.

No permit shall be issued so long as the applicant owes the city any permit and inspection fees for any current or prior work commenced or performed.

**<u>SECTION 4.</u>** 6-20 **Building Official to act as Plumbing Inspector; Delegation of powers and duties** shall be amended to read as follows:

## Section 6-20 Code Enforcement Officer to act as Plumbing Inspector: Delegation of powers and duties:

The Code Enforcement Officer and his or her delegates shall obtain a State of Arkansas Plumbers Inspectors Licenses and shall act as the plumbing inspector for the city of Camden, Arkansas and the duties and functions may be delegated and performed by authorized representatives of the Code Official and under his control and supervision. Section 5. Section 6-20.1 shall be added and shall read as follows:

6-20.1 Request an emergency disconnect due to an immediate hazard:

The Code Enforcement Officer is hereby authorized to request the Water Department to discontinue or cause to be disconnected all water service or services to any and all premises, lands, buildings or structures where it is fond that an immediate hazard exists to the purity or potability of the City water supply due to non-compliance with the Plumbing Code and to require the immediate correction of the non-conforming condition prior to restoration of services.

## **ORDINANCE NO. 11-24**

### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, AUTHORIZING THE ASSIGNMENT OF CERTAIN DUTIES TO A PRIVATE ACCOUNTANT; AND FOR OTHER PURPOSES

**WHEREAS**, Arkansas Code Annotated § 14-43-405 provides that a city of the first class may allow one person to assume the duties of city clerk and city treasurer as a clerk treasurer; and

**WHEREAS**, the City of Camden, in Ordinance 12-10, divided the duties of the city clerk and city treasurer and created an elected city clerk and an appointed city treasurer; and

**WHEREAS**, Ordinance Number 6-19 provides that the position of city treasurer shall be recommended by the Mayor and approved by the City Council; and

WHEREAS, Resolution 14-24 temporarily assigned the duties of city treasurer to the city clerk; and

**WHEREAS**, Arkansas Code Annotated § 14-59-115 provides that the governing body of a municipality may assign or contract with a private, qualified person or entity to perform certain duties; and

**WHEREAS**, the City of Camden, desires to authorize the employment of private, qualified individuals or entities to perform certain duties.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS:

**<u>SECTION 1</u>**: There is hereby created a new position of "Outside Accountant" within the finance administration department.

**SECTION 2:** A private, qualified individual or entity may be retained to perform any of the following duties:

Monthly reconciliation of city bank accounts; Processing payroll; Calculating and submitting payroll tax deposits; Preparing required payroll reports; (941's, W-2's, etc); Preparing other monthly submissions (APERS, LOPFI, municipal league); Prepare monthly sales and use tax returns and monthly city/county sales tax allocation; Preparing other monthly/quarterly/annual reports; Answering calls from administration and staff on routine business issues; Preparing and reviewing monthly financial statements. Provide annual audit assistance; Provide budget preparation; Provide FOIA request response; Attend council meetings.

**<u>SECTION 3</u>**: The Outside Accountant shall be approved by the City Council after soliciting proposals from qualified individuals and entities.

**SECTION 4:** The Outside Accountant shall assist and coordinate with the city treasurer for any duties it is contracted.

**SECTION 5:** The cost of the Outside Accountant shall be paid from a newly created line item 01-030-52500.
