Alderman Askew inquired if our drivers were causing the problems. Mr. Newton said it was probably 50/50 driver and vehicle.

Alderman McDonald stated that he had sent an email to come see the trucks but he had not received a reply. Public Works Director Kevin Franklin told him he is welcome anytime.

Alderman Aregood asked Mr. Newton how his new program was working. Mr. Newton said it's very good and the mechanics are using it. He's now starting teaching the Administrative Assistant for Public Works how to use it.

Alderman Askew thanked all the sanitation workers for their extra work while the trucks were down.

D. NEW BUSINESS

 RESOLUTION NO. 60-22, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, CREATING A YOUTH SPORTS EXPLORATORY COMMITTEE; AND FOR OTHER PURPOSES.

The Mayor introduced the Resolution and the City Clerk read the number and title. Alderman Askew made a motion to approve the resolution, seconded by Alderman Aregood. Alderman Aregood started the discussion by stating that he doesn't think John Dawson is ready to let go of the Recreation Complex. Alderman Lindsey said there are other things that were much more deserving of a special meeting than forming an exploratory committee and suggested delaying the Resolution until the election is over and we know if there's going to BE an Advertising & Promotion Commission. Alderman Askew stated that he grew up at the Boys Club, raised his kids at the Boys & Girls Club. It's not the Boys & Girls Club anymore. The City can't use our own fields when the Ouachita County Recreation Complex has games and that's not right. Mayor Lott emphasized several times during the discussion that the resolution is only to form an exploratory committee and put them to work. Nothing else.

Alderman Bell made a motion to allow Mr. Thornhill to speak, seconded by Alderman Lindsey. Alderman Askew said there were several people raising their hands and he would like them to have the

opportunity to speak too. Attorney Frey said allowing Thornhill to speak would be opening up audience participation. Alderman Bell withdrew his motion. Alderman Askew made a motion to open audience participation, seconded by Alderman McDonald. The motion passed with a 5-1 vote with Alderman Lindsey voting no.

AUDIENCE PARTICIPATION

Mr. Terry Thornhill, 1001 Forest View, said as an investor in Camden, people are coming to Camden now to decide if they want to move here. We need to prepare now. It's about doing something to make our city more attractive. Right now, children under age 6 are being left out of sports in Camden and their parents are taking them out of town to play.

Ms. Ebony Gulley, 605 Progress, urged the Council to form the committee and volunteered to be on it. Mr. Jessie Sanders, 219 Jack Parr, spoke in favor of the Resolution.

Mr. Mike Sherman, 240 Adams, stated that this decision is not political, it's about the kids.

Mrs. Nancy Lott, 412 Arkansas, asked why they were arguing so much just to form a committee.

Mrs. Helen Aregood, 3020 Cherokee, suggested taking out the 3rd, 4th, 5th, and 6th Whereas and just form the committee.

Mrs. Callie Hughey, 257 Madison, said the kids need something to do, so form the committee.

Alderman Bell made a motion to amend the resolution and strike the 3rd, 4th, 5th, and 6th whereas. Alderman Askew seconded. The motion to amend passed with a 5-1 vote with Alderman Lindsey voting no.

Alderman Askew made a motion to approve the Resolution as amended, seconded by Alderman Aregood. The Resolution was approved by a 5-1 roll call vote with Alderman Lindsey voting no.

ORDINANCE NUMBER 12-22

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS ESTABLISHING PROCEDURES FOR CHANGING THE NAME OF A STREET; AND FOR OTHER PURPOSES

WHEREAS, the City has previously changed the names of streets at the request of local residents; and

WHEREAS, the City desires to implement a uniform process for the application, review and approval of such requests.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1. Applicants requesting that a street be renamed shall follow the procedure set forth in this Ordinance.

SECTION 2. The Mayor shall develop forms for requests to rename a street substantially similar to the forms attached hereto.

SECTION 3. Applications to change a street name shall be presented to the Camden Planning Commission. If approved by the Planning Commission, the application shall be presented to the City for consideration.

SECTION 4. The applicant shall submit the required forms to the Camden Code Enforcement Department, 206 Van Buren NE, Camden, Arkansas, (870) 837-5508. These forms may be obtained in advance in order to expedite the filing. The application shall evidence at least fifty percent of the residents on such street as approving the change by their signature. The petition must include address and printed and signed name of all residents. A list of all affected persons and addresses must also accompany application.

SECTION 5. The applicant shall submit as part of his application three (3) copies of a survey or other instrument such as a recorded plat indicating the area of the name change.

SECTION 6. The payment of a filing fee in the amount of One-Hundred and Fifty Dollars (\$150.00) shall be required at the time of filing.

SECTION 7. The applicant shall submit as part of the filing a cover letter outlining the proposal and stating the reasons for the proposed change.

SECTION 8. After filing the proper forms and meeting the requirements set forth above, the applicant shall give notice to affected properties as required below. Before the Planning Commission shall consider a petition for a name change, the applicant shall first give at least 30 days written notice of the time, place and date of the public hearing thereon to all residents of land abutting portions of the street involved. This includes all occupants of apartment houses, business occupants and single-family homes.

SECTION 9. The notice shall be by certified mail. Copies of certified mail receipts must be submitted to the Code Enforcement Department, one (1) week prior to the hearing date. The form for notice shall be that as provided by the staff.

SECTION 10. The applicant should be present at the meeting in order to answer any questions of the Commission or other interested parties. The absence of the applicant may be cause for deferral or rejection.

SECTION 11. The applicant's noncompliance with the above may be cause for the petition to be withheld or not considered at the meeting scheduled and may require the re-notification of all residents/property owners.

SECTION 12. If the Planning Commission approves the request, then the application shall be presented to the City Council for consideration.

ORDINANCE NO. 13-22

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, FIXING THE RATE OF TAXATION FOR THE YEAR 2023; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1. Upon each and every dollar of taxable property, both real and personal, there shall be and is hereby levied the following rate of taxation for the year 2023:

- 1. For defraying the general expense of the City, known as taxes for general purposes:
 - 5.0 mills on the dollar for real property.
 - 5.0 mills on the dollar for personal property.
- 2. For creating a fund to be used for the payment of firemen's pensions:
 - 1.0 mills on the dollar for real property.
 - 1.0 mills on the dollar for personal property.
- 3. For creating a fund to be used for the payment of policemen's pensions:
 - 1.0 mills on the dollar for real property.
 - 1.0 mills on the dollar for personal property.
- 4. For creating a fund to be used for maintenance of a public library:
 - 1.0 mills on the dollar for real property.
 - 1.0 mills on the dollar for personal property.

SECTION 2. The County Clerk of Ouachita County, Arkansas, on receipt of a duly certified copy of this Ordinance from the City Clerk of the City of Camden, is directed to enter upon the tax books of Ouachita County, Arkansas, for the year 2023, the foregoing rate of taxation by which all property, both real and personal, is assessed in the City of Camden, and the Collector of Ouachita County, Arkansas, is directed to collect said taxes and pay over to the Treasurer of the City of Camden the respective amounts so collected and found due to said City on his statement with the County Clerk of Ouachita County, Arkansas.

SECTION 3. It is recognized that according to the provisions of Arkansas Code Ann. § 26-26-406, the County Clerk of Ouachita County, Arkansas, has the statutory authority to make base year adjustments to the millage levy for personal property outlined above.

SECTION 4. It is ascertained that the time for making the levy of these taxes for the year 2023 is about to expire and in order to prevent the loss of revenues to the City of Camden, it is necessary that this Ordinance take effect immediately; therefore, an emergency is declared to exist and this Ordinance shall take effect and be in force from and after its passage.
