**ORDINANCE NO. 4-23**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, REPEALING CAMDEN CODE SECTION 2-54 REGARDING ADVERTISING OF BIDS FOR PUBLIC IMPROVEMENTS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City passed section 1 of Ordinance 576 (1963) and section 2 of Ordinance 15-85 (1985); and

**WHEREAS**, the ordinance sections were codified at Section 2-54 of the Camden Code of Ordinances; and

**WHEREAS**, Section 2-54 provides:

“The city shall advertise in a newspaper published and having general circulation in the city for sealed bids when contracts for public improvements or for public work amounts to five thousand dollars (\$5,000.00) or more, except in the case of emergencies where three (3) competitive quotations may be secured without advertising and the contract so awarded by the board of aldermen is to the lowest and best quotation.

**WHEREAS**, A.C.A. § 14-58-303 requires competitive, sealed bidding for purchases and contracts that exceed Thirty-Five Thousand Dollars (\$35,000.00); and

**WHEREAS**, the more restrictive threshold of \$5,000.00 for certain projects is no longer practical.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:**

**SECTION 1.** Section 2-54 of the Camden Code of Ordinances, derived from Section 1 of Ordinance 576 and Section 2 of Ordinance 15-85, is hereby repealed.

**ORDINANCE NO. 05-23**

**AN ORDINANCE AMENDING ARTICLE II OF THE CAMDEN CODE; ESTABLISHING RATES AND PROCEDURES FOR COLLECTION OF GARBAGE; AND FOR OTHER PURPOSES.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:**

**WHEREAS**, the fees for collecting garbage from commercial customers has not been increased since 2003; and

**WHEREAS**, the costs of picking up garbage from commercial customers has increased significantly; and

**WHEREAS**, the rates for commercial customers should to be adjusted to adequately compensate for the costs of the service; and

**WHEREAS**, the use of trash containers has changed since the City last addressed garbage collection; and

**WHEREAS**, the rates for special garbage pickups have not been increased in numerous years.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:**

**SECTION 1:** Section 11-16 of the Camden Code of Ordinances is amended by deleting the second paragraph defining “back door collection”.

**SECTION 2:** Subsection (e) of Section 11-20 of the Camden Code of Ordinances regarding fees for commercial collection is deleted in its entirety and replaced by the following:

(e) Schools, churches, businesses or industrial establishments, with the exception of downtown zoning district C-3 (central business district), shall pay the following monthly fees to the city for removal of garbage and trash:

- (1) Each service unit, per cubic yard .... \$ 16.00
  - Minimum monthly fee, per using establishment ..... \$ 19.00
  - Monthly fee for downtown central business district ..... \$ 24.00

(2) Collection charge per month:

	1 pickup per week	2 pickups per week	3 pickups per week	4 pickups per week	5 pickups per week
3 yard container	\$ 48.00	\$ 96.00	\$ 144.00	\$ 192.00	\$ 240.00
4 yard container	\$ 64.00	\$ 128.00	\$ 192.00	\$ 256.00	\$ 320.00

**SECTION 3:** Section 11-33 of the Camden Code of Ordinances is amended by adding the following language to the end of the Section:

“Commercial dumpsters must be placed on a solid surface. A surcharge fee of \$2.00 per month will be added to the bill for each dumpster not in compliance.”

**SECTION 4:** This ordinance shall become effective on January 1, 2024.

**ORDINANCE NO. 07-23****AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, AMENDING CAMDEN CODE SECTIONS 2-46, 2-52 and 2-53, REGARDING PURCHASES AND CONTRACTS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City passed Section 1 of Ordinance 576 (1963) and Section 1 of Ordinance 8-96 (1996), and the ordinance sections were codified at Section 2-46 of the Camden Code of Ordinances; and

**WHEREAS**, Section 2-46 provides:

“The mayor shall have the exclusive power, and responsibility to make all purchases of supplies, apparatus, equipment, materials and other things necessary to carry out municipal functions for the city, and to make contracts for work or labor to be done, or material or other necessary items to be furnished for the benefit and use of the city, or in carrying out any work or undertaking of a public nature in the city where the amount of the expenditure for any purpose or contract does not exceed the sum specified in state statutes enacted by the general assembly of the state.”

**WHEREAS**, the City passed Section 1 of Ordinance 576 (1963); Section 3 of Ordinance 3-89 (1989); and Section 6 of Ordinance 8-96 (1996), and the ordinance sections were codified at Section 2-52 of the Camden Code of Ordinances; and

**WHEREAS**, Section 2-52 provides:

“Sec. 2-52. Purchases over one thousand dollars but less than the cost limit specified in state statutes. Materials, supplies, equipment or services (except professional services) costing over on thousand dollars (\$1,000.00), but less than the cost limit specified in state statutes enacted by the general assembly, shall be purchased only by designated personnel after first securing two (2) or more written quotations upon the authorization and approval of the mayor. A purchase requisition is required for this type of purchase.”

**WHEREAS**, the City passed Section 1 of Ordinance 576 (1963); Section 1 of Ordinance 15-85; (1985); Section 4 of Ordinance 3-89 (1989); and Section 7 of Ordinance 8-96 (1996), and the ordinance sections were codified at Section 2-53 of the Camden Code of Ordinances; and

**WHEREAS**, Section 2-53 provides:

“Sec. 2-53. Purchases exceeding cost limit specified in state statutes. Materials, supplies, equipment or services (except professional services) exceeding the cost limit specified in state statutes enacted by the general assembly, shall be purchased only after first securing sealed bids upon the authorization of the mayor and final approval of the board of aldermen. A formal purchase order shall be issued to the successful vendor once the bid has been approved and accepted by the board of aldermen.”

**WHEREAS**, A.C.A. § 14-58-303 was amended by the state general assembly raising the cost limit requiring competitive, sealed bidding for purchases and contracts from twenty thousand dollars (\$20,000.00) to Thirty-Five Thousand Dollars (\$35,000.00); and

**WHEREAS**, the City Council desires to amend Camden Code Sections 2-46, 2-52 and 2-53 to provide procedures for purchases that cost at least twenty-thousand dollars (\$20,000.00).

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:**

**SECTION 1.** Section 2-46 of the Camden Code of Ordinances, derived from Section 1 of Ordinance 576 and Section 1 of Ordinance 8-96, is hereby amended to read as follows:

“The mayor shall have the exclusive power, and responsibility to make all purchases of supplies, apparatus, equipment, materials and other things necessary to carry out municipal functions for the city, and to make contracts for work or labor to be done, or material or other necessary items to be furnished for the benefit and use of the city, or in carrying out any work or undertaking of a public nature in the city where the amount of the expenditure for any purpose or contract does not exceed the sum of twenty-thousand dollars (\$20,000.00).”

**SECTION 2.** Section 2-52 of the Camden Code of Ordinances, derived from Section 1 of Ordinance 576; Section 3 of Ordinance 3-89; and Section 6 of Ordinance 8-96, is hereby amended to read as follows:

“Sec. 2-52. Purchases over one thousand dollars but less than twenty thousand dollars. Materials, supplies, equipment or services (except professional services) costing over one thousand dollars (\$1,000.00), but less than twenty thousand dollars (\$20,000.00), shall be purchased only by designated personnel after first securing two (2) or more written quotations upon the authorization and approval of the mayor. A purchase requisition is required for this type of purchase.”

**SECTION 3.** Section 2-53 of the Camden Code of Ordinances, derived from Section 1 of Ordinance 576; Section 1 of Ordinance 15-85; Section 4 of Ordinance 3-89; and Section 7 of Ordinance 8-96, is hereby amended to read as follows:

“Sec. 2-53. Purchases of twenty thousand dollars or more. Materials, supplies, equipment or services (except professional services) at or exceeding twenty thousand dollars (\$20,000.00), shall be purchased only after first securing sealed bids upon the authorization of the mayor and final approval of the board of aldermen. A formal purchase order shall be issued to the successful vendor once the bid has been approved and accepted by the board of aldermen.”

**AN ORDINANCE REPEALING ORDINANCE NO. 11-11 ASSESSING A LIEN ON CERTAIN PROPERTY LOCATED AT 327 BUCHANAN ST. SE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT ORDINANCE NO. 11-11 PASSED AND APPROVED ON MARCH 13, 2012, IS HEREBY REPEALED IN ITS ENTIRETY AND THE FOLLOWING SUBSTITUTED THEREFOR:**

**WHEREAS**, the City declared the structure located at 327 Buchanan St. SE, Camden, Arkansas, Parcel No. 804-00026-000R, to be a nuisance to the provisions of Section 6-61, et, seq., Resolution No. 41-06; and

**WHEREAS**, the owner of the property failed to remove the structure as required by law and the City performed the removal of the structure.

**WHEREAS**, notice has been given to the property owner that a hearing will be held on Tuesday, October 10, 2023 at 7:00 p.m. to determine the status of the lien assessed to the property as required by law.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:**

**SECTION 1:** The net costs performed on the removal of the structure located at 327 Buchanan St. SE, Camden, Arkansas, being located on said property, has been determined at a hearing before the City Council of the City of Camden to be the sum of \$4,194.88.

**SECTION 2:** The property concerned herewith located at 327 Buchanan St. SE is in the name of Eric Falls. Mr. Falls is offering \$840.00 to satisfy the lien. The City hereby sets a lien in the amount of \$840.00 to the property concerned herewith.

**SECTION 3:** That a certified copy of this Ordinance shall be transmitted to the Tax Collector of Ouachita County Arkansas, with the direction to place the above cost of removal and penalty on the tax books for the property described herein as delinquent taxes and collect the same according to law, with the amount so collected, less 3% thereof to be retained by the Collector for their costs, to be paid directly to the municipality as provided by law.

**SECTION 4:** BE IT FURTHER ORDAINED THAT this Ordinance shall take effect upon its passage and approval.
