SECTION 1. The City Council hereby recognizes the rules governing *Meetings and Procedures* as set forth in Section 2-22 through Section 2-34 of Chapter 2, Division 2, of the Code of Ordinances of the City of Camden.

SECTION 2. The Mayor shall be responsible for preparation of the Council's agenda. Any item that is to be included therein must be delivered to the Mayor's office before 5:00 p.m. on the last Friday of the month for the following month's meeting. During a Council meeting no item can be submitted for vote by Council, unless it has been included on the agenda, without two-thirds (2/3) vote of the entire membership of the City Council. All resolutions and ordinances shall be offered in writing in accordance with the Code of Ordinances of the City of Camden.

SECTION 3. An Audience Participation section shall be made a part of the City Council's agenda whereby any person(s) who has signed in as a speaker, shall be permitted to address the Council on any subject. However, before addressing the City Council, the Mayor shall first recognize the individual(s) wishing to speak and ask them to give their name and home address for record and to limit their comments to three minutes or less.

ORDINANCE NO. 1-26

AN ORDINANCE OF THE CITY OF CAMDEN ARKANSAS, REZONING PROPERTY LOCATED AT 137 DOAK ST. FROM RS-2 (SINGLE FAMILY) TO RM-1 (MULTI FAMILY).

WHEREAS: Act 186 of 1957, as amended by Act 128 of 1959, Act 36 of 1963, Act 134 of 1965, Act 138 of 1965, Act 66 of 1967, and Act 379 of 1969, of the General Assembly of the State of Arkansas, empowers the City to engage in municipal planning, to adopt plans and ordinances to regulate land-use and development practices, and to provide for the administration, enforcement, and amendment thereof and, the rezoning request is in harmony with Camden's land use plan.

WHEREAS: The Planning Commission desires to amend Ordinance 1-90 Zoning Ordinance of the City of Camden, Arkansas enacted February 20, 1990.

WHEREAS, Certain properties located in Section 21, Township 13, Range 17 West which is Block 10 Lots 3,4,5 and 6 are zoned RS-2

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMDEN, ARKANSAS, THAT:

SECTION 1: Ordinance No. 1-90, Zoning Ordinance of the City of Camden, Arkansas, enacted February 20, 1990, is hereby amended to rezone certain property located at 137 Doak St. in the City of Camden as described below:

From RS-2 (Single Family) to RM-1 (Multi Family) described as follows Subdivision Liberty Heights. Parcel #715-00054-000R.

SECTION 2: The Planning Commission of the City of Camden met in regular session on December 18, 2025, and approved a request by Micheal Cox to rezone the property located at 137 Doak St. from RS-2 to RM-1.

SECTION 3: The "Official Zoning Map" of the City of Camden, Arkansas Shall be updated.

SECTION 4: BE IT FURTHER ORDAINED THAT this Ordinance shall take effect upon its passage and approval.

WHEREAS, a petition was duly filed with the City Council of the City of Camden, Arkansas, on November 1, 2025, asking the City Council to abandon Lena Street located near Fairview Road, in the City of Camden, Arkansas, as shown on the recorded plat thereof; and

WHEREAS, after due notice as required by law, the City Council has at the time and place mentioned in said notice heard all persons desiring to be heard on the question and has ascertained that said street, as hereinafter described, has heretofore been dedicated to the public for use as a street, has not actually been used by the public generally for a period exceeding (5) years subsequent to the filing of the plat, and that the public interest and welfare would not be adversely affected by the abandonment of the street.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF CAMDEN, ARKANSAS, THAT:**

SECTION 1: The City of Camden, Arkansas hereby releases, vacated and abandons all its rights, together with the rights of public generally, to Lena Street near Fairview Road as shown on the attached plat. Reserving, however, the same as an easement for the construction, installation, maintenance, operation, repair and replacement of any utility.

SECTION 2: A copy of this Ordinance duly certified by the City Clerk shall be filed with the Office of the Circuit Clerk and Ex-Officio Recorder of Ouachita County, Arkansas and recorded in the Deed Records thereof.

SECTION 3: This Ordinance shall take effect immediately and be in full force from and after its passage and approval.
