B. Affordable Housing Development Loan Amendment

Recommended Action: Adopt Resolution No. 4393 authorizing the City Manager to execute an Amended Loan Agreement with MP Rail Trail Associates, LP to increase an existing loan of \$250,000 by \$1,307,808 for a total loan of \$1,557,808 to fund development of 52 residential units affordable to low income households at 1098 38th Avenue, Capitola, CA and allocating \$357,807.60 of PLHA Funds and \$950,000 of Housing Successor Agency Funds thereto.
