SPECIAL PRESENTATIONS

10. Employee Recognition

Mr. Parvin recognized Harbor Master Larry Denning for five years of service with the Town, noting that he worked for several years as a contract employee before being hired full-time. Mr. Parvin praised Mr. Denning's work at the marina, mooring field, anchorage, and street ends and highlighted the excellent reviews he receives from visitors.

Mr. Oakley recognized Police Chief Vic Ward for five years of service with the Town, highlighting Chief Ward's leadership by example and focus on officer safety, community safety, and community well-being. Police Chief Ward emphasized that the department's success was due to the collaborative efforts of everyone involved.

11. Events Update by Tim Murphy

Mr. Parvin presented in Community Service Manager Tim Murphy's absence regarding the Steve Haydu St. Patrick's Lo Tide Run on March 14. He explained that there would be a route change this year, with Lake Park Boulevard being closed at Cape Fear Boulevard 7:55-9:30 AM on race day. Mr. Parvin said this change, which was unanimously recommended by the Events Committee, would create a safer, more efficient event by implementing a hard closure with detours along Dow Road.

12. Manager's Update

Mr. Oakley reviewed the budget FY 2026-27 schedule:

- Council strategic planning/budget retreat – January 29-30
- Budget open house – February 11
- Public hearing for non-profit requests – March 10
- Public hearing for community input – April 14
- Budget workshop – April 28
- Budget open house – May 5
- Review revenue and expense projections and public hearing for community input – May 12
- Budget message presented to Council – May 26
- Budget public hearing and adoption – June 9

Mr. Oakley gave an update on various projects:

- Beach nourishment: The project is currently paused. The U.S. Army Corps of Engineers will hold a public meeting on February 3 to discuss the project and answer questions.
- Tree City USA: The Town has been awarded Tree City USA status by the Arbor Day Foundation for the third consecutive year, thanks to the work of staff and the Beautification Committee.
- Infrastructure revenue bonds: The Town will present to the Local Government Commission on February 3, with bonds for sale on February 11 and closing in March. Projects will commence after closing.
- Project updates: Several major projects – including the Boardwalk bathroom, Lake Park pump house, Lake Park bathroom, and the 1810 Canal Drive beach access – will be substantially complete by the end of March. Mr. Parvin clarified that the 1810 Canal Drive beach access project includes paving the lot with handicap access, which is targeted to be completed before March 1, pending coordination with beach nourishment equipment staging.
- Freeman Park Committee: Mr. Parvin reported that staff has been developing the framework for the land management plan. The committee kickoff meeting is tentatively scheduled for February 16 or 18, likely 3:00-5:00 PM. This will be approximately a year-long process with both committee meetings and public input sessions.

Mayor Barbee noted that there is a separate project involving dredging of the Intracoastal Waterway crossing at the inlet, which will place sand on Freeman Park.

Mayor Pro Tem LeCompte inquired about an update from the N.C. Department of Transportation (DOT) regarding striping on Lake Park Boulevard. Mr. Oakley said there was no update yet, noting that subcontractors were behind and that weather conditions were affecting the timeline.

PUBLIC COMMENT

Christy Lee of Ivy Lane spoke regarding a desire for an ordinance for pet shops that would create zoning and separation requirements for establishments selling dogs or cats not obtained from the New Hanover County Animal Shelter or non-profit animal organizations. She cited statistics on euthanasia rates in North Carolina, described poor conditions in puppy mills, and referenced public health concerns. Ms. Lee contended that such an ordinance would be beneficial to keep a pet shop from being established on the island and that it would prevent adverse impacts on property values and tourism.

PUBLIC HEARINGS

13. Zoning Map Amendment and 2020 CAMA Land Use Plan Amendment to Consider a Request to Rezone 205 Raleigh Avenue from Mixed Use (MX) to Central Business District (CBD)
Applicant: Jonathan Lee “Zeke” Hutchins

Applicant Zeke Hutchins has submitted a petition to consider rezoning 205 Raleigh Avenue from Mixed Use (MX) to Central Business District (CBD) zoning. There is an existing single-family home on the property that was built in 1933. The surrounding uses include a bank, two restaurants, a single-family home, a duplex, and two vacant lots.

The 1984 Zoning Ordinance and Zoning Map show the property in B-1: Central District. In 2000, 205 Raleigh Avenue was rezoned to MX.

ACTION: Motion to open the public hearing

Senior Planner Gloria Abbotts presented the details, including dimensional standards and permitted uses in both districts. She said the proposed rezoning would be inconsistent with the Land Use Plan, but State statute does allow for it if the amendment also amends the Future Land Use Map. Ms. Abbotts noted that the Planning & Zoning Commission recommended approval 4-1.

Mr. Hutchins said he and his wife Sharon, who live at 211 Virginia Avenue, bought that property in 2017 to use as a beach house but decided to make it their primary residence several years ago. He said they have been looking for a way to give back to the community with a business venture and like quirky historic beach cottages, so they bought 205 Raleigh Avenue with plans to open a bookstore that would focus on community programming and enrichment. Mr. Hutchins said the CBD zoning would allow them to utilize the backyard space and add an Americans with Disabilities Act (ADA) ramp on the side of the building without affecting the front porch.

No one else requested to speak.

Council Member Healy noted this was the third "quirky" property Council had considered in recent months and that when he was on the Land Use Plan Committee, they had not specifically looked at these small properties. He said he is in favor of the plans and expressed support for keeping a 1933 cottage alive.

Mayor Pro Tem LeCompte agreed with preserving old cottages and said she thinks the bookstore would bring something special to the Town. She acknowledged concerns about "CBD creep" but pointed out that old maps had this property as part of the Central Business District.

Mayor Barbee noted that the property is surrounded by commercial uses.

ACTION: Motion that whereas in accordance with provisions of the NCGS, Council does hereby find and determine that the adoption of the Zoning Map Amendment for 205 Raleigh Avenue is consistent with the goals and objectives of the adopted Land Use Plan and other long-range plans; the adoption of this Zoning Map Amendment also amends the Future Land Use Map and meets the vision of the Town

ITEMS OF BUSINESS

14. Employee Recruitment and Retention

Recruiting and retaining quality employees is a challenge, especially while larger organizations in the area are competing for the same talent. Some of these larger organizations can offer sign-on bonuses and other perks that are not practical for the Town due to its small size. Several good employees have left the Town for these types of opportunities, and there are numerous applicants choosing other places for the same reasons.

The Town is planning to review how benefits compare with other local organizations and make recommendations in the proposed FY 2026-27 budget. However, Mr. Oakley is now proposing to add another percentage point or two to the previously approved 2% merit increase for employees, noting that the Town's strong financial position would allow for this additional compensation.

Council Member Healy emphasized that retention is crucial and costs less than replacing employees. He said any additional compensation should be merit-based.

Council Member Rouse noted that some employees receive recruitment letters from other places every two months.

Council Member Losito said it costs ten times more to bring in and train a new person than to retain current staff.

Mayor Pro Tem LeCompte added said retention and longevity should be the Town's goal.

Mr. Oakley said specifically, he is proposing that each employee be eligible for up to 4% based on performance.

SUBJECT: Sidewalk from Carolina Beach Lake to Carolina Sands

BACKGROUND:

In May of 2023 the Town Manager was in discussions with North Carolina Department of Transportation (DOT) about how we could get sidewalks added from Carolina Sands to the Lake. Later that summer funding from DOT was earmarked for this project. Several on-site meetings occurred with Town staff and DOT. In November a plan was given to the town. The plan showed the sidewalk meandering from DOT right of way to private property. There were multiple conflicts with power poles, mailboxes, utilities, trash bins, signage, etc. Costs of purchasing the additional needed right-of-way was also a significant concern.

Staff worked with DOT on an alternative that would bump out curb and gutter and avoid all the conflicts. DOT met with staff on-site again and determined there was adequate drive aisle width to accomplish this task. Money agreed to be allocated by DOT: **\$183,118**

In 2023 the cost estimate came in at \$640,000. Below is the breakdown of the cost share

Total:	\$640,000.00
NCDOT Project Funds:	\$183,119.84
Town Contribution:	\$456,880.16

In 2025 the Town was notified by DOT the cost has increased due to requiring additional preliminary engineering and design costs. The revised costs are below.

Total:	\$850,000.00
NCDOT Project Funds:	\$183,119.84
Town Contribution:	\$666,880.16

The initial concept placed the new sidewalk within the roadway with the curb line bumped out, and travel lane reduced to 12'. However, during design development, DOT identified significant drainage concerns. The proposed curb alignment would create a berm, trapping water behind the sidewalk, and

prevent it from draining into the roadway, which would lead to flooding in adjacent properties. To address this, we evaluated adding inlet catch basins and piping between nearly every driveway. This increased the estimated construction cost significantly. With further investigation by the drainage designer, they determined that this design was feasible because they were unable to provide adequate drainage for a number of properties on the southern end of the project because of the existing grades of the property.

They are now considering other possible alternatives. The latest is a hybrid design in an attempt to minimize the impacts to the drainage, this concept proposes the sidewalk from North of Carolina Sands to South of Sumter Ave be placed behind the existing curb, and reduces easements required by combining the curb bump-out design from Sumter Ave to the existing sidewalk at Carolina Lake. This approach reduces impacts to the existing drainage network while improving pedestrian connectivity. One drawback from this approach is that more temporary construction and permanent easements will be needed to construct this portion of the sidewalk behind the existing curb.

Attached you will find the updated concept plans, and below is a summary of the construction and right-of-way cost estimates below.
