PROCLAMATION NO. 24-2302

WHEREAS the conferring of the designation of Eagle Scout is one of the highest awards that can be bestowed upon a Boy Scout, as it requires years of dedication and commitment.

WHEREAS Benjamin Anderson joined the Boy Scouts of America Carolina Beach Troop 210 in

February, 2021 during the Covid pandemic.

WHEREAS Ben has made lifelong friends while attending camp outs, National Youth Leadership

Training, National Jamboree, and participating in Order of the Arrow in his journey to complete the rank of Eagle Scout. He has earned 42 merit badges, the Paul Bunion

Woodsman Award, and the World Conservation Award.

WHEREAS Benjamin's Eagle Scout Project provided life jackets on distribution stands at marinas

and boat ramps. Ben continues to manage the 7 distribution sites in the Carolina Beach

area. This past year, the project built 25 new stands and stocked over 100 life jackets.

WHEREAS Benjamin is involved in Order of the Arrow (OA), a service organization for BSA scouts

who exemplify the Scout Law and Oath in their daily lives. Scout members can be elected by their troop peers once they have achieved the rank of 1st class. Ben has earned the rank of Brotherhood in OA and is the Kittahican Chapter Chief of the

Klahican Lodge, and a part of the Ceremonies Team.

WHEREAS When Ben is not participating in Scouting events, he enjoys lifting weights, playing video

games, and playing instruments such as the bass guitar, percussion, and the bugle. He can also solve multiple size Rubik's cubes in less than a minute. After high school, Ben plans to get a degree in mechanical engineering and is considering serving our country

in the U.S. Coast Guard or U.S. Navy.

SUBJECT: Volleyball Court on Cape Fear Boulevard

BACKGROUND:

Pleasure Island Volleyball is a group of locals who have historically played volleyball at the Lazy Pirate. The owners at Lazy Pirate have reworked their business plan and no longer provide volleyball. In search of a new beach volleyball venue, the Pleasure Island Volleyball group has been to multiple Town Council meeting requesting the Town build a volleyball court. They have also expressed interest in helping finance the venture.

After discussions with Town Council, Parks and Recreation Staff, and review by TRC is has been determined that the 300 block of Cape Fear Blvd would be a viable location for a beach volleyball court. After review, the following has been determined.

PARKING: Based on zoning the court without designated viewing areas would require 4 parking spaces and 1 designated handicap space. If viewing areas/bleachers are proposed then additional parking will be required. There are 3 parking spaces and 1 handicap space on-site. One additional parking space could potentially be used from the adjacent parking lot that supports the community building and help center.

BATHROOMS: NC Building Code would require the addition of this use to have bathroom facilities. To meet this requirement, it has been recommended that the Community Building be unlocked during the hours when the volleyball court is open.

LIGHTING: The Pleasure Island Volleyball group are interested in having lights for nighttime play. It is recommended that these lights be shielded and oriented to limit any impacts on the surrounding residential uses.

HOURS OF OPERATION: The finalized hours of operation are still under discussion. 8am to 9pm was one consideration.

FENCING: The Town recommends contracting the installation of a fence designed to mitigate: 1. Loss of sand due to wind; and 2. Adequate height to prevent balls leaving the court (possible netting on top of fencing similar to the ball fields at Mike Chappel Park.

SITE PLAN: The Pleasure Island Volleyball group have developed an initial site plan. The Town recommends working with a contractor to develop a final design of the court location that maximizes the setback from Cape Fear Blvd.

ACTION REQUESTED:

If Town Council would like to move forward staff recommends the following actions:

- 1. Contract to have a site plan completed.
- Schedule a community meeting at the site to get input from adjacent property owners and Carolina Beach residents.
- 3. Make any changes based on comments received and finalize site plans.
- 4. Get final quotes and allocate a budget from the general fund. Receive any donations from Pleasure Island Volleyball and/or others interested in donating.

- 2. Recommend staff move forward with the requested actions with the following additions.
