OUR GOALS

Carolina Beach is a fabulous town with amazing amenities to offer stakeholders and visitors. Improve the Lake Park Blvd corridor to be more aesthetically appealing, safe and pedestrian friendly.

<u>Combined Council Appointed Committees present the following</u>

ideas and goals for consideration, feasibility, and implementation:

- Implement a realistic and strategically planned timeline in coordination with NCDOT repaving of Lake Park Blvd and Centennial Celebrations, scheduled for 2025.
- Budgetary line item annually for maintenance of all projects at minimum of ten years.
- Budgetary line item annually for continuation of beautification projects.
- Budgetary line item annually for continuation to completion of all other listed CAC projects presented here.
- Complete projects in manageable phases and time frames and finish for CENTENNIAL.
- Prepare a nursery area with donations from NCWF Island Wildlife Chapter with donated plants and trees through CB Trash Walkers.
- Work with requisite state, county, municipal organizations & stakeholders.
- Transform the major corridor of Carolina Beach to a walkable, engaging, beautiful and safe experience, connecting all sections of the Lake Park thoroughfare.
- Use indigenous and other species that are prolific drought and salt resistant plants.
- Propagate perennials annually as a resource for constant and continued beautification and species maintenance.

Funding and Implementation

IMPLEMENTATION & RESEARCH

- NCDOT has a beautification plan engage
- Get NCDOT permission encroachment agreement
- Discuss with Keith Groves NCDOT Div.3, Řoadside Environmental Engineer regarding the NCDOT supplying trees/shrubbery/plants with town care agreement of plantings. Requires planting plan in place and application to the NCDOT "Landscape Enhancement Program".
- Bring in Duke Energy to verify placement allowance
- Bring in AT&T to verify placement allowance
- Bring in the Town of Carolina Beach Public Works & Utilities regarding location of water/sewer and storm water lines for placement allowance
- Establish who will be doing the plantings
- Establish who will be purchasing the trees/plants
- Town Resources will be recommended for care and maintenance of all improvements.
- Will need landscape architecture plan drawings for ALL submissions to NCDOT for approval.

FUNDING

- Work in Conjunction with Pleasure Island Habitat, Friends of the Carolina Beach Parks & Greenways and Island Wildlife, and other 501c(3) groups for fundraising
- Grants to be written by town staff and possibly engage an independent grant writer, Barbara Robinson
- Approach businesses/property owners to consider splitting costs of trees with town

Marketing Committee: Would like to see the Marketing Logo added to the NCDOT "Welcome to Carolina Beach" sign on the north side of Snow's Cut Bridge and/or included somewhere within The Plan that would be beneficial to our tourism industry

Operations Advisory Committee: Butch LeCompte

<u>The three high level submitted ideas are:</u>

- 1. Decorative bike racks for enhancing the natural transition from parking & bicycling, to walking safely in the CBD.
- 2. The creation of safety bump-outs at intersections on Lake Park Blvd between Harper Blvd and Charlotte Avenue. And eliminating street front parking on the blocks where Havana's and El Cazador are on one side & The Dive and Shuckin Shack are on the other side.
- 3. Signage at hamlet avenue on both sides of lake park and at each beach access street along Carolina Beach Avenue South to direct bicyclists to use CBAS as an alternate safety bike route instead of lake park Blvd Where it could be considered dangerous to bike next to lake park especially around the curve of the CB Lake. (I cross verified this with Ricky Neic, the chairman of bike/Ped in advance .. that they would be supportive of this and not interpret this as contrary or distracting from their own 'ask' to stripe a bike/pedestrian aisle on the west side of lake from Charlotte Ave to Carolina Sands (pending DOT feedback).
- 4. 25 MPH Lake park Idea Removed as a submission.
- Note: For the slide describing where the bump-outs might be, you will see 3/4 round corner bump/outs at cape fear and lake and trapezoidal bump-out at Raleigh and lake as well as Harper and lake to address the smaller scale and space availability there.

Phase 1A GATEWAY TO CAROLINA BEACH PLANTINGS Green on calendars

- Fall 2022
- Plant the area north of the bridge down the center.
- Move MURAL PROJECT "Welcome to Carolina Beach" sign to south west corner of Lake Park and Dow Road.Include lighting for sign.
- Presented: landscape architecture plan drawings for GATEWAY to NCDOT for approval.
- NEW NCDOT Carolina Beach sign and bed planting on west right of way.
- Native drought resistant perennials to minimize maintenance.
- Town has NCDOT permission to plant this area if town maintains.
- ADVANTAGES: Planting perennials gives the ability to propagate annually and plant more throughout town at almost no cost.
- These types of flowers and grasses will attract butterfly species that are in danger like the Monarch.



- Plant: west side of the road going south at Dow Road between Bridge Barrier and Elton to match the plantings at the corners of Dow Rd and N. Lake Park at the light. Plant Cost: \$2000
- ADVANTAGES: Planting perennials gives the ability to propagate annually and plant more throughout town at almost no cost.
- These types of flowers and grasses will attract butterfly species that are in danger like the Monarch.



Phase 1C Light at Dow Rd & N Lake Park - add trees to concrete medians. 2 PHASES Yellow & Red on calendars

- Spring 2023
- Plant 15 Sable Minor Palm trees (native trees per NCDOT) in the concrete medians south of the Dow Rd/Lake Park intersection in a 3 across by 5 deep pattern.
- Speed limits allow this.
- Proposed:
- NCDOT approval for project to cut appropriate square planting holes.
- Speed limit here allows for trees in median.
- Irrigation of area has been discussed.
- Suggest Palm Trees here to minimize overhang and keep visibility clear.
- Monkey Grass or other type grass at base of trees for low maintenance.



Phase 1D Create communal areas in CBD Orange on Calendars

- Winter 2022-2023 Benches and tables Spring 2023 Tree plantings
- Proposed: PROMOTE A SENSE OF COMMUNITY

Make the CBD beautiful, approachable, communal, and peaceful.

USE: Benches, trees, game tables and perennial long-flowering drought-resistant plants will transform the defined streetscapes where setbacks allow. Tree bases with thick lilies or grasses at the bases will provide shade and greenery without hiding signage for businesses. Benches and tables will offer more communal areas for shoppers to gather, rest, or enjoy our downtown. Possibility of widening the sidewalks in the CBD. These additions will draw people for fireworks viewing and to our businesses.

A. Place benches (with flipping backs) and trees in the grassy area on the east side of N Lake Park between Cape Fear Blvd and Charlotte.

B. Add benches (with flipping backs) on both sides of Cape Fear Blvd, between N Lake Park Blvd and Canal Drive.

Benches and Palm Trees between the street lights.

Benches should have backs so people can choose which way to face. People can gather for fireworks and music, coffee, quick breakfasts, food pickup, and rest from shopping. Use controlled height grass types around the Palm Trees to reduce maintenance.

Phase 1D COMMUNAL AREAS in CBD: Before and After Image mock-ups NOTE: In NCDOT areas ONLY NATIVE SPECIES allowed. In Privately owned areas, any species allowed. Only the

Phase 1E Plantings past median to St. Joseph Street Complete tree planting on N. Lake Park Blvd to St. Joseph St. in conjunction with property owners/businesses.

Early 2023 to end 2023 (possibly in conjunction with The Proximity project)

- Will request a simple agreement with an owner or business to plant on their property and, if needed, an agreement with NCDOT if planting on their property. May need an easement with Duke Energy as well.

Proposed:

Palm / Indigenous / low growth (height) trees to keep visibility, walkways, roadways, electrical lines, business signage and overhang controlled. NOTE: In NCDOT areas ONLY NATIVE SPECIES allowed. In Privately owned areas, any species allowed. Only the Sable Minor Palm (smaller) is considered an NC native of the Palms.





Phase 2 Winter 2023 - Spring 2024

Tree Planting and beautification between St. Joseph St. and the Carolina Beach Lake Park at Atlanta Ave.

- Winter 2023 Spring 2024
- In conjunction with property owners/businesses and NCDOT approval.
- Funding from sources identified in this report.

Phase 3 Fall 2024 South end of Carolina Beach Lake Park to Carolina Sands entrance

Tree planting and establishment of a bike or walking path between the South End of the Carolina Beach Lake Park and the entrance of Carolina Sands at Carolina Sands Drive, on the west side of South Lake Park Boulevard. Bike/Ped Committee is requesting NCDOT to stripe a Bike Lane between mid point of the lake and south or just south of the lake and Carolina Sands. They have been working with NCDOT Complete Streets Program and the WMPO.

- Fall 2024
- In conjunction with area businesses, the Town's Bike & Pedestrian and Operations Advisory Committees, subject to the Town and NCDOT approval.
- Will require a discussion of removing 7 parking spaces on the west side of South Lake Park Blvd.
- Will involve cooperation with NCDOT.
- Will require a much more involved effort to implement.
- Time frame allows for planning and discussion.
- Needed for safety for pedestrians to navigate these businesses and this area on bicycles and on foot.

Phase 4 2024 - 2025 South of Carolina Sands Drive to Alabama Ave.

- Work in conjunction with affected property owners, the Town and the Town's Bike/Ped and Operations Advisory Committees, and the WMPO, to request implementation and installation by NCDOT of sidewalk/bike path and tree plantings on the west side of S. Lake Park Blvd within the already established setbacks.
- Include tree plantings and benches
- Include perennial plantings
- Needed for bike and pedestrian safety on this main thoroughfare.
- Raise funds for tree plantings to be identified on the east side of S. Lake Park Boulevard, with NCDOT support and approval.

Tree and Planting Needs Suggestions:

KONIGEEHRE 20 Gallon Tree Watering Bags, Reusable, Heavy Duty, Slow Release Water Bags for Trees, Premium PVC Tree Drip Irrigation Bags. 5 for \$54.99 Bags will need to be filled every two days, if two bags per tree, every four days. Will need a water truck (town has???) Irrigation has been discussed as an option at TRC.

Water Bladders need to be used on trucks to water trees or fill watering bags. Can be found at Farmers Supply.

Palm trees planted in spring after April 15, all other trees can be planted in fall.

SPECIES SUGGESTIONS FOR TREE APPLICATIONS: Trees to be less than 15' in height full grown.

Need trees with good roots, small root balls that don't spread too much, salt and drought tolerant.

Little Gem Magnolia: evergreen, can be trimmed, need less water than palms, good size Sable Minor Palms / Palmetto: evergreen, require a lot of water first year, Fitness Tree does 1 year warranty, excellent root ball size Vitex Chaste Tree:: Deciduous - good size, flowers summer Yaupon Holly: evergreen, salt and drought tolerant, fall planting, winter red berries Sweet Bay Magnolia: evergreen year only losing some leaves. White flowers May-June Deciduous - flowering spring through fall.White, lavender, red, or pink flowers **Crepe Myrtles:**







SPECIES SUGGESTIONS FOR PLANTS AND GRASSES APPLICATIONS:

Prolific bloomers, drought and salt resistant, thick growing to force out weeds, can be mowed and weed whacked and recover. Most of THESE PERENNIALS, once established, can be split and used to propagate new plants at ZERO COST, excluding the worker effort

Stella D'oro Day Lillies:	choose reblooming, comes in yellow, red, purple, pink. Can be divided and propagate
Gallardia:	reblooming red/yellow. Drought & salt tolerant. Grows wild here.
Pink Muhly Grass:	Autumn bloom, salt tolerant, 3-4' W&H, dry to moist, cut back, butterflies
Little Blue Stem Grass:	Autumn color change blue to orange, salt tolerant, 2-4' W&H, cut back, butter
Sand Coreopsis:	Spring - summer continuous blooms, salt tolerant, sun, 1-2' W&H
Purple Cone Flower:(orange	?)bloom July-September, drought & slightly salt tolerant, good for median/road 🛛 🛛 📲
Black Eyed Susan:	bloom Summer to Autumn, drought and slightly salt tolerant, good for median/road.
Blue Wild Indigo:	bloom Summer to Autumn, drought and slightly salt tolerant, good for median/road. Spring bloom, dry soil, low salt tolerant, good for median/roadways and not beach
