WHEREAS, the Town of Carolina Beach was served on 11/8/2023 with a Civil Summons and Complaint filed by Carolina Beach Landholdings, LLC; and

WHEREAS, the Carolina Beach Town Council met in an advertised closed session during their regular meeting on November 12, 2023 for attorney client privilege as permitted by NCGS 143.318.11(a)(3) to discuss the lawsuit with the Town Attorney; and

WHEREAS, the Town Attorney requested Council retain additional legal counsel to assist with the defense of the lawsuit given the importance of the Carolina Beach Boardwalk to citizens and tourists and the potential impact of the lawsuit on the Carolina Beach Boardwalk as it exists today; and
