Discuss and consider approving the emergency repair of a water leak located in the area of 1st Street and approving a quote from Alvin E. Stock Contractors, LLC and authorizing the Mayor or the City Manager to execute contracts for such matters.

REASON FOR EMERGENCY MEETING

Pursuant to Section 551.045 of the Texas Government Code, this meeting is called with more than one hour but less than seventy-two hours' notice to consider a matter of emergency or urgent public necessity requiring a meeting under said statutory provision is as follows:

There exists an emergent and immediate need for approval of the emergency repair of the above described water leak to avoid the potential and immediate threat to the health, safety and welfare of the community. According to the City Manager and Public Works Director, time is of the essence in moving forward with the emergency repairs.

Pursuant to Government Code Sec. 551.047 related to Special Notice to News Media of Emergency Meeting or Emergency Addition to Agenda, any news media who has met the requirements of Sec. 551.047 have been notified of the addition of the emergency meeting by either telephone, facsimile transmission, or electronic mail at least one hour before the meeting is convened.

8. Deliberation regarding economic development negotiation (§551.087)
9. Deliberation regarding test item (§551.088)
