**Discuss and consider approving the emergency repair of a natural gas leak located in the area of 705 North 13<sup>th</sup> Street and contracting with Gasti, Inc. in an amount not to exceed \$7,000, and to authorize the Mayor or the City Manager to execute contracts for such matters.**

**REASON FOR EMERGENCY MEETING**

Pursuant to Section 551.045 of the Texas Government Code, this meeting is called with more than one hour but less than seventy-two hours' notice to consider a matter of emergency or urgent public necessity requiring a meeting under said statutory provision is as follows:

There exists an emergent and immediate need for approval of the emergency repair of the above-described natural gas leak to avoid the potential and immediate threat to the health, safety and welfare of the community. According to the City Manager and Public Works Director, time is of the essence in moving forward with the emergency repairs.
