Mayor Pro Tem Sofia Morones inquiries on being over the budget and how many times do other cities amend the budget. Mayor Pro Tem Sofia Morones recommends for the City Manager and Finance Director to meet once a month to review the budget.

Special Counsel Bobby Maldonado states that other cities amend their budget once a year.

Motion made by Mayor Pro Tem Sofia Morones, Councilor Mario Ruiz to include a budget report and overtime pay every month.

Vote for approval 4-0 (unanimous).

Motion carried.

16. DISCUSSION AND APPROPRIATE ACTION REGARDING PAY RATES FOR CITY OF CARRIZO SPRINGS SPECIAL EVENTS

Special Counsel Bobby Maldonado states that very few cities adopt a special events and premium pay, 4th of July triggered this item. This will benefit all employee's exempt and nonexempt will be paid "premium pay" at double their normal hourly rate. Payroll employees that have not worked a full 40-hour week will still get paid double pay for the special events.

Mayor Pro Tem Sofia Morones asks if the employees get paid for working special events from General Funds or HOT Funds. Finance Director Edgar Castillo states that the employees are paid for special events with HOT Funds. Mayor Pro Tem Sofia Morones recommends for salaried employees to have a choice to take comp time or get paid time and half if they work special events.

Finance Director Edgar Castillo asks Special Counsel Bobby Maldonado if hourly or salary employees will have taxes deducted from the special event pay. Special Counsel Bobby Maldonado states that the employees will have taxes deducted for special event pay.

Motion made by Mayor Pro Tem Sofia Morones to approve Section 6 Leaves and Absences: New Section 6.13 Special Events and Premium Pay to pay double time for non-exempt employees and exempt employees to have a choice to choose comp time hour to hour or get paid time and half.

Motion not seconded; motion failed.

Mayor Pro Tem Sofia Morones withdraws her motion.

Councilor Mario Ruiz states that exempt employees should get comp time if they work special events instead of getting compensated time and a half. Mayor Pro Tem Sofia Morones states that the exempt employees give up their holidays and they would appreciate having a choice between comp time and premium pay.

Special Counsel Bobby Maldonado recommends the city adopt a comp time policy.

Councilor Ashley Moreno also recommends that exempt employees have a choice between comp time and premium pay.

Councilor Mario Ruiz states that he just wants to be transparent. Mayor Oscar E. Puente and Mayor Pro Tem Sofia Morones state that the Council is being transparent and want to recognize all employees.

Motion made by Councilor Mario Ruiz, seconded by Mayor Pro Tem Sofia Morones to adopt a comp time policy and for exempt employees to get comp time hour per hour and non-exempt employees to get paid double their hourly rate when working special events.

Vote for approval 4-0 (unanimous).

Motion carried.

City Manager Chris A. Castaneda states that he will be out of the office on August 12-15, 2022.

Gas Department:

The gas department had its annual audit with the Texas Railroad commission and had no findings or violations. City Manager Chris A. Castaneda thanks Abelardo Puente, and the Gas department staff for the work they have done to keep the city gas running in the right direction. The city needs to stay focused on future upgrades to the gas infrastructure replacing the iron gas line as required by the state. Gas Consultant Simon Pena the has been a major help.

Civic Center Ramps:

Eagle Builders was hired to fix the issue with handicap ramps at the Civic Center.

Dollar Tree Update (drainage):

City Manager Chris A. Castaneda met with Garcia and Wright Engineer Raul Garcia Jr. regarding the drainage issues with Dollar Tree and Grace of God store. Mr. Rual Garcia Jr. will put together a report and forward it to City Manager Chris A. Castaneda and Special Counsel Bobby Maldonado. Mr. Raul Garcia Jr. stated that the property does sit outside of the City Limits. Not sure if this was done when the city annexed that property.

HEB Building:

Ron Alvarado will be working on a report regarding the use of old HEB building. He states the best use would be for city offices. It will cost about 5 million just to renovate the building to be used as office space or anything else. Just the restrooms alone would be about \$500,000. City Manager Chris A. Castaneda will provide an update once he gets a report.

Water Dept:

With the severe heat and drought, the water department has been having an increase with water leaks. We are still shorthanded in this department and fixing the leaks as they are being reported and as soon as all the lines are marked and located.

Flow Meter:

Water Department is waiting on a price for the flow meter to be installed on sewer line coming in from Carrizo Hill. The best place to install it will be on Veteran Blvd and FM 1917. We are waiting on a price for the installation and meter cost. We are also looking into it being solar or electrically powered.
