Juan J. Ortiz, DCPL Director presented Council with the Dimmit County Public Library Budget and Interlocal Agreement. The total budget for the Dimmit County Library is \$147,000 for Fiscal Year 2021-2022. Mr. Ortiz requested 25% for yearly expenses from the city totaling \$32,387.64 and stated that the rest of the expenses will be covered by Dimmit County and private donations.

Mayor Pro Tem Sofia Morones asked Mr. Ortiz how much the library receives from the county. Mr. Ortiz stated that he receives \$8,500 per month from the county and \$2,600 from the city.
