3. DISCUSSION AND APPROPRIATE ACTION TO APPROVE RE-SALE BID ON TRUSTEE PROPERTY, TO-WIT: "LOT 5, BLOCK 13, OF THE EAST SIDE ADDITION TO THE CITY OF CARRIZO SPRINGS, DIMMIT COUNTY, TEXAS", TAX OFFICE PROPERTY ID NUMBER 12753. (TAX SUIT 09-02-02436-DTX, CITY OF CARRIZO SPRINGS VS. FEDERICO MEDINA)

James E. Cabello presented Council with Alfredo Jaramillo's bid of \$3,900 for a property located at 209 E. Walker Avenue.

Motion made by Councilor Estanislado Z. Martinez, seconded by Councilor Noel Galvan to approve re-sale bid on trustee property, to wit: "lot 5, Block 13, of the East Side addition to the City of Carrizo Springs, Dimmit County, Texas", tax office property ID number 12753 (tax suit 09-02-02436-DTX, City of Carrizo Springs vs. Federico Medina).

CIVIC CENTER BALCONY DECK PROJECT

4. DISCUSSION AND APPROPRIATE ACTION REGARDING THE CIVIC CENTER BALCONY DECK PROJECT

Mayor Oscar E. Puente states that the Civic Center Balcony Deck was not professionally built, the work is extremely poor. Mayor Pro Tem Mario Ruiz states that the deck will need to be replaced after the pool season.

Councilor Sofia Morones asks if the contractors will replace the whole deck. City Manager Azalia Garcia states that she has not had any discussion regarding replacing the balcony deck with Ryno Services and will meet with them after the Council decides how to move forward with the project.

Special Counsel Bobby Maldonado states that he would have to review the inspector's report to recommend how the project should be addressed.

Councilor Noel Galvan also states that if Ryno Services did not have the knowledge to replace the electrical boxes they should not have done the work. City Manager Azalia Garcia states that electrical was not in the specifications. Councilor Estanislado Martinez states that even if it was not in the specifications a professional would know what was required to replace the electrical boxes.

Motion made Councilor Noel Galvan, seconded by Councilor Sofia Morones to replace the Civic Center balcony deck with the recommendations made by inspector Richard Lara and Ryno Services will be held responsible for the cost of replacing the deck.

Mayor Oscar E. Puente states that the city will work with the Grace of God to resolve the problem. Mayor Pro Tem Mario Ruiz recommends to City Manager Azalia Garcia to get a quote from J & J Excavation and if the quote is over \$5,000 to bring it back to Council for approval.

Motion made by Mayor Pro Tem Mario Ruiz, seconded by Councilor Sofia Morones to direct City Manager Azalia Garcia to contact J & J Excavation to get a quote to repair the drainage issue between the Grace of God Community Church and the Dollar Tree and if the repair is over \$5,000 to bring it back to Council for approval.

Councilor Sofia Morones asks who is representing the County to present the EMS Interlocal Agreement. City Manager Azalia Garcia states that Victory Ambulance is present if Council has any questions. Mayor Pro Tem Mario Ruiz states that the EMS Interlocal Agreement is the between the City of Carrizo Springs and Dimmit County and not with Victory Ambulance.

Councilor Sofia Morones recommends to table item.
