CITY MANAGER REPORT

21. ORGANIZATIONAL UPDATES

SWIMMING POOL

POOL REPAIRS

• Parks & Recreation Supervisor Frank Rosas has communicated with the company that will make the pool repairs but have not provided a start date for the project. Therefore, the repairs will be scheduled for late August 2025.

• The Parks Department is working on cleaning the pool and power washing it.

POOL STAFF

• The city has recruited 6 certified lifeguards Three applications for pool manager have been received.

LIFEGUARD CLINICAL

• Coach Gomez has been contacted to organize and schedule any required refresher courses before the pool season begins. The clinic includes conditioning, review of emergency action plans, rescue skills, and CPR/First Aid. Lifeguards will begin the clinical on the weekend of May 16th.

DATES

• Lifeguards will begin to clean the pool, equipment, and take inventory the week of May 19th. We have 3 lifeguards scheduled to work Project Graduation on May 23rd from 12am-2am. The pool will be open to the public on May 24th or May 27th.

VETERANS PARK ADDITION

- The bridge has been painted black, park benches have been stained and the sprinkler system has been installed.
- City Manager Azalia Garcia has communicated with ISD Welding team to design park signage for next school year.
- Parks & Rec Supervisor Frank Rosas has solicited 3 contractors for quotes (Eagle Construction, Cortinas Construction, MC Builders)to place stones on the perimeter of the exercise equipment and to build a stand for the plaque.
- Alamo Solutions began the manufacturing of the steel poles on April 28, 2025. The shade canopy will be royal blue and poles will be brown. The estimated timeline for fabrication is 6-8 weeks. The crew will weld each bar on the fence to reinforce.

COMMUNITY ENGAGEMENT

- City Manager Azalia Garcia met with Albert Alvardo of the Winter Garden Music Ensemble and invited his group to christen the amphitheater with a performance. The event will be scheduled for June 1, 2025 at around 8pm. Local vendors will be invited to the event.
- Two meetings have been held to recruit members and to form a city market day committee. We have planned and organized to begin the first event on June 21, 2025.

INTERLOCAL AGREEMENTS

- The revised interlocal agreement was sent to the Dimmit County Judge on April 21, 2025. Judge Martha Ponce and City Manager Azalia Garcia will meet the week of May 12th to discuss the next steps. and a joint meeting might have to be scheduled.
- The Law Enforcement MOU between Dimmit County and the City of Carrizo Springs was also discussed. Payment has not been made to Dimmit County because the agreement is still pending revisions and the outstanding debt on the agreement needs to be removed.
