Leadership Team

City Manager Ronnie J. Guest, Jr. states to Council that he met with the City of Carrizo Springs Leadership Team on November 3, 2020 and delivered a presentation on Strategic Planning.

Community Updates

The concerns at the intersection of Levi/Saltillo have been addressed with the intersection being repaved. The intersection of 13th/Oak is currently pending estimates from two gas construction companies to address the long-standing concern of the smell of gas in that area. The city does not have the equipment to address it, so the team was instructed to look at potential contractors. The estimates should be ready within the next week to proceed with the repairs.

Old HEB Building

City Manager Ronnie J. Guest, Jr. met with Dr. Hector Gonzales of Southwest Texas Junior College (SWTJC) on November 3, 2020 regarding possibility of creating a partnership with the City of Carrizo Springs to create a possible educational resource center at the old HEB building.

NAD Bank RFQ

The Request for Qualifications related to the NAD Bank Increased Water Distribution Services, was released, and provided to others regarding Small Minority Women Business Enterprises. The deadline for the RFQ is December 4, 2020.

Civic Center Parking Lot

City Manager Ronnie J. Guest, Jr., team members and Special Counsel Bobby Maldonado had a zoom meeting with the First United Methodist Church to move forward with officially documenting the transition of property of the Civic Center parking lot project. A draft narrative is being worked between Mr. Maldonado and First United Methodist Church attorneys to finalize the deal and identify the necessary right-of-way/easement needed to complete the project.
